PREFACE

The works cited in this bibliography have been examined carefully and with a practical purpose. They were compiled for use in a workshop on socio-culturally disadvantaged children and youth which Project SUCCEED conducted during the summer of 1965. Project SUCCEED had been conceived in the Learning Research and Development Center to study the problem of socio-cultural disadvantage in the schools and to develop educational programs better suited to the needs and interests of youngsters so handicapped.

The first SUCCEED summer workshop was attended by administrators and faculty selected from schools cooperating in the Project and trained to act as cadres of change agents in their schools.

The workshop program embodied lectures, discussions, role playing, planning sessions, and a practicum in which the cadre members worked with youngsters in disadvantaged neighborhoods. Selected reading from this bibliography, most of whose items were reproduced or abstracted, was a vital accompaniment to all other workshop activities.

The main work of compilation was done by Dr. Herbert Aurbach, in cooperation with Mrs. Rosalie Cohen, Mr. Barry Kaufman and Mr. John Koesel, all research assistants on Project SUCCEED.
