It is merely a guide to a few well known materials related to the topics suggested in the syllabus and should serve only as a point of departure from which you can expand to add further depth and dimension to your classes.

Your school librarian and your audio-visual consultant should be of help in meeting individual needs as they develop. There are numerous A-V catalogs, many of which will be on file in your school, and your library should have the Subject Guide to Books in Print, U. S. A. and A Guide to the Study of The United States of America put out by the Library of Congress. These two reference tools list hundreds of books from which you may select those desired for classroom or library use. Of course, frequent consultation of The Readers' Guide to Periodical Literature is a must for keeping up with the most current materials.

Many additional materials are available from the enrichment centers in the PROBE area. To receive materials teachers in those schools serviced by the Curriculum Enrichment Center in Norwich should contact Mrs. Elsie McNulty. For those schools serviced by the Rural Supplementary Educational Center in Stamford, materials may be obtained by contacting Mrs. John Gould.
