SUBJECT: RECOMMENDATION: Submission of an application for mini-grant (\$25,000) to plan a Demonstration School for Educationally Disadvantaged Children.

Titles I and III of P.L. 89-10, the Elementary and Secondary Education Act, have provided funds for a number of instructional programs in the Dade County Schools. In the various schools there are programs which are exemplary and worthy of consideration for adaptation on a broader scale in the school system.

The intent of this proposal is to plan a Demonstration School, to be located in the Demonstration Model Cities area, in which adaptive, exemplary, and innovative instructional programs can be introduced and evaluated.

RECOMMENDED: That the Superintendent be authorized to submit a request for a mini-grant under Title III, P.L. 89-10 to plan the establishment, location, and operation of a Demonstration School.

PART II: OBJECTIVES

The general objective of this project is to plan the location, construction, equipping and programs of a Demonstration School for educationally disadvantaged children. This facility will display in one location operational examples of the most successful instructional methods, techniques, materials, and equipment proved effective in the federally funded programs of Dade County Schools. Successful programs from other programs, local and national, will also be considered for use.

The Demonstration School will initially serve a target area encompassing seven elementary, two junior high, one middle, and one senior high school. These will be considered associated schools.

Through the Demonstration School's in-service and cadre activities, an effort will be made to improve the image of the associated institutions.

The specific objectives of this project are to:

1. Evaluate all proposed school sites available in the target area for construction of a Demonstration School and indicate the problems related to each, i.e., bussing, integration, location in the target area, and composition of the student population to be served.
2. Plan the construction and equipping of the Demonstration School by coordinating the activities and interests of school officials and architects

with those of community leaders, civic officials, teachers, social, health and welfare agencies, consultants, housing officials, "Demonstration Cities Project" representatives, and other interested agencies.

3. Identify some of the positive behavioral characteristics common to educationally disadvantaged children and propose a rationale for capitalizing on these assets in an educational setting.
4. Propose guidance and instructional techniques or approaches specifically designed to make use of the identified characteristics.
5. Make a consolidated listing of instructional techniques, approaches, materials, and equipment proven effective in stimulating the involvement of educationally disadvantaged children, both academically and non-academically.
6. Compile a listing of the special qualifications and behavioral characteristics considered essential for administrators and instructional personnel to be selected to staff the Demonstration School.
7. Select, in coordination with the Center for Self-Instruction staff, self-study programs, including programmed equipment and materials that are geared to the culture and thinking of the Demonstration School's proposed population.

8. Plan, with the coordinated effort of community leaders, school programs and activities that will attract and actively involve the adults in the community.
9. Plan for the joint use of school facilities and the coordinated effort of community health, welfare, recreational, and social agencies in providing for the needs of the Demonstration School children and their families.
10. Plan, in coordination with selected principals and teachers, guidelines for establishing and maintaining the most desirable learning and social atmosphere in the Demonstration School.
11. Develop criteria for selecting, training, and organizing a cadre at the Demonstration School to assist the principals and teachers, at the associated schools, in improving the image and learning atmosphere in their respective schools.
12. Coordinate with representatives of private non-profit schools in the target area to formulate plans for the participation of pupils and teachers in the Demonstration School classes and in-service activities.

PART II: ACTIVITIES

The principal investigator for this project will, with the assistance of all legal, technical, and instructional resources of the Dade County Board of Public Instruction, coordinate with all concerned and interested agencies in evaluating available

sites for construction of a Demonstration School for Disadvantaged Children.

1. Some of the problems anticipated in considering available sites are:

- a. Racial composition of the surrounding community.
- b. Integration potential of the site considered.
- c. Location of the site in relationship to the total attendance area to be served.
- d. Physical environment of each area considered.
- e. Community response to construction of the proposed school.

2. Coordinate with the following agencies on the construction and equipping of the Demonstration School:

- a. School architects.
- b. Community leaders and parents.
- c. Concerned and/or interested civic officials.
- d. Community social, health, welfare and other interested agencies.
- e. Selected teachers and administrators.
- f. Consultants.
- g. Metropolitan Housing and Urban Development authorities.
- h. City Demonstration Project officials.
- i. Other interested and concerned agencies.

3. Coordinate with the following to consider the feasibility and practicability of identifying the positive behavioral characteristics common to educationally disadvantaged children. Devise a rationale or capitalizing on these assets in an educational setting.
 - a. Project managers, teachers, and teacher-aides in local federally funded programs.
 - b. Specialist in the Title I Evaluation Unit and the Research and Development Department of Dade County Public Schools.
 - c. University of Miami.
 - d. Consultants.
 - e. Juvenile Court Officials and Youth agencies.
 - f. Neighborhood block club leaders.
 - g. Guidance counselors and visiting teacher counselors.
 - h. Others as appropriate.

4. Relate the selected behavioral characteristics to instructional approaches which can make use of these assets. For example: Educational authorities generally agree that the educationally disadvantaged child is "physical and visual rather than aural." If this is a valid conclusion the instructional procedures most likely to succeed should emphasize physical involvement, motion, songs, dances, the abacus, the slide rule, cuisinaire rods, role playing and similar activities, as appropriate to the subject.

5. Review with project managers, and teachers in federal programs the techniques, approaches, materials, and equipment used in existing programs that have proven effective.
6. Through the use of available research data, consultants and local resources the project investigator will compile a list of the special qualifications and behavioral characteristics determined to be most desirable for staffing the Demonstration School.
7. Select programmed instructional equipment and materials that are geared to the culture and thinking of the Demonstration School population as determined by:
 - a. Conferences with experienced teachers.
 - b. Coordinating with instructional personnel at both the Dade Public School Center for Self-Instruction and the Dade Junior College Center.
 - c. Correspond with commercial agencies to obtain lists of the latest instructional devices, programs, and materials.
8. Solicit commitments for cooperation in providing for the needs of the school population and their families from:
 - a. The Dade County Health Department.
 - b. The Dade County Park and Recreation Department.
 - c. The Neighborhood Centers of the Economic Opportunity Programs, Inc.
 - d. The Dade County Welfare Department.
 - e. The Dade County Office of Public Safety.

- f. The Better Business Bureau.
 - g. The Metropolitan Housing and Urban Development Authority.
 - h. Other community agencies.
9. Plan school programs and activities that will attract and actively involve adults in the community by:
- a. Coordinating with the Director of Parent Activities for the Head Start Program to ascertain the types of programs proven effective.
 - b. Meeting with the actual community leaders, rather than the designated leaders, to determine the real desires of the community populace.
 - c. Coordinate with the Directors of Community Schools to determine the types of programs that are successful in their respective programs.
 - d. Solicit opportunities to meet with community organizations to present the basic intent of the Demonstration School and obtain reactions.
10. Involve community health agencies in planning for the joint use of school facilities to assure more readily available community health services.
11. One of the most crucial problems presented by the inner-city school is the atmosphere which permeates these institutions. A primary intent of this project is to devise methods and approaches which may be effective in changing the atmosphere, and ultimately the image of these schools.

The principal investigator, in coordination with selected principals, teachers, district superintendents and directors, parents, community leaders and other interested agencies will:

- a. Establish guidelines for developing and maintaining the most desirable learning and social atmosphere in the Demonstration School and the associated schools.

This will be accomplished by:

- a. Determining the actions and activities of principals, teachers, and students which contribute to a poor learning atmosphere and an undesirable social atmosphere.
- b. Determine the neighborhood environmental factors which have an adverse impact on the school and propose counter-measures for same.
- c. Determine the most common school activities which result in poor public relations with parents and the public news media.
- d. Establish standardized procedures for principals to follow in the event activities occur at the school which may result in a significant degree of public interest.
- e. Establish basic criteria for organizing bi-racial committees at the Demonstration School and the associated schools to consider problems related to integration and racial incidents.
- f. Develop criteria for selecting, training, and organizing a cadre of five persons at the Demonstration School to work

with the administrators and faculties of "de facto segregated schools" in creating and maintaining the best possible learning atmosphere in the existing environment. This procedure is not designed to perpetuate segregation but is in recognition of an immediate need. Time, money, and the collective efforts of the Federal, State, and local government are all necessary to eliminate this problem. The target area for this project is in the Dade County Demonstration Cities Project Area.

The District Superintendent of the North Central District, in which the Demonstration School will be located, will attend a Conference on Urban School Planning - A Schoolhouse in the City. The Conference is expected to offer city governments, school and planning officials some answers to the hard school planning problems that lie ahead of them.

PART II. EVALUATION OF OBJECTIVES

This project is designed to meet special planning needs of the Dade County Public Schools Board of Public Instruction. Each objective established for this project will be subjected to continuous evaluation through the involvement of authorities and qualified persons in the development of each. The final plan for each objective will be further evaluated, if appropriate, by submission to other authorities for further evaluation.

The final evaluation of all objectives will be determined by:

- a. The potential of each objective to attain the desired goals as determined by authorities.
- b. The feasibility and practicability of implementing each objective.

Non-Public School Participation:

Representatives from private non-profit schools in the target area will be invited and encouraged to participate in the planning of the Demonstration School and related activities. The facilities and services of the school will be available to the total community which includes the children and teachers in the private schools.

Subject: Planning for Demonstration School

On Thursday, March 23, the people listed on the attached sheet attended a meeting in my office to discuss the nature of the facilities to be constructed on what we are terming the Olinda School site, that is, from N. W. 54th to 56th Streets and from N. W. 21st to 22nd Avenues.

The initial task is to prepare and submit a Title III, 89-10 planning grant prior to May 15, 1967. Mr. Eldridge Williams of Mr. Howard McMillan's office, will coordinate the preparation of this proposal. Mrs. Ida T. Ratcliffe of the North Central District Office, has been assigned to work with Mr. Williams for this purpose. The representatives from the various institutions participating in the meeting have offered to assist in any way that they are able.

Some of the specifics to be considered in the planning of the facilities to be provided on the site are:

- A. The development of appropriate educational programs for children who reside in an economically deprived neighborhood (Mr. Gato, District Directors);
- B. The provision for continuous staff development programs within the school and community environment for preservice and inservice staff members (Dr. O'Connor, Dr. Wey);
- C. The development of programs to involve the adults and parents of the community within the complete definition of what the community-school concept implies (Mr. Tasse, Mrs. Zoloth);
- D. The involvement of various Dade County agencies in the utilization of the site and facilities, e.g., Public Health Department (Dr. Matta); Dade County Model City Proposal (Mrs. Lotz); Community Library (Mrs. Lotz); Community Recreation (Mr. Peavy); and
- E. The provision of appropriate educational and community facilities to encompass the needs of the above-listed areas.

This list is not meant to be all-inclusive but only serves to begin describing what could be occurring on this particular site. The names in parentheses indicated with these broad considerations are only examples of those who should be contacted for planning purposes.

In general, this school-community center should be geared primarily to the needs of the children and adults of the immediate community since the efforts to improve both are unquestionably interrelated.
