INTRODUCTION

Background and coverage:

This is a supplement to the Bibliography of publications, 1941-1960 by Charles S. Mack (now out of print), and covers 1961 through December, 1968. All previously issued supplements are superseded by this edition. The NORC Library prepares cumulative supplements and sends them to persons on the general mailing list. Additions to this list are invited.

Included are general staff and study-related publications; the study numbers are indicated in parentheses within each entry. Additional information on studies is available from the Library or from the following publication, which lists and annotates most NORC studies from 1941 through June, 1964:
