ABSTRACT

This directory of selective film titles has been prepared to serve as a ready index to many of the films of potential value for the enrichment of a corrections curriculum. Recognizing that the list is not complete, the directory has been assembled in a manner which allows for adding titles by alphabetic sequence on the blank sides of the pages. Information provided for each film includes: (1) name of the film, (2) film size, (3) viewing time in minutes, (4) name and address of the producer, (5) name and address of the distributor, and (6) descriptive details on the film content. The more than 100 titles treat such topics as: (1) Children in Trouble, (2) Control of Inmates, (3) Crime Under 21, (4) The Death Penalty, (5) Jail Procedures, and (6) Penology Research.
