## ABSTRACT

Titles of theses and dissertations directly related to school health and school health education have been selected for inclusion in this compilation. Although each citation is listed only once by author and is not cross-referenced, categories are defined to aid in locating specific titles. These include: (1) Community and Public Health, (2) Curriculum Development, (3) Evaluation--health knowledge, attitudes, and practice; instruments, (4) Health and Physical Education, (5) Health Instruction--general; materials and resources; methods and techniques; misconceptions; needs and interests, (6) History and Biography, (7) Professional Preparation, (8) Research: Techniques and Analysis, (9) School Health Services, (10) Total School Health Program, and (11) Specific Health Topics--driver and traffic safety; environmental health; mental health, nutrition and weight control; safety; sexuality, marriage, and family life; and stimulants and depressants. Resources used in locating the titles were "Completed Research in Health, Physical Education, and Recreation", Volume 1 (1959) through Volume 10 (1968); "Research Quarterly", (March 1958 through May 1969); "Health, Physical Education, and Recreation Microcard Bulletin," Volume I (1949) and Volume II (May 1969); and "Dissertation Abstracts", Volume 20 (1960) through Volume 29 (February 1969). # Preface

This *Topical List of Theses and Dissertations in Health Education* was compiled after a careful perusal of each volume of each of the publications cited. Only those titles which appeared to be *directly related to school health and school health education* were selected for inclusion. Once the titles had been obtained, categories for the listings were developed, and each title was placed in the category to which it seemed to relate most closely. Each title has been listed only once, and has not been cross-referenced.

Titles appearing in the *Health and Physical Education Microcard Bulletin* have been so designated by including the word *Micro* in parentheses after the title as listed in this compilation. Those titles which appeared in the volumes of *Completed Research in Health, Physical Education, and Recreation* are indicated by an asterisk (\*) following the entry. Usually a study is listed in the volume of *Completed Research* published the year following its date of completion. If a study is described in the *Research Quarterly* as well as one of the other sources, it is indicated by the notation: "See also *Research Quarterly* . . ." which appears in parenthesis at the end of the appropriate entries.

In many cases titles could be placed just as easily in one category as in another. For example, a study which focuses on the development of a tool to evaluate a unit in family life education could be placed in either Category III-B (Evaluation Instruments) or Category XI-G, which contains studies pertinent to the specific topics of sexuality and family life. Therefore, it is suggested that all applicable category listings be reviewed if the title of a specific type of research is desired. It should be noted that the Specific Health topics in Category XI also contain professional and educational aspects of the topic (i.e., Nutrition and Weight Control includes listings in nutrition education, Safety includes safety education, etc.).

It is obvious to the compiler of this listing that errors may be present either within the specific data of each entry or in the categories in which studies have been placed, or/and in overlooking appropriate theses or dissertations in the volumes perused. It would be appreciated if these errors would be identified so they can be corrected if an up-dating of this compilation is undertaken. A note regarding the correction should be sent to Mary K.
