ABSTRACT

Concern over the problems of labor-management relations in the public sector has generated considerable interest and concern in recent years among faculty and students as well as government employers and employees throughout the nation. Thus the Manpower and Industrial Relations Institute of the University of Alabama decided to issue a series of bibliographies on the subject for national distribution. ## PREFACE

This bibliography is the first in a series to be prepared by the faculty and staff of the Manpower and Industrial Relations Institute of the University of Alabama. Housed within the Graduate School of Business, the Institute was established in January 1972 to further the University's teaching, research, and technical service programs in the fields related to manpower and industrial relations.
