ABSTRACT

Data on a variety of social and economic characteristics for persons and families in the United States of Mexican, Puerto Rican, Cuban, and other Spanish origin and comparative data for the remaining population were selected from the March 1972 Bureau of the Census Current Population Survey (CPS). Revisions in the March 1972 CPS, as compared to the 1970 CPS, include the introduction of 1970 census-based population controls and metropolitan residence definition, the use of 1970 census sampling materials for part of the sample, a change in the average segment size from 6 to 4 housing units for part of the sample, and a change in the first stage ratio estimation procedure. The 10 tables contain information concerning (1) U.S. population by ethnic origin; (2) age distribution by ethnic origin; (3) characteristics of families by ethnic origin; (4) percent of the population 25 years old and over who had completed less than 5 years of school or 4 years of high school or more, by ethnic origin; (5) labor force participation of persons 16 to 64 years old, by age, sex, and ethnic origin; (6) unemployment rates for persons 16 to 64 years old, by age, sex, and ethnic origin; (7) employed men 16 years old and over, by major occupation and ethnic origin; (8) median income in 1971 by years of school completed for males 25 years old and over by ethnic origin; (9) family income in 1971 by ethnic origin; and (10) low-income status in 1971 of persons of Spanish origin for the U.S. and 5 southwestern states. SELECTED CHARACTERISTICS OF PERSONS AND FAMILIES OF MEXICAN, PUERTO RICAN, AND OTHER SPANISH ORIGIN: MARCH 1972

(Advance data from March 1972 sample survey)

This report presents data on a variety of social and economic characteristics for persons and families in the United States of Mexican, Puerto Rican, and other Spanish origin. The figures come from the March 1972 Bureau of the Census Current Population Survey.¹ Detailed reports on the characteristics of persons by ethnic origin will be published later.

According to the March 1972 Current Population Survey, 9.2 million persons, or about 4.5 percent of the population identified themselves as being of Spanish origin, including 5.3 million of Mexican origin, 1.5 million of Puerto Rican origin, and about six hundred thousand Cubans. About 2.1 million heads of families were identified as being of Spanish origin.

There were 2.1 million men and 1.1 million women of Spanish origin in the labor force in March 1972; about 8 percent of these Spanish persons 16 to 64 years old were unemployed. The median income in 1971 for families of Spanish origin was \$7,500. Median family income where head worked year round full time was about \$9,596 and included about 57.0 percent of all families of Spanish origin. About 2.4 million persons of Spanish origin, a fourth of that population group, fell below the low-income level in 1971.

About one-third of the Spanish origin population 25 years old and over completed at least 4 years of high school. About one-half of persons of Spanish origin 25 to 29 years old had completed high school.

Of the 9.2 million persons of Spanish origin substantially more than half (about 60 percent) were living in the five Southwestern States of Arizona, California, Colorado, New Mexico, and Texas. About 85 percent of the 5.3 million Mexicans were living in those States as well.

The Mexican and Puerto Rican population are young with median ages around 18 years (as a result of relatively high fertility). The Cuban population, on the other hand, is substantially older with a median age of 34.1 years and essentially reflects the age composition of the persons who entered the United States from Cuba in the late 1950's and early 1960's.

Data on persons of Spanish origin for March 1971 were published in Current Population Reports, Series P-20, No. 224, "Selected Characteristics of Persons and Families of Mexican, Puerto Rican, and Other Spanish Origin: March 1971." Data for November 1969 were published in Series P-20, No. 213, "Persons of Spanish Origin in the United States: November 1969." Statistics on characteristics of persons and families are published regularly in Series P-20 of the Current Population Reports and income statistics are published in Series P-60. Data on employment and earnings are published monthly by the Department of Labor in Employment and Earnings.

The information presented in this report on Spanish origin or descent was obtained from use of the following question and instruction:

Persons of Spanish origin were considered to be persons who chose Mexicano, Chicano, Puerto Rican, Cuban, Central or South American or other Spanish descent. They may be of any race, but 98 percent of all persons of Spanish origin were reported as white. Families of Spanish origin were identified by the origin of the head of the household.

Since the estimates in this report are based on a sample, they are subject to sampling variability. Moreover, as in all field surveys, the figures are subject to errors of response and nonreporting. All statements of comparison made in the text of this report, however, are statistically significant. This means that the chances are at least 19 in 20 that a difference identified in the text indicates a true difference in the population rather than the chance variations arising from the use of samples.

Comparability of Estimates from March 1972 CPS with Estimates for Preceding Years

The data for 1971 collected in the March 1972 Current Population Survey (CPS) are, in some

instances, not entirely comparable to figures for earlier years because of revisions in the Current Population Survey. Starting in January 1972, 1970 census-based population controls, metropolitan residence definition, and other materials were introduced into the sample and estimation procedures. The major item affecting comparability at the overall national level is the introduction of population controls based on the 1970 census. Figures for previous years are tied in with 1960 census-based population controls. Basically, these changes should have no substantial impact on summary measures, such as medians and means, and on proportional measures, such as percent distributions and poverty rates. However, the changes may have more impact on the population levels in different subgroupings such as the total number of persons or families either overall, or within some particular category.

Other revisions in the March 1972 CPS are the use of 1970 census sampling materials for part of the sample, change in the average segment size from 6 to 4 housing units for part of the sample, change in the noninterview adjustment procedure for sample areas which are SMSA's, and change in the first stage ratio estimation procedure. In general, these changes are not believed to have any significant effect on comparability with figures for earlier years. A more detailed description of these revisions appears in the Bureau of Labor Statistics report "Employment and Earnings," Vol. 18, No. 8, February 1972.

Another change in the Current Population Survey which affects occupational data only, is the inclusion of a supplemental question, "What were your most important activities or duties?" which provided additional information for classifying persons by occupation. In general, the major impact of this supplemental question was to reclassify some persons from the "managers" classification into other types of occupations (primarily into the major occupation group of "craftsmen").




In addition to the findings of the Census of Population, conducted every ten years, the Bureau of the Census publishes continuing and up to date statistics on population counts, characteristics, and other special studies on the American people. Data are issued in the eight separate series of reports described herein and released under the general title, Current Population Reports.



P-20 POPULATION CHARACTERISTICS.

Current national and, in some cases, regional data on geographic residence and mobility, fertility, education, school enrollment, marital status, numbers and characteristics of household and families, etc. Approximately ten reports each year.

P-23 SPECIAL STUDIES. Infrequent reports on methods, concepts, or specialized data.



P-25 POPULATION ESTIMATES AND PROJECTIONS.

Monthly estimates of the total population of the United States; annual mid-year estimates of the population of States, by broad age groups, and of the United States by age, color, and sex; annual estimates of the components of population change. Estimates of the population selected metropolitan areas and their component counties. Projections of the future population of the United States and individual States. Approximately 20 reports each year.

P-26 FEDERAL-STATE COOPERATIVE PROGRAM FOR POPULATION ESTIMATES. Population estimates for counties for selected States in which the figures are prepared by a State agency as part of the Federal-State Cooperative Program for Local Population Estimates.

P-27 FARM POPULATION.

(Census-ERS). Data on the size and selected characteristics of the farm population of the United States. Issued jointly with the Economic Research Service, U.S. Department of Agriculture. One or two reports each year.

P-28 SPECIAL CENSUSES. Results of population censuses taken at the request and expense of city or other local governments. Subscription includes only the quarterly and annual summaries showing the total population figures for all the censuses conducted during the particular period. Individual reports issued for areas of 50,000 or more, showing the population by age, sex, and color are available separately. See "How to Order Reports." Five reports each year.

P-60 CONSUMER INCOME. Information on the proportions of families and persons at various income levels. Also data on the relationship of income to age, sex, color, family size, education, occupation, work experience, and other characteristics. Two reports each year.

P-65 CONSUMER BUYING INDICATORS.

Information on the proportion of households reporting intentions to purchase automobiles, houses, and household equipment within a particular period of time. Also data on recent purchases. Quarterly.

All Current Population Reports are sold as a single subscription for \$14.00 a year. This price includes Series P-20, P-23, P-25, P-26, P-27, P-28 (quarterly and annual summaries only), P-60, and P-65.
