Relationship of oral contraceptives to cervical carcinogenesis
Obstetrics and Gynecology 40:508-518, Oct. 1972

A retrospective epidemiologic study was conducted on 324 women with cytologic smears suggestive of neoplasia and on a control group of similar number. The results lead to the conclusion that women who use oral contraceptives for an average of twenty months are not more likely to develop squamous dysplasia or carcinoma in situ within 2 1/2 to 3 years after initial use than are women who do not use oral contraceptives.

The data from a controlled study (December 1968 - 1971) do not suggest that the use of oral contraceptives is related in any way to the risk of breast cancer but provide some evidence that the preparations may actually protect against benign breast disease in those women who have used them altogether for more than two years.

The studies presented in this paper offer no alternative explanation for the decrease in PHLA during oral contraceptive therapy apart from the suggested antagonism to the release of triglyceride lipase activity by heparin. No major impairment in plasma triglyceride removal was found.

Of 58 patients treated by Artificial-Donor-Insemination
(AID), 34 received intravenous injections of estrogen
to induce ovulation and 24 did not. In the group with
ovulation-timing the proportion of successes averages
41.65% of the number of cases treated that month, and in
the control group the rate is only 10.1% per month. AID
with timed ovulation is almost a causal treatment.

This procedure is currently the most frequently used midterm abortion procedure (over 50%) in Japan. The Laminaria-metreurynter method is also commonly used any time after mid-pregnancy for evacuating a dead fetus with or without spontaneous rupture of the membranes.

This is the first reported cluster of uterine perforations related to a single physician using the suction curet. Although the overall perforation rate of 3.6 per 1000 abortions was not remarkable, the risk of perforation increased from 0.0 per 1000 abortions at 10 weeks' gestation or less to 96.8 per 1000 abortions at 15 weeks or more. An accurate diagnosis of the length of gestation is critical.

Two hundred fifty women who had had a therapeutic abortion attended a group therapy program after discharge from the hospital. Each group was led by a psychiatrist-gynecologist team and consisted of three to five women. The authors concluded that the program was beneficial, helping patients to cope with guilt feelings and to clear areas of misinformation about sexual function and contraceptives.

In the first year of the liberalized New York State abortion law, over 20% of the legal abortions were performed after the twelfth week of pregnancy. Of a representative sampling of women undergoing late abortion, 55% were delayed because of personal reasons while 26% were delayed for reasons attributable to the medical care system. The late abortion patients were more likely to be younger, single and nulliparous and less likely to have ever used contraception than the early abortion women.

Tubal sterilization by the application of tantalum clips may be approached transabdominally or transvaginally. Both procedures are simple. A review of such cases done at the University of Maryland Hospital from 1960 through 1969 illustrates that the pregnancy rate following abdominal purperal tubal sterilization is too great to warrant utilization of this procedure - 11% compared to 1.2% with vaginal oviductal sterilization.

A study of the use of stilbestrol taken postcoitally by a thousand women of childbearing age who had one unprotected or inadequately protected sexual exposure since the patient's last menses. A followup on each patient revealed that there were no pregnancies.

Prostaglandins 2:135-141, August 1972.

Seven patients presenting missed abortions have been treated with intravenous prostaglandin F-2a to terminate the pregnancies. The drug has been effective in all cases and the mean induction-termination interval has been eight to twelve hours.

Black professional thinking appears to be that family planning is an important health measure, but is rejected as a population stabilization device. Family planning services are viewed as an integral part of badly needed comprehensive health care, which should have more black employees, more concern for counseling the whole family, including the male partner, and more emphasis on community control. Safeguards against coercive practices, including having members of the black caucus and others monitor proposed family planning legislation, are considered essential.

Black Africa has experienced three periods of development planning: the colonial era, the early years of independence, and the current period. This report analyzes the methods and effectiveness of each era and suggests that the governments will have to contend with the implications of population problems if future development planning is to be successful.
