ABSTRACT

This report presents a collection of annotated bibliographic and other information relating specifically to the areas of post-secondary and short-cycle education outside the United States. The bibliography is divided into five sections. Section I is an annotated bibliography of general information. Section II is an annotated bibliography of materials produced by the Organization for Economic Cooperation and Development (OECD). Section III is an annotated list of materials produced by governmental bodies other than the OECD. Section IV is an annotated bibliography of foreign journals convering post-secondary/short-cycle education and higher education. Section V is a listing of the addresses of agencies and groups from which related information is available. (DC)

A BEGINNING BIBLIOGRAPHY

This project presents a collection of annotated bibliographic and other information relating specifically to the areas of post-secondary and short-cycle education outside the United States of America. This project attempts to emphasize the international development of community college systems and/or their equivalents.

Three major university libraries were used in executing this project: The University of British Columbia, Vancouver, British Columbia, Canada; the University of Victoria, Victoria, British Columbia, Canada; and the University of Washington, Seattle, Washington, U.S.A.

An early discovery was that the community college as developed in the United States of America has not been exported in total to foreign countries interested in developing more accessible forms of post-secondary education. Canada and Japan have community college systems based on, or heavily influenced by the United States model. Some European countries have developed systems that exhibit influences from the United States model. Other countries have developed systems unique to themselves, and many countries have no system equivalent to or anything like a post-secondary, short-cycle form of education.

Terminology also varies. Familiar terms such as adult education and/or continuing education, vocational and technical education, and university transfer courses were encountered. Newer, and less familiar, terms were found, such as further education, folk education, short cycle education, worker education, and C.A.A.T. colleges.

What seems to be needed in the long run is the development of a continuous bibliographic project to record sources and information dealing with community college systems or their equivalents in countries around the world outside the United States. Many of the entries in the bibliography of this project were obtained from a variety of sources -- very often sources not directly identified with community college systems or community college education.

One organization proved to be a very fruitful source of information for this project. This source was the Organization for Economic Cooperation and Development (O.E.C.D.) and one of its research arms, the Centre for Educational Research and Innovation (C.E.R.I.) -- centered in Paris, France. The entries from this source have, therefore, been placed in a separate section of the bibliography.

A separate section listing other agencies and sources, and their addresses, has been included. These sources should provide additional information concerning post-secondary/short-cycle education and higher education from countries around the world. Continuous contact with these agencies and sources should provide access to the most recent information and research.

Annotation has been carried out for those selections which permitted viewing and/or reading. Those books and publications marked with (x) were not at my disposal "de visu". However, some basic information from other information sources was annotated if it seemed cogent and important for this project.
