ABSTRACT

This booklet describes 38 projects funded during Fiscal Year 1974 by the Intradepartmental Committee on Child Abuse and Neglect. Projects include community prevention programs, child protection, family resource centers, mother-infant attachment, the demography of child abuse, and the effect of birth order on the mother-child relationship. Project descriptions are organized by funding agency. The principal investigator or project director is listed for each described project, and a brief synopsis of the purpose of the project is given. The history and goals of the Intradepartmental Committee on Child Abuse and Neglect are also briefly explained. Project descriptions are indexed by: (1) principal investigator and institution, (2) region, and (3) project number. (Author/BRT)

Introduction

A brief description of the history and goals of the Intradepartmental Committee on Child Abuse and Neglect is also contained in this publication.

Overview

The Intradepartmental Committee on Child Abuse and Neglect was established on June 22, 1973, by a directive of the Secretary of Health, Education, and Welfare, the Honorable Caspar W. Weinberger. Chartered expressly to monitor the Department's child abuse and neglect activities, the Committee insures that the child abuse and neglect programs, "fit within a common framework with clear goals and objectives, so that our use of funds is complimentary towards common goals."

The Office of Child Development in the Office of Human Development was designated the lead organization and charged with the coordinating responsibility for insuring that efforts of the Social and Rehabilitation Service, Public Health Service, and the Office of Education focus effectively on the problems of child abuse and neglect.

During FY 1974, the Department's commitment to coordinated solution to the child abuse and neglect problem resulted in the Committee member agencies jointly funding 11 demonstration projects as well as the Committee's monitoring of 27 projects funded by the individual Committee member agencies. Four million dollars of new money was obligated to fund the 38 Committee monitored projects, which are briefly described in this volume.

The Committee continues to function, meeting once a month, and more often if required, to evaluate progress and to plan future directions.

The following 11 projects have been jointly funded by Social and Rehabilitation Service and the Office of Child Development

Parent and Child Effective Relations Project

This project, in Pinellas County, Florida, will reduce the incidence of abuse and neglect by (1) improving case finding through training a variety of personnel having regular contact with children and families, (2) improving case handling and treatment by the use of inter-disciplinary coordinating teams, (3) developing additional treatment approaches to minimize the removal of children from their families, while at the same time developing management information and cost effectiveness systems. It is anticipated that 1,000 families will be affected by one or another of the various aspects of the project.

Early Warning Signals of Serious Neglect and Abuse

This project has the following major components and objectives. (1) A survey of sustained and unsustained cases of child neglect and abuse sampled at various stages of entrance into protective services systems, in order to elucidate differentiating factors in the

psychosocial, circumstantial and ecological fabric which impact on the families surveyed. (2) Intensive interviewing of a sample of families identified through the survey to validate and elaborate upon the findings in (1). (3) A literature and expert survey of knowledge in child development in order to identify those elements necessary for or injurious to healthy growth and development of children, and the relative degree of certainty upon which such information is based. (4) A rationale will be developed out of these steps for studying specific situations or populations at varying degrees of risk. Out of this rationale, hypotheses about interventive methods with such populations will be developed. These hypotheses will be tested through assessment of the appropriateness of services for persons in those families in which there is a more pathological and less supportive psychosocial and ecological fabric.

Mother to Infant Attachment

Three studies will define the basic principles of mother to infant attachment: (1) to determine if the infant's contribution to a reciprocal interaction which a mother perceives is necessary in the formation of mother to infant attachment; (2) to determine if close contact of the mother with her infant in the first hours of life will significantly influence maternal attachment and therefore increase the length of time she breast feeds. In addition this close contact of the mother in the first hour of life may confer on the infant striking protection against hospital infection thus reducing bacterial infection in the infant; and (3) to investigate the unique situation of the attachment of a mother to her malformed infant in which grief and mourning occur at the same time that attachment should be developing.

The investigator believes that the process of modernization of American blacks has been delayed by a caste system which reinforces perceived powerlessness and an authority-based concept of social control; this traditional orientation in turn affects the mother-child interactions. One goal of the project is to modify these interactions and thereby to change the mother's self-esteem and her concept of herself in relationship to her child.
