WOMEN'S STUDIES: A STUDENT'S GUIDE TO REFERENCE SOURCES

New Feminism, or the Movement, may be said to date from 1963 with the publication of Betty Friedan's The Feminine Mystique. Since then a steadily growing flow of books, articles and surveys on the subject of woman has appeared, together with reprints of older classics rediscovered as seminal studies both in literature and social history. However, as yet few formal bibliographies have been compiled. This guide to the bibliographies and other selected reference works held by the Reference Department, McLennan Library is therefore brief. It must be supplemented by more general bibliographies and periodical indexes to a subject field as well as by judicious use of the L.C. and Cutter subject catalogues.

Government publications such as the studies and reports of the Canadian Royal Commission on the Status of Women, the Canadian Women's Bureau, the U.S. Women's Bureau and the U.N. Commission on the Status of Women are held by the Government Documents Department, 2nd floor, McLennan Library. Since most government publications are not listed in the McGill Union Catalogue you should consult the printed catalogues of Canadian and U.S. government publications (Z1373 .C2 Ref.; Z1223 .A18 Ref.) for relevant material under the subject heading Women.

All locations and holdings have not been indicated for items cited in this bibliography. For additional locations and detailed holdings please consult the McGill Union Catalogue under the entry used in this bibliography.

If you have any difficulty using this bibliography or the reference sources listed in it, please do not hesitate to ask for assistance from a reference librarian.
