ABSTRACT

This directory is the initial result of a Congressional mandate to the National Center for Education Statistics (NCES) to improve coordination among Federal agencies concerned with the collection and use of education data. It identifies and describes education data bases, predominantly quantitative, available on computer tape from Federal agencies conducting education-relevant research and maintaining data systems. The directory's emphasis is on describing the basic methodological and substantive aspects of the survey or system from which the data are derived, the general content of the tape, and significant characteristics of the data. The following information is described for each data base: persons to contact for tape access and general information, objectives, date of data collection, periodicity of data collection, methodology, significant variables, cost of the tape, data characteristics, and auxiliary services. The directory is organized as follows: Elementary/Secondary Education; Postsecondary Education; Demographic, Vital, Health, and Welfare Data; Manpower Supply and Demand; Libraries and Media Centers; and Federal Outlays for Education. Within each level, the descriptions are arranged alphabetically by the agency which disseminates the data. (RC)



The Education Amendments of 1974 mandated NCES to participate with other agencies interested in education data to form a Federal consortium which would improve access to Federal data on education. The Federal Interagency Consortium of Users of Education Statistics provides a special opportunity for NCES to furnish support in solving that problem.

In the initial development of the Consortium, the Secretary of Health, Education, and Welfare asked more than 30 agencies to participate. We look forward to even more diverse support and the expansion of efforts to improve accessibility of Federal data. Thanks are due to persons from the agencies represented in the Directory for their contributions to this first product. William Dorfman, NCES, and John Alden, ASE, provided general guidance and direction to the project.

NCES has attempted to focus this publication on the needs of the research/policy analysis community in the hope that extensive use will be made of the data described within. We solicit your comments on ways to improve this product and your suggestions for other Consortium services.

INTRODUCTION

BACKGROUND OF THE FEDERAL INTERAGENCY CONSORTIUM

During the spring of 1974, hearings on "A Bill to Provide for Obtaining Certain Educational Statistics" (HR 13991) and the "Education Amendments of 1974" (S 4379) were held in Washington, D.C., before education committees of the House of Representatives and Senate, respectively. Issues pertaining to the availability and accessibility of education data were expressed by a wide range of users throughout these hearings. Repeatedly, the view was expressed that prospective users find it difficult to keep informed about the availability of education-relevant data. Frequently, even after learning about data of possible interest, users did not know whom to contact in order to obtain the information.

In an effort to improve coordination among Federal agencies concerned with the collection and use of education data, Congress mandated the National Center for Education Statistics (NCES) of the Department of Health, Education, and Welfare to work with other agencies to form a consortium of Federal agencies interested in education data. As stated in the Education Amendments of 1974 (Public Law 93-380, Section 501), the mandate requires that:

"The Center shall participate with other Federal agencies having a need for educational data in forming a consortium for the purpose of providing direct joint access with such agencies to all educational data received by the Center through automated data processing. The Library of Congress, General Accounting Office, and the Committees on Labor and Public Welfare and Appropriations of the Senate and the Committees on Education and Labor and Appropriations of the House of Representatives shall, for the purposes of this subparagraph, be considered Federal agencies."

Since then, NCES has organized the Federal Interagency Consortium of Users of Education Statistics, with a membership of more than 30 agencies involved in the collection and use of education data. They are listed in appendix I on page 171.

In general, the Consortium members agreed that availability and accessibility of education data obtainable from Federal agencies were first priorities. Future areas for Consortium planning include user needs and priorities, standardization problems, and utilization of data for cross-agency analysis.

This Directory of Federal Agency Education Data Tapes is the first product of the Consortium. It identifies and describes education data bases available on computer tape from agencies of the Federal Government conducting education-relevant research and maintaining data systems. (The screening criteria, used to help define the data of interest for the Directory, are discussed on pages 2 through 3 in appendix 2 on page 173.)

During the summer of 1975, representatives from each member agency of the Consortium canvassed* their agencies for education data bases which reside on computer tape. Each representative wrote a description of the available tapes in a specified format and submitted it to NCES for inclusion in the Directory (see appendix 3 for

*The comprehensiveness of coverage of agencies and reported data bases are thus a function of the method used by each representative within his or her agency and may vary across agencies. format.)** The Directory represents a compilation of the data base descriptions submitted to NCES during the period of June 1975 to October 1975. Consortium member agencies represented in the Directory are the

SCREENING CRITERIA

In order to determine which data bases would be included in the Directory, screening criteria were developed by NCES. (See appendix 2 on page 173 for the specific criteria.) First, all data bases described in the Directory are available on magnetic computer tape. Data bases available in other machine-readable form, such as card and disk, were requested but none reported. Future directories will expand the storage media coverage, although it is expected that tape will be the predominant form of storage. Other screening (inclusion/exclusion) criteria are based on data base characteristics such as geographic scope, nonconfidentiality, and utility.

All the data described in the Directory are derived from sample or universe collection efforts that are national in scope, thus, the samples can consist of such areas as nationally sampled regions, States, Standard Metropolitan Statistical Areas (SMSA's), counties, cities, or census blocks or tracts. No requirements were placed on the frequency of data collection. The data are collected in recurring, periodic, or one-time studies and are available in conformance with requirements of the confidentiality and privacy legislation. Most of the data are of general interest and use. With a few exceptions, data describing specific Federal programs such as data on participation rates, characteristics of participants, and monies expended, are not included in the Directory.

In the development of criteria for the content of the Directory, delineation of the levels of education follows the usual classification of preschool, elementary/secondary, and postsecondary education and covers both public and nonpublic channels. Career/vocational/technical data are included in the elementary/secondary as well as postsecondary education classification. The postsecondary section also includes higher, adult/continuing, and other traditional and nontraditional forms of education which takes place beyond the years of compulsory school attendance. Although preschool and extension education as well as museum data were included in the screening criteria, no applicable data bases were reported. Similarly, while a special populations category was included (e.g., education for the handicapped, gifted, culturally deprived, bilingual, aged, foreign and exchange students, and refugees), no data bases were reported. Demographic, vital (including birth, marriage, and divorce), health, and welfare data bases containing educational background variables are included. Manpower supply and demand data are included in the Directory if the data pertain to educational institutions, educational personnel, or the educational experiences or backgrounds of persons in the labor force. There are also data on school and public libraries and media centers and on Federal outlays for education.

In general, the data bases included in the Directory consist predominantly of quantitative data, thus, bibliographic data bases such as the Educational Resource Information Center (ERIC) of the National Institute of Education of the Department of Health, Education, and Welfare are not included.

**Each agency had responsibility to ensure the accuracy of its descriptions included in the Directory.

DATA BASE DESCRIPTION FORMAT

Each description identifies and characterizes a specific data base. The descriptions are oriented to the substantive rather than technical considerations of the tapes, since the largest audience is assumed to consist of educational researchers, data analysts, program managers, and policymakers. The emphasis of the Directory is on describing the basic methodological and substantive aspects of the survey or system from which the data are derived, the general content of the tape, and significant characteristics of the data. Although technical specifications of the tape, such as the computer language by which it was generated or the character code used, are not within the scope of this product, such information is available from the appropriate contact.

Each description provides contacts through whom general information or an overview of the data base can be obtained. When necessary, a distinction is made between contacts for general information and those for access to the tapes. For example, in the NCES descriptions, a data tape may be purchased directly through the "Contact for Tape Access." Questions regarding the purchase of a tape are also directed to the "Contact for Tape Access." However, information on the content of the survey (e.g., specific data elements included and definitions of variables) and on the methodology of data collection (e.g., the mailout or interview procedure, response rate, and imputation) is obtainable through the "Contact for General Information."

Each description contains methodological information such as the date of data collection, the frequency (or, periodicity) of data collection, identification and size of the sample or universe, and the unit of data collected. Substantive information on the objectives of the data collection effort and significant variables is also provided. (In the "Significant Variables" section, only major variables are included.)

Selected characteristics of the data are specified, such as whether the data can be accessed at and/or below the State level, whether data are current (at the date of data collection), retrospective, longitudinal, projected, and/or derived from recordkeeping activities. For each data base, information is furnished on the cost of the tape. The tape format accompanies a tape when sent to a user.

Although the Directory focuses on education data on magnetic computer tapes, additional information describing auxiliary services provided by each agency enables a user to determine whether the data can be obtained by means of special tabulations, report generation, or publications in situations where computer and programming capabilities are not readily available to the user. Questions concerning auxiliary services may be addressed to the "Contact for General Information" unless otherwise stated.

The format for the data base descriptions is presented as figure 1 on page 4. The data base reporting form used by Consortium representatives is included as appendix 3 on page 175.

ORGANIZATION OF THE DIRECTORY

The Directory is organized as follows:

- Elementary/Secondary Education
- Postsecondary Education
- Demographic, Vital, Health, and Welfare Data
- Manpower Supply and Demand
- Libraries and Media Centers
- Federal Outlays for Education

Within each level of education and substantive area, the data base descriptions are arranged alphabetically by the agency which disseminates the data. In most cases, the agency disseminating the data tapes is also the collecting agency; however, in a few instances they differ. For example, the National Archives and Records Service distributes tapes containing data collected by numerous other agencies, including the Manpower Administration of the Department of Labor, the Office of Economic Opportunity, and The President's Commission on Campus Unrest.

OVERVIEW OF DATA

Figures 2 and 3 array the data bases, according to significant variables contained in the data base, by level of education or topic area for individuals and institutions respectively. On each table, the columns consist of the levels of education and topic areas, and the rows represent significant variables. For example, a user who is interested in individual-based achievement data at the elementary/secondary level needs only to refer to the "Achievement" row and the "Elementary/Secondary Education" column to see which tapes contain information of possible interest. In this case, seven tapes furnish information on achievement at the elementary/secondary level of education. The abbreviations in capital letters signify the agency disseminating the tape, and the numerals to the right of the dots indicate the page on which the tape description begins. Thus "DHEW/NCES . . ." shows that the tape description starting on the given page contains data disseminated by the National Center for Education Statistics. A tape may appear in more than one cell if it contains data applicable to other sections.

in general, variables such as achievement, educational attainment, educational experience, and socioeconomic characteristics are available for individuals. Such data include scores on verbal and nonverbal ability tests, career inventories, and grade averages, interests, attitudes, educational and occupational aspirations and plans of students, academic disciplines studied by students, and the teaching experience of staff. Information on the level of educational background of students or former students and their parents, education personnel, and persons in the Federal civilian workforce is available.

The institutional variables include curriculums and programs offered, degrees conferred, employees, enrollment, finances, institutional characteristics, and physical facilities. Institutional enrollment data are provided, for example, by sex, racial/ethnic group, and attendance and residence status. Financial data include revenues and expenditures, assets, and endowments. Institutional characteristics comprise such items as type of control, accreditation status, level of offerings, and principal officers. Data are available on physical facilities, including the number of square feet of physical plant space by type and function of room.

The actual data base descriptions follow.
