ABSTRACT

Basic data about State Teacher Standards and Licensing Boards (STSLB) (and practices commissions) that now exist and the names of persons who may be contacted for further information are listed. The listing is factual only. The inclusion of any board or commission does not mean that the body meets the criteria of the National Education Association. In some cases, a particular board or commission that currently has responsibility for teacher licensing was not viewed as a teacher standards board by the state association and therefore is not listed. The listing includes the state, the title of the association along with contact persons, the total members, number of teacher members, number of staff and meetings, and in some cases the amount of funds in the budget. Table 1 presents the powers and responsibilities of STSLBs by state according to 12 criteria, such as certification and teacher contracts. Table 2 gives data on membership for STSLBs by state under the broad headings of teachers, administrators, and higher educators. Table 3 provides information on qualifications for membership by individual state, then the variables of state resident, U.S. citizen, and professional qualifications. (DMT)

FOREWORD

The National Education Association favors control of entry and continuation in the teaching profession by members of the profession. This position is formally stated in Resolution F-1, adopted in 1969 and amended in 1975:

The National Education Association believes the profession must govern itself. The Association also believes that each state should have a professional standards board, with a majority of K-12 public school-classroom teachers. Professional standards boards should have the legal responsibility for determining policy and procedures for teacher certification, approval of teacher certification, approval of teacher preparation programs, recognition of national accreditation of preparation programs, and programs designed to improve teacher education.

In an effort to assist state affiliates wishing to implement this resolution, NEA staff collect and publish pertinent resource information such as this listing. The listing includes basic data about state teacher standards and licensing boards (and practices commissions) which now exist and the names of persons who may be contacted for further information.

This listing is factual only. The inclusion of any board or commission should not be construed to mean that the body meets NEA criteria as stated in Resolution F-1. In some cases, a particular board or commission which currently has responsibility for teacher licensing was not viewed as a teacher standards board by the state association and therefore is not listed here.
