ABSTRACT

Representative collections relating to all areas of women's history are included to make the document of the greatest potential use to researchers in women's studies. Preface

The publication of this bibliography is part of the ongoing effort of the Michigan Department of State through its Michigan History Division to make historical resources within the state more readily available. Finding aids, such as this one on sources related to women, while not glamorous, are crucial first steps which make possible exciting and valuable articles and books.

A bibliography that will aid researchers in women's history is particularly appropriate at this time. In the last several years women's history has attracted the interest of a growing number of historians and researchers in other fields. Hopefully, this volume will help maintain and nourish that interest. Furthermore, the increased study of women's history has already had its impact on the Bicentennial. Clearly, the Bicentennial celebration of the American Revolution will include significant mention of women and other groups who have been neglected in the past. The Michigan History Division hopes that this bibliography will aid those Bicentennial projects that plan to highlight the role of women in history.

Finally, we hope this volume will clearly illustrate that Michigan has a number of fine archives that contain materials too long neglected. Ultimately, the purpose of this volume is to make those repositories more well-known and useful.

Introduction

This cooperative finding aid does not presume to list all unpublished collections pertaining to women in the State of Michigan. The institutions chose to publish information only on the most representative collections — those which each cooperating institution felt to be of the greatest potential use to researchers in women's studies. At the out-set of the project the question arose whether to list only materials directly related to women's causes, i.e. suffrage organizations, women's rights groups, and so on. However, a more catholic interpretation prevailed, that collections related to women regardless of their direct relation to the "women's question" should be listed. Clearly, a researcher might be as interested in the diaries of a Michigan farm wife during the great depression or of a black woman active in the struggle for racial freedom as in specific women's causes. In other words, this list was designed to help researchers in all areas of women's history. Hopefully, it will be a small step toward a better understanding of woman's role in society.

Archivists are concerned that finding aids have consistency of format and style. Such uniformity has been difficult to achieve in this volume as each cooperating institution catalogs their materials differently and keeps varying information on their collections. For example, some archives classify their materials by cubic feet, some by linear footage and still others by the number of items in a collection. Varying types of materials are also described here. Many personal manuscript collections are listed; one will also find the records of women's organizations, or archival collections of government agencies which directly effect women. The compiler hopes that the reader will understand that the listing of widely varying materials is essential in an effort such as this and that consistency of style though implemented to the fullest possible extent must be secondary to a wide listing of materials.

The compiler would like to thank Valerie Browne of Wayne State University, Wayne Mann of Western Michigan University, Joe Oldenberg of the Burton Historical Collections, Bill Miles of Central Michigan University, Mary Jo Pugh of the University of Michigan and Kathy Roe of the State Archives for preparing the listings from their repositories for this *Guide*.

She served in the war under the name, Franklin Thompson.

Garrett, Cecilia (Vincent) 1853-1927
Wife of Milton W. Garrett, of Redford, Michigan. Correspondence with friends and relatives in Connecticut and New York; scrapbook of poetry; and mortgage for land in Redford, Michigan. Some of the earlier letters relate to school teaching.

Hampton, Charles George 1850-1942
Union Army officer. Business and personal correspondence, diaries, journals, record books, and other papers relating to the Hampton and Stark families and the Civil War. Also includes material on the Woman's Relief Corps. Description available with the collection.

Hannaford, Julia (Barnard) (Mrs.) 1866-1867, 1937
Mother's journal written in Michigan in 1866 and 1867. (An account of the trials and tribulations of Julia M. Hannaford and her family during their first year of settlement and farming in the wilderness around the village of Glen Arbor, Leelanau County, Michigan, September 9, 1866-September 14, 1867.) Typewritten copy of her manuscript, prepared by her son William H. Hannaford, in 1937.

Hinds, Henry Harrison 1871-1906
Personal and business correspondence of Mr. Hinds, his wife, Mary Sherwood Hinds, and daughters, Alma and Edna Hinds of Stanton, Montcalm County, Michigan. The business correspondence pertains to the American Short Horn Breeders' Association (1889-1906), Michigan Live Stock Sanitary Commission (1886-1902), Patrons of Husbandry (1891-1893), Woman's Relief Corps (1890-1896), and other business interests. Hollands, Hulda Theodate (St. Bernard) 1859, 1905-1929
Teacher and author. Correspondence, diaries (1907-1908) relating to social life and club activities in Detroit, typewritten manuscript of writing on Michigan history, and contract (1859) to teach in Port Huron, Michigan. Includes letters from Peter White, regent of the University of Michigan, relating to Mrs. Hollands' book, *When Michigan Was New* (1906), and business letters (1925-1929) from the office of Henry Ford. Three scrapbooks with newspaper clippings on St. Clair, Michigan, and her children's stories.

Holmes, Adelaide ca. 1855-1868
Reminiscences of her childhood in DeWitt (New York State), 1853-1864, and Peck Village, Michigan, 1864-1868 ca., describing farm life and early school days. Includes genealogical data.

Ina, Lyman 1860-1965
Farmer near Brockport, New York, who came to Galesburg, Michigan in 1869. Had five daughters: Amelia, Emma, Jennie, Julia and Netta. Jennie's husband James H. Imus was a traveling salesman. Diaries and cash account books of Mr. Lyman (1860-1877), his daughter Jennie (1867-1872), her husband James (1872, 1874) and their daughter Genevieve Imus (1891-1965). Diaries give daily accounts of family activities on a farm in Michigan and Ohio.

Include church attendance, travel, family celebrations, purchases of various articles, gifts, rent, taxes, etc. A wedding picture of Jennie and James H. Imus.

A chronological history of the Girl Scouts in the Mt. Pleasant, Michigan area including Mt. Sanford, M. L. (Mrs.) 1858-1868, 1871
Housewife from Sciota, Shiawassee County, Michigan. Letters to her daughter Amanda, a schoolteacher in the eastern states. Depict social life in Michigan (Sciota, Antrim), her daily chores on a farm, includes detailed

description of her house, family affairs. Few letters from other members of the family on Universalist preaching, many bears around. Owosso, Dr. Revin accused of abortion. 2 Civil War letters.

Sewall, May Wright (Mrs.) 1877-1904

Scrapbooks with clippings from newspaper and magazine articles in various languages concerning woman's suffrage, her participation in international women's congresses (London, 1899; Berlin, 1904) and in the World's Columbian Exposition, 1893. Many articles are written or edited by her. Also includes pamphlets, invitations, programs, menu cards, portraits of famous suffragettes, and some complimentary letters to her (1899); Mrs. Sewall was principal of the Girl's Classical School, Indianapolis, Indiana.

Starr, Minnie E. 1897-1913

Resident of Royal Oak, Michigan. High school teacher in Villisca, Iowa; Birmingham and Flint, Michigan and Moline, Illinois.

Letters from family, fellow teachers, former students, keeping her in touch with her former schools. She was a music teacher.

Thomas, Jessie 1871-1872

Contains list of letters received and sent, music lessons taken, expenses, and a day to day account of her trip to Paddock's Grove, Illinois to stay with relatives so she could go to school. Her residence in Michigan unknown.

VanDeusen, Minnie 1842-1969

Wife of a furniture store owner and undertaker in Elsie, Michigan.

Diaries (1901-1905, 1922-1969) dealing with the weather, her daily activities at home, trips in Michigan, social events in Elsie, Michigan. Small account book of her father-in-law, R. G. VanDeusen (1842-1849), her own accounts, 1940-1945. Volume with minutes of meetings of the Knights of the Modern Maccabees, Tent 419, Elsie, Michigan, 1904. Bills, receipts, World War Ration Books, 1942, scrapbook with newspaper clippings from the Elsie Sun, 1899-1906, with articles on social events in Elsie, chiefly obituary notes. Her husband died in 1934. Handy cash book, 1893 with brief accounts of all that happened in the year 1894.

Also 2 printed books with lectures of Clarke's Cincinnati College of Embalming, 1902.

Webster, Mary L. (Mrs.) 1846, 1862-1863

Native of Bellville, Jefferson County, New York. Letters from the Sacramento region, California and Lake of the Mountains, Nevada Territory, to her daughter (n.p.) describing her voyage by ship to Sacramento, gold and copper mining in the west, living conditions, intemperance and religious infidelity. One letter is from a friend in Rock County, Wisconsin (1846), relating her trip from New York State to Wisconsin and country life there.

Williams, Maria D., Stowell

Housewife, of Dexter, Washtenaw County, Michigan. Family correspondence, letters relating to Mrs. Williams' articles in the Waverly magazine, poems and receipts. Correspondents include John Williams, her son, and Spencer Williams, her husband.

Wing, Josephine 1896-1899

Letters of recommendation for Miss Wing, from Vicksburg, as a qualified teacher. Also three teacher's certificates.

Record books of the meetings and activities of the society, including membership rolls.

Bessie Stark Chadwick letter. From Bessie Stark Chadwick, DeWitt, Michigan to Esther M. Martin, Palmyra, New York, commenting on settling of area.

Materials accumulated by Jane Irwin Lewis (1913-1966), on quality of elementary and secondary education in the Ferndale, Michigan school system.

Greenough, Annetta 1881-

Certificates of Registered Nurse, war service record of Annetta E. Greenough.

Patchin, Elizabeth 1820-1902

Journal kept by Elizabeth Patchin, comments on life as wife of minister, movements to different parishes, homemaking.

Includes general legislative files, 1971-1974. The constituent correspondence contains subjects such as National Organization of Women Legislators speeches, League of Women Voters and Michigan Black Women's Political Caucus.
