ABSTRACT

Presented is the final report of a project to develop a consortium of Kentucky training institutions prepared to teach educational personnel for handicapped populations. Brief sections cover the following topics: purposes of the project (such as the establishment of a comprehensive statewide data base for student populations); the procedures and activities used to meet project objectives in three major areas (including those related to the faculty and programmatic characteristics of the member institutions); the four major products generated (such as the "Resource File of Kentucky's College and University Faculty Personnel Who Teach or Provide Services in the Area of Special Education") and the four related activities initiated (which included statewide sharing of revised training programs); the findings of a questionnaire survey to evaluate products; modifications made to the data collection procedures during the second year of the project; conclusions and recommendations (such as the provision of adequate production monies to permit circulation of products to all interested parties); and the 13 objectives initially proposed and related consortium efforts. The bulk of the document consists of appendixes which include information on the work breakdown structure during the first year, Kentucky's graduating special education teachers available for employment for the 1976-77 school year, procedures for inter-institutional utilization of resources and personnel in the area of practical supervision, the 1975-76 faculty resource file, the 1976-77 position openings list, the Inter-state Cooperative Planning Conference, product evaluation questionnaires and cover letters, summaries of product evaluation collected during the second year, the workbreakdown structure for the second year, a sample page of the matrix included in the second year's version of available position documents, data collection questionnaires, the executive board, and a sample newsletter. For Handicapped Populations: A Final Report

Introduction

During the academic year 1972-73 informal discussions were held among representatives of the Kentucky institutions involved in training teachers in the area of Special Education. Originally nine colleges and universities plus personnel from the Kentucky Division of Special Education were involved.

The subjects of these discussions were wide ranging but they eventually came down to the concept that cooperative planning is an essential element for effective training and service in Special Education. This present project was proposed as providing a potential vehicle through which specific problems related to training programs could be approached in a logical comprehensive manner by the Special Education faculties of all of Kentucky's Colleges and Universities.

A result of these discussions was the identification of several areas in which the representatives felt cooperative efforts should be developed. These areas then served as the basis for formulating the rationale from which the proposal was written to support this project. The areas identified were:

1. Effective utilization of current training resources require availability of both intra-institutional and inter-institutional program data. Comprehensive and projected planning is difficult, if not impossible, when approached from the perspective of submission of competitive or independent proposals to state or federal agencies. The need for a coordinated approach for responding to personnel priorities should be given critical focus by the thrust for more definitive evaluation data in pre-service and field performance areas. For example, there are fourteen Special Education training schools in Kentucky and prior to this project there were no data relative to the number of prospective teachers being trained, their

levels of preparation or their specific areas of speciality, i.e., mental retardation, learning disabilities. There also existed an absence of any systematic organized method or vehicle for exchanging information on specific project proposals to state or federal agencies which had, in the past, resulted in duplicative efforts and inconsistencies of direction.

2. On a projected basis, the development of personnel training programs to meet demands for competency certification requirements and to develop new types of professional personnel in public education and non-public school areas requires a comprehensive data base and coordinated procedures not currently available. Reduction of duplicative or competitive program planning and development is essential.

There is a need for the colleges and universities to come to some general agreement as to what competencies are necessary for particular types of certification. Prior to this project there was relatively little inter-institutional quality control in this matter.

3. Coordinated development of preparation programs in specific training areas on an inter-institutional basis is necessary. Questions related to "how many programs are necessary to meet manpower needs in specific preparation areas?" and "What are the minimal requirements for program support and endorsement?" must be considered and resolved. This planning and development must be based on data specific to both field and training program characteristics. There was a need to both collect and analyze this data in terms of priorities and to determine which institutions should emphasize which programs and at what level.

4. Representative of training program needs and priorities to resource control bodies may be best effected on a coordinated, comprehensive basis. Such representation must involve close coordination with SEA's and related state agencies. Priorities for meeting the needs of the handicapped will not be sustained by unilateral, fragmented action on the part of any one institution or agency.

Faculty from the fourteen colleges and universities were serving on a variety of committees and boards in the general areas of exceptional children. Decisions were often made by these groups which vitally effected training programs but only the most haphazard attempt was being made to consult with all schools before the fact. In many cases this resulted in disorder and confusion in the teacher training programs of Kentucky.

The major assumption underlying the initiation of this project was that a need existed to foster increased coordination and reciprocal support among training institutions in Kentucky. Further, this coordination should include state agencies and regulatory/legislative levels if priorities for the handicapped were to be sustained. The following events constituted the initiation of the Consortium:

1. Identified participating Teacher Training Institutions within the State.
2. Requested and received from those institutions letters indicating support for and willingness to participate in the Consortium. A total of thirteen Teacher Training Institutions within the state indicated support for and the desire to participate in the Consortium. Kentucky's State Department of Education, Division of Special Education, pledged its support as did several of the state's local educational agencies (LEA).

3. Created of an Executive Board, members of which represented the participating Teacher Training Institutions, the State Department and several LEAs (See Appendix L).
4. Assisted in the development and presentation of a Cooperative Intra-State Planning Meeting between all agencies within the state who have responsibilities in training personnel to work with handicapped children. This meeting was hosted jointly by the Division of Preparation Programs, Bureau of Education for the Handicapped, the Division of Special Education, Kentucky State Department of Education, and the University of Louisville's Department of Special Education.
5. Identified and hired a project coordinator (Dr. Cregg F. Ingram).
6. Initiated a state survey of participating Institutions of Higher Education regarding the programs they offered for both endorsement and degrees in addition to the generic areas of special education.
7. Developed and initiated a communication network between the Consortium and participating agencies for facilitating future project activities.
8. Developed of a work breakdown structure to guide the initial activities of the Consortium (Appendix A).

Activities used continually throughout the Consortium have included:

1. Quarterly Executive Board meetings
2. Collection of data (i.e. student status, faculty characteristics, program description, etc.) from each institution relative to meeting project objectives (See Appendix K for questionnaires used in these data collection activities).
3. Preparation and dissemination of materials (i.e. position openings in Special Education faculty availability for consulting, etc.) relative to meeting project objectives.

4. Communication with related educational agencies as to the activities engaged in by the Consortium (See Appendix N).

Activities that altered or changed during the duration of the project.

1. The notification of funding for this project was given almost two months after the proposed starting date. This resulted in an overall delay of approximately three months in beginning the project. A project coordinator was not hired until three months after the project was planned to begin. Consequently this delayed developing and implementing activities to meet objectives, completing the project on the date originally set, and expending the funds allocated for the project.
2. At the end of the initial year there was available enough unexpended funds to support one additional year of operation. A No Cost Extension to continue the project was requested and granted. This allowed for the continuation of activities designed to meet project objectives and afforded an opportunity to develop evaluation procedures to determine the effects of these activities on meeting project objectives.
3. A new director assumed leadership of the project during the second year of operation. The new director was given a work breakdown structure of activities to be initiated or continued and time as to when those activities should be completed (See Appendix I). This allowed for continuity of activities throughout the two year duration of the project, however it did restrict the Consortium staff from exploring differential methods or activities to satisfy stated goals.

Purpose

The purpose of this project is best reflected in the original objectives proposed for it. These objectives were:

1. Develop a comprehensive statewide data base for student populations

1.1 Background Referents

There currently exists no data base for students in pre-service training programs. It is impossible to relate SEA data regarding manpower needs or priorities with students in process or project program enrollments. No basis exists for coordinating program endorsement or approval at graduate and undergraduate levels.

1.2 Enabling Objectives

Develop procedures for data input, processing and analysis specific to:

- 1.2.1 Undergraduate status by declared major or area certification.
- 1.2.2 Undergraduate status by year; freshman, sophomore, junior, senior.
- 1.2.3 Certification level; elementary, secondary.
- 1.2.4 Graduate status; masters, educational specialist, doctoral.
- 1.2.5 Type of position obtained upon degree or certification program completion.
- 1.2.6 Develop a comprehensive data matrix for coordinating institutional and SEA data.

1.3 Evaluation Objective

Develop and operationalize data input, processing and analysis procedures among institutions by June 30, 1975.

2. Develop procedures for in-field follow-up.

- 2.1 Evaluation Objective

Develop and operationalize model for comprehensive follow up in coordination with SEA by June 30, 1975.

3. Develop Procedures for coordinating inter-institutional pooling of generic competency areas.

- 3.1 Evaluation Objective

Specify procedures for inter-institutional sharing of training curriculum models and procedures with emphasis on core competency areas by June 30, 1975.

4. Develop procedures for coordinated utilization of field practica sites and supervisory personnel.

- 4.1. Evaluation Objective

Registry of field practica sites and procedures for coordinated utilization will be operational by June 30, 1975.

5. Develop procedures for facilitating placement of program graduates in rural areas.

- 5.1 Evaluation Objective

Develop procedures for inter-institutional stress of rural placements and coordination with placement offices by June 30, 1975.

6. Develop procedures for inter-institutional coordination with related state service and training agencies, i.e., Vocational Education, Vocational Rehabilitation, Mental Health.

- 6.1. Evaluation Objective

Review related agency manpower needs data and possible projections of training needs by June 30, 1975.

7. Develop procedures for collective coordination with related educational program and agency activities.

7.1 Evaluation Objective

Develop registry of agencies and procedures for coordinated activities by June 30, 1975.

8. Coordinate consortium activities with newly developing local state educational functions.

8.1 Evaluation Objective

~~Develop and organize school district plans for program~~
planning by consortium institution by June 30, 1975.

9. Coordination of continuing education activities in Kentucky

9.1 Evaluation Objective

Identification of needs, possibilities for joint institutional planning and program to be completed by June 30, 1975.

10. Develop coordinated faculty/staff cooperative relationships between participating institutions.

10.1 Evaluation Objective

Develop, distribute and operationalize data with identified programming needs for cooperative planning by June 30, 1975.

11. Develop procedures for collective representation to state agencies.

11.1 Evaluation Objective

Develop and operationalize plans for collecting and dissemination of state plans involving handicapped population to the consortium members and transmittal of reaction to appropriate agencies by June 30, 1975.

12. Coordinate utilization of resource such as the RACHE project with the Educational Commission of States.

12.1 Evaluation Objective

Prepare and disseminate relevant information to consortium members to enhance utilization of such resources by June 30, 1975.

13. Coordinate consortium activities with directly related special regional and national projects.

13.1 Evaluation Objective

Develop registry of projects involved in developing materials directly related to consortium program activities; dissemination of material to consortium members; establish feedback loop relative to use of supplied materials by June 30, 1975.

Procedures

To facilitate maximum use of available Consortium resources and staff, the proposed objectives for this project were categorized into three groups representing clusters of related objectives. This allowed the staff to apply selected activities and strategies to several related objectives at one time. Data collected for answering a particular objective in many instances had relative value in answering several; therefore most of the activities specified and implemented during the project were used in collecting data or developing materials for categories and not individual objectives. The remainder of this section will be presented according to the three major areas of objectives. Within each area the objectives will be stated followed by the procedures and activities to meet those objectives.

Area 1. Objectives in this area related to students' status and performance. The objectives dealt primarily with the status of students either in training or as they functioned on the job. This area included the following objectives and activities.

Objectives

1. The Consortium will attempt to coordinate the development of a comprehensive statewide data base for student populations.
2. The Consortium will attempt to develop procedures for in-field follow-up. To meet the objectives in this area the following activities were initially certified, developed and implemented by the Consortium staff.

Activities

1. Information was solicited and collected from each of the institutions as to the students who would be graduating or completing a certification program and would be

seeking employment in the area of Special Education. This descriptive information was organized by area of exceptionality and included the potential employees (teachers) name and address. In Appendix B can be found a sample of the type and organization of this information. After the information had been collected it was printed, bound and disseminated to all agencies who had been identified as potential employers (i.e. school districts, hospitals, clinics, etc.) of special education personnel.

2. In an attempt to develop an in-field follow-up system the Consortium collected from each institution descriptions of their evaluation and/or follow up systems. This information became a part of the University Information File; this file is a catalog of descriptive information about each of the institution training program.

Area II. Objectives related to the faculty and programmatic characteristics of the member institutions. The objectives and activities for this area included:

Objectives

1. Develop procedures for coordinating inter-institutional pooling of generic competency areas.
2. Develop coordinated faculty staff cooperative relationships between participating institutions.
3. Develop procedures for coordinated utilization of field practica sites and supervisory personnel.
4. Develop procedures for facilitating placement of program graduates in rural areas.

Activities

- 2.1 An ad hoc committee of Consortium members was formed to develop procedures for inter-institutional sharing of resources and personnel in supervising practica. The results of this committee's efforts are found in Appendix C. The document from this committee was duplicated and circulated to all Consortium members with recommendations for future development and implementation of the proposed procedures.
- 2.2 A University Information File composed of descriptive information about each of the member institutions training program to include the course work, number of credit hours required and practicum experience offered. Also, the training relative to the area of exceptionality and the teaching competencies to be learned were included in this file. (This document is quite extensive and too large for inclusion on this report, however, a copy can be obtained upon request from the Consortium.)
- 2.3 A Resource File was developed relative to identifying faculty personnel from each institution as to their area of expertise and training background. Information was collected from the institutions faculty members and then organized into areas of exceptionality and/or professional services faculty could provide. Appendix D provides some examples of the type and organization of this information. Once collected the information was reproduced and submitted to all Consortium members and agencies who it was felt could use the information in an attempt to meet Area II objectives.

2.4. Information as to the positions available for the coming year was solicited from all agencies in the state who had indicated they hired special education personnel. Once collected the position openings were organized according to Kentucky's Educational Development Districts (EDD) by public and private educational agencies, area of exceptional and number of positions available. Appendix E contains samples of information.

Area III Objectives dealt with the activities of Related Educational Agencies. Categorized into this area were the following objectives and activities:

Objectives

1. Develop procedures for inter-institutional coordination with related state service and training agencies, i.e., Vocational Education, Vocational Rehabilitation, Mental Health.
2. Develop procedures for collective coordination with related educational program and agency activities.
3. Coordinate utilization of resources such as the HACHE project with the Educational Commission of States.
4. Develop procedures for collective representation to state agencies.
5. Coordinate consortium activities with newly developing local state educational functions.
6. Coordination of continuing education activities in Kentucky.

7. Coordinate Consortium activities with those that directly relate to other special regional and national projects.

Activities

- 3.1 A search was initiated to locate and identify all related agencies, state, federal and private within the State of Kentucky that provided service to exceptional population. Once identified the agency was contacted to determine the type and extent of the service offered. This information was then used in determining future Consortium activities. (i.e. development of position opening file, dissemination of materials to agencies in need of information, etc.)
- 3.2 The Consortium assisted in conducting a cooperative inter-state planning conference which was an initial attempt to bring all agencies serving handicapped populations together to identify areas in which these agencies could share information, resources and material to better serve handicapped children. Appendix F contains a summary of the activities and recommendations made during this conference.
- 3.3 A system of communication (i.e. telephone, letter and personal contact) was developed and implemented with all educational agencies serving handicapped population. This was done in an attempt to reduce duplication of service by identifying the services being offered by each agency and then making that information known to all other agencies.

Results

Products Generated

Four major products were compiled and disseminated during the duration of the project. The questionnaires used to collect data required to generate these products are found in Appendix K. These products and their related Consortium objectives are as follows:

1. Resource File of Kentucky's College and University Faculty Personnel Who Teach or Provide Services in the Area of Special Education - Area 2, Specifically Objectives 2 and 3 and Area 3 Objectives.
2. Kentucky's Graduating Special Education Teachers Available for Employment for the 1976-77 School Year - Area 1 objectives Area 2 specifically, Objective 4.
3. Position Openings in Special Education Within the State of Kentucky for the 1976-77 School Year - Area I, II, and III.
4. University Information File - Area I Objectives, Objective 2 and Area II Objectives, Objectives 1 and 3. (Compiled and disseminated during Year I only).

Activities Initiated: Year II

Four related activities were pursued in addition to the Product Generation assignments which were suggested as the primary Consortium tasks during the second year of the project. These activities and their relationship to overall Project objectives are discussed in the following sections:

- (1) Project RETOOL - Two proposals were forwarded to the Teacher Education Division of the Council for Exceptional Children in behalf of the Consortium participants. These proposals dealt with Phases I and II of Project RETOOL, a continuing education project for college and university level teacher trainers in

Special Education. Both proposals were funded and consequently a statewide needs assessment was conducted by Consortium-staff (Phase I) and the proposed service delivery model relative to the identified retraining needs is currently being expanded (Phase III) during the fall of 1976. These efforts are and have been totally supported by Project RETOOL funds. The activities involved in Project RETOOL are felt to be very closely related to the overall Consortium objective of fostering closer cooperation between the participating agencies as well as that of assisting in the enhancing of the capabilities of the participating Teacher Education Programs to meet the in-service and pre-service teacher training needs in Kentucky.

- (2) Statewide sharing of revised training programs - New special education certification requirements, imposed by the State Department of Education, and scheduled to go into effect in 1981 have necessitated the revision of all existing special education training programs in the Commonwealth of Kentucky. The Consortium staff is currently compiling copies of the revision efforts from each participant for distribution to all participants by mid-summer 1976. This activity is perceived by Consortium personnel and participants as being closely related to the general objective of providing a unified front to State Education Agencies as well as exemplifying a favorable cooperative atmosphere developing between the participants.
- (3) Division of product generation responsibilities - In the interest of attempting to continue making available the products compiled and disseminated during the duration of the project after expiration of the current grant, the participants are currently being surveyed

to ascertain their willingness and perceived capabilities to perform the tasks involved in producing these documents on a shared basis. Conceivably these documents could be produced at minimal expense in terms of time and/or money by each participant agreeing to fulfill specified commitments and in turn forwarding the results of their efforts to some central depository for final compilation and dissemination. The response to date has been very positive, however, the survey efforts are still in progress and it is anticipated that further definitive action will be impossible until mid-summer of 1976. The initiation of this suggestion by the Executive Board (representative of all participating agencies) would seem to be indicative of a supportive gesture in relation to the specific objectives identified as being related to the functions served by these documents. Additionally, the suggestion and the response to the survey to date further exemplifies the cooperative relationships that have evolved from post Consortium endeavors.

- (4) State Department support of continued efforts - The Consortium Director drafted a letter to Dr. George Troutt, Assistant Superintendent, Bureau of Education for Exceptional Children in the Kentucky State Department of Education requesting assistance in publication and dissemination of the three products proposed for continuation. This action was taken upon recommendation of the Executive Board and the response, still pending, will have considerable influence on the capability (and perhaps willingness) of the participants to endeavor to produce these documents independently after the current no cost extension of the grant expires.

Evaluation of Products

Questionnaires were designed to solicit evaluative feedback from the recipients of three of the four major documents produced during the project. These questionnaires (See Appendix G) have been distributed to all recipients and are still being returned and the data being compiled. The results, as available to date, are summarized for each document in Appendix H. At present, return rates for these three surveys vary from 22% for the Graduating Special Education Teachers document to approximately 50% for the Resource File. Such low return rates make it rather risky to draw conclusions regarding the data. However, some attention may be warranted the item on each questionnaire which deals with the "perceived need for the document in the future." 100% of the respondents to the Position Openings in Special Education questionnaire have expressed a desire to see this document's dissemination continued, 98% have expressed a similar opinion in reference to the Graduating Special Education Teachers list, and only 10% of the respondents have suggested that they anticipate no future need for the type of information contained in the Resource File.

The collection and compilation of this data will continue beyond the current grant's expiration as such data may be helpful in seeking whatever internal or external assistance may be required to continue production and dissemination of these types of documents in the absence of a federally funded Consortium. Even when considering the rather sparse return rates a definite, positive reaction trend would seem apparent in regard to user evaluations of all three products.

No formal evaluation procedures were utilized in relation to the University Information File.

Procedural Modifications: Year 2

Modifications were made with respect to the data collection procedures used for all three major products developed during the second year of the project. These modifications are detailed in the following sections:

1. Data Collection Procedures.

In an effort to stimulate a higher response rate to requests made for data necessary for compilation of the Resource File, Graduating Trainee List and Available Positions documents contingencies were specified in the cover letters accompanying the appropriate questionnaires for each document. Potential respondents were told that their receipt or subsequent Consortium products would be directly contingent upon their forwarding responses to the current requests for information. Copies of the revised Resource File were to be distributed contingent upon response to the Resource File questionnaires; copies of the revised Available Positions document were to be distributed contingent upon response to the Graduating Trainee's questionnaires; and copies of the revised Graduation Trainees List would be distributed to respondents to the questionnaire surveying Available Positions. When compared with returns for 1974-75 the 1975-76 data would suggest that something, perhaps the contingencies, did seem to stimulate higher response rates for college and university personnel in relation to the Resource File and Graduating Trainees List. However, the local education agencies and other agencies surveyed regarding Available Positions did not seem to be influenced by the newly imposed contingencies (perhaps they were even offended by them).

Table 1 depicts the comparison of response rates in relation to data collection activities for the two year duration of the project.

A matrix was added to the initial page for each Educational Development District's (EDD) entries in the Available Positions Document which enabled the user to identify at a glance (1) the agencies projecting teaching position vacancies by number of such vacancies and type of unit, (2) the agencies reporting to projected openings, and (3) the agencies failing to respond to the request for such information. This modification was implemented in an effort to reduce the time required of reading through all entries in the EDD's section in order to ascertain where vacancies existed as well as the types of positions available. A sample of the matrix may be found in Appendix J.

Conclusions and Recommendations

1. Project objectives were unwieldy as initially stated and had to be regrouped to permit more efficacious staff and resource utilization. Future projects organized for similar purposes might be better advised to focus attention on a few very specific critical objectives rather than attempt to deal with the broad range of objectives as proposed for the particular project.
2. Levels of inter-institutional cooperation seemed to improve significantly during the second year of operation of the current project. Response rates improved for all university data collection activities and several cooperative endeavors were undertaken (sharing of revised programs, Project RETCOL, etc.). This may not have evolved had the project terminated at the end of year 1 as originally proposed. Future such projects would be advised to be established on a multi-year basis to allow potential participants to "buy into" the idea.
3. Recipients of Consortium products reacted very favorably to them, however, budgetary constraints imposed upon the current project did not permit sufficient distribution to all who perhaps could have benefited from them. All faculty, rather than only department chairmen or program component heads, should receive Graduating Trainee Lists and Resource Files. Future similar projects should include adequate production monies to permit circulation of their products to all interested parties.
4. The designation of the Consortium office as the central depository and vehicle for circulation of information perhaps acquired or developed by one participant but of potential use to all participants has been a strong feature of the current project. A similar arrangement could evolve even in the absence of external support and, regardless of the funding situation, such an arrangement would certainly be recommended.

5. Evaluation of the current project's products was largely restricted to IHE and LEA personnel. Extending the evaluation population to include program graduates, eg. Follow-up of program graduates to determine usefulness of Available Positions document in relation to finding jobs, etc., would be advised.
6. Consortium products were favorably received by their recipients, however, the current evaluation efforts have centered primarily around the usefulness of information presented by the individual products. Future similar endeavors should examine production costs in relation to the usefulness of the products as well.

Summary

The Kentucky Training Consortium was developed to better meet the perceived needs of preparation programs in Special Education. Originally thirteen objectives were specified in the original proposal (October, 1973). The proposal was funded beginning June 1, 1974 through May 31, 1975. Due to the lateness in being notified of the grant approval we were unable to recruit a Project Director. We appointed Dr. Cregg Ingram who joined the faculty at the University of Louisville as the director for 1974-1975 and provided him release time for this purpose. Dr. Ingram left at the end of the first year and Dr. Marvin Holmes assumed his position as Project Director during the second year (1975-1976). The grant was supported the second year through a one year No Cost Extension which was made possible from the unexpended funds the first year due to our lateness in getting a Project Director appointed.

The thirteen objectives initially proposed and related Consortium efforts are: presented, as grouped into the three related areas during Year 1:

AREA I

1. Coordinate the development of a comprehensive statewide data base for student population.

Graduating senior list and card index of students in training.

2. Develop procedures for in-field follow-up.

Shared in University Information File

AREA II

1. Develop procedures for coordinating inter-instructional pooling of general competency areas.

Shared in University Information File (Enabling Objective 3.2.1).

Newly developing programs resulting from new state certification requirements are being compiled for distribution during summer of 1976.

2. Develop coordinated faculty/staff cooperative relationships between participating institutions.

Resource File identified TEP personnel by areas of research interest, expertise, consultive services, etc. (Enabling Objective 10.2.1).

3. Develop procedures for coordinated utilization of field practica sites and supervisory personnel.

Sites being used by all Consortium participants identified in University Information File (Enabling Objective 4.2.2).

4. Develop procedures for facilitating placement of program graduates in rural areas.

Graduating Trainees List distributed to all LEAs affording rural as well as urban and suburban personnel the opportunity of establishing direct contact with trainees available to fill S.E. vacancies.

Available Positions document distributed to all SE TEPs to be used in making prospective graduates aware of specific needs and contacts as pertain to rural as well as urban and suburban vacancies in SE Programs (Enabling Objective 5.2.1).

AREA III

1. Develop procedures for inter-institutional coordination with related state service and training agencies, i.e., Vocational Education, Vocational Rehabilitation, Mental Health.

Preliminary search conducted.

2. Develop procedures for collective coordination with related educational program and agency activities.

No specific action taken.

3. Coordinate utilization of resources such as the HACHE project with the Educational Commission of States.

Participated on behalf of Consortium in an interstate planning conference.

4. Develop procedures for collective representation to state agencies.

Sharing of individual SE TEPs' program revision efforts instituted to meet new state certification requirements.

5. Coordinate Consortium activities with newly developing local state educational functions.

Available positions document permits specification of personnel needs on a statewide basis (Enabling Objective 8.2.2).

6. Coordination of continuing education activities in Kentucky.

Project RETOOL activities, undertaken in behalf of the Consortium, have identified a variety of retraining needs of college/university SE personnel. Subsequent service delivery model development and implementation activities should also be beneficial in related continuing education endeavors for classroom teachers, parents and other interested laymen. (Enabling Objectives 9.2.1 and 9.2.2).

7. Coordinate Consortium activities with those that directly relate to other special regional and national projects.

Proposal for Project RETOOL submitted in behalf of all Consortium participants.


WORK BREAKDOWN STRUCTURE: YEAR I

Background Referent

An ad hoc committee to develop procedures for inter-institutional sharing of resources and personnel related to supervision of practica experiences was created as a result of an executive board recommendation. The committee was charged with the responsibility of specifying (1) reasons why utilization of resources of personnel between institutions was necessary; (2) conditions in which sharing could take place; and (3) procedures for utilization of resources and personnel between each of the institutions that compose the training consortium. Essentially the committee endeavors to meet this charge would result in identifying strategies for satisfying two of the consortium's primary objectives, which are:

Develop procedures for coordinated faculty/staff cooperative relationships between participating institutions.

Develop procedures for coordinated utilization of field practica sites and supervisory personnel.

Committee Composition

The committee was composed of five members: Dr. Thomas, McCarthy, Ecklarline College, Dr. Weitse de Hoop, Eastern Kentucky University; Dr. Edward Blackhurst, University of Kentucky; Dr. Curtis Englebright, Western Kentucky University; and Dr. Cregg Ingram, Training Consortium Director.

Committee Proposal

Given the aforementioned charge and provided with information from a task force that had initially worked on this same problem the committee made the following proposals and recommendations.

1. IDENTIFICATION OF REASONS FOR COOPERATIVE UTILIZATION OF RESOURCES

1.1. Reduced Expenditures For Supervision

Individual institutional costs for supervision of practica experiences can be reduced through cooperative sharing of resources and personnel. This is most evident when an assessment is made of the amount of travel and time each institution consumes in supervision of its practica experiences. For example, some of the institutions have practica sites located at great distances from them. This requires both expenditure in travel and faculty time to supervise these sites. Most often there exist, in closer proximity to the site, qualified and capable personnel from another institution who could, with reduced costs in travel and time, adequately supervise those sites. Through cooperation the institution maintains its practica sites necessary for training students but reduces the cost of supervising those sites.

1.2. Increased Potential For Supervision

Through cooperation each institution increases its potential for providing adequate supervision; that is, if the institutions cooperatively share resources and personnel they have increased

their capacity in terms of numbers of practica sites and supervisory personnel to provide supervision. Without cooperation each institution is limited as to its capability to provide supervision in terms of personnel, finances and time.

1.3. Increased Resources For Accomodating Students Training Needs

If each institution identified and made available its practica sites and supervisory capabilities this would increase the number of practica experiences that each institution could offer as options in their training programs. Students would then be afforded the opportunity of selecting practica experiences that could better accomodate their training needs. An ancillary benefit of this type of resource could be the identification and potential use of increased numbers of quality practica sites by the institutions.

2. CONDITIONS UNDER WHICH COOPERATIVE UTILIZATION OF RESOURCES OF PERSONNEL SHOULD TAKE PLACE

2.1. Specification Of Commitment

Each institution should identify and specify the degree of commitment it has or can make for sharing resources and personnel for practica and practica supervision.

2.2. Willingness To Cooperate

A cooperative effort will be dependent upon having each

institution not only identify the degree of commitment they could invest but to express the degree of willingness they have to meet that commitment. This should be in writing and made available, through the consortium to each of the other participating institutions.

3. PROCEDURES FOR COOPERATIVE UTILIZATION OF RESOURCES AND PERSONNEL

3.1. Practica Site Development

3.1.1. Identification and description of all practica sites now being used by each institution. This information is to be made available to all institutions.

3.1.2. Identification and description of other potential practica sites, especially in rural areas, that could be used by each institution for field experiences.

3.1.3. A resource file on all practica sites and supervisory personnel will be developed and made available through the consortium to each of the institutions.

3.2. Supervisory Development On Site

3.2.1. Identification of local education agency (LEA) personnel who could be hired or used as supervisors of practica experiences for each of the institutions.

3.2.2. These persons would have to meet the following criteria:

1. Provisional certificate in area of exceptionality in which supervision is to be done.

2. Master Degree - Rank II
 3. Two years teaching experience in the area of exceptionality the supervision is to be done
 4. Express a willingness to participate as a supervisor
 5. Be identified as a "good teaching" model
 6. Be identified by the district superintendent of special education supervisor as a potential supervisor even though they do not meet all of the above criteria.
- 3.2.3. Their selection would be based on the expressed willingness of the district, in which they worked, in allowing them to participate. The district superintendent and special education supervisor would have to give approval for using these persons. Also, the district superintendent or special education supervisor would be involved in the identification and selection of qualified personnel in their district who could be used as supervisors.
- 3.2.4. These "on site" supervisors, hired by the institutions, would help to decrease the travel and time expenditures for faculty from each of the institutions.
- 3.2.5. On site supervisors would or could act as a screening mechanism for the district for the identification and

selection of new teachers in the area of special education. For example, an "on site" supervisor from the district could determine which of the student teachers being supervised would be good potential teachers for the districts. The supervisor would, in effect, act both as a screening device and recruiter for the district.

3.3. Development Of Supervisory Criteria

3.3.1. Each institution will assist in the identification and specification of behaviors and competencies student teachers should develop or manifest as a result of each practical experience. These would be used as a guide for supervising those experiences.

3.3.2. The supervisor, either the institution's or on site supervisor, would have a checklist of behavior or competencies from which to observe and evaluate student teacher behavior.

3.3.3. A checklist of behaviors would be developed for each area of exceptionality in which cooperative supervision practicals could be effected.

3.4. Development Of Areas For Institutional Cooperation

3.4.1. Each institution should make available library and other resources plus classroom space for seminars to supervisory personnel and students from other institutions

when they are supervising practica in sites within the geographic location of that institution. For example, if Western Kentucky is supervising practica experiences in the Louisville area the University of Louisville would make available to the capacity they were able, classroom space and library resources to Western Kentucky University and vice versa.


3.4.2. Inter-Institutional Supervision And Practica Experience

1. Institutions should set a fee for the amount they would charge to supervise students from other institutions.
2. Every institution that has students supervised by another institution will be expected to reciprocate supervising that same number of students for that institution.
3. Institutions could cooperatively hire additional supervisory personnel who would supervise each institutions practica experiences.

Introduction

This second edition of the Resource File of Kentucky's College and University Faculty Personnel Who Teach or Provide Services in the Area of Special Education represents the up-dated faculty alignments for school year 1975-76. All information contained within this document was voluntarily provided by each person whose name appears herein.

Rationale

Each of Kentucky's thirteen (13) institutions of higher education providing teacher training programs in the area of special education have faculty members with unique abilities, interests, training and background. These faculty members are not only a valuable resource to each of their respective institutions but potentially to the entire state's educational system. It was felt by the Training Consortium that by identifying faculty members as to their areas of interest, training and backgrounds and then making that information available to all agencies that provide special education services (i.e. local school districts, state educational agencies, private agencies) this resource could be tapped to provide increased and better services to Kentucky's exceptional children. The purpose of this file is to circulate to all agencies providing services to exceptional children information about the available expertise within the colleges and universities that could be used for:

1. developing in-service training programs for agency staff.
2. direct services, such as diagnostic-prescriptive assistance, to exceptional children.
3. consultative assistance for developing, implementing or evaluating educational programs.
4. conducting research in the area of special education.
5. developing new innovative programs for serving exceptional children.
6. improving the teacher training programs within the colleges and universities, etc.

Organization

The file has been organized by (1) generic area of special education; (2) areas of consultation; (3) direct services assistance. Future resource information will be collected, in addition to that above, as to interest in research, program development, etc. Following is an example of how this resource file has been organized.

College and Universities (in alphabetical order)

Faculty members names and addresses

Areas of consultative service (within the generic area)

Areas of research interests within generic area

Special interests (within generic area)

Potential Users of this Document

This resource file should be a worthwhile tool to any persons interested in developing, improving, implementing and evaluating educational programs for exceptional populations. For example, school district personnel wishing to develop an inservice training program in diagnostic-prescriptive techniques for the handicapped could refer to this document to identify university personnel who could assist them in this task. A school district or private agency wishing consultative assistance in the administrative or supervision of their special education program could use this file in identifying personnel within Kentucky who have the necessary expertise to assist them. Any agency that plans an inservice or pre-service training program or needs diagnostic-prescriptive services given directly to students should find this file a valuable resource.

In addition, University personnel called upon to provide consultive services may use this document to assist the agency seeking such services in locating other qualified personnel should that particular faculty person be unavailable at the time of the request.



The list was generated by sending a questionnaire to all the Kentucky's local, state, and private educational agencies, (school districts, state schools, comprehensive care centers, private schools, etc.) that provide services to handicapped children, requesting them to identify positions available for personnel trained in special education. Information on position openings was collected on each category of exceptional child education.

INTRA-STATE COOPERATIVE PLANNING CONFERENCE

Summation of Activities
Cooperative Intra-State Planning Conference

This report is a summation of the activities conducted during the conference on developing an intra-state cooperative plan for the preparation of personnel to meet the educational needs of Kentucky's handicapped children. A Special Project Grant was awarded to the University of Louisville in conjunction with other Kentucky colleges and universities with the stated purpose being to develop a cooperative effort for preparing personnel to work with handicapped children. This conference was the initial discussion and planning step for this state-wide consortium project. Personnel, representing the educational agencies that are involved in personnel preparation, were brought together to discuss and make recommendation as to the most appropriate characteristics that should be considered in constructing a cooperative plan.

Participants

Conference participants represented all levels of educational development and services in Kentucky. Included were representatives from Local Education Agencies (LEA); State Education Agencies (SEA); Institutions of Higher Education (IHE); and representatives from the Bureau of Education for the Handicapped (BEH). A total of 22 persons attended the conference. This group, after introductory comments as to the purpose and function of the meeting, was divided into two subcommittees. Each subcommittee being composed of representatives from each of the above mentioned educational agencies.

Conference Activities

Focus of each subcommittee was directed toward identifying the concerns each educational agency (LEA, SEA, IHE, and BEH) had in relationship to the formulation of a cooperative intra-state plan. The committees were also asked to discuss and make recommendation as to the procedures and characteristics they felt should be considered by the consortium project in developing a cooperative effort. Following is a summation of the subcommittees concerns and recommendations related to this project that should be considered by the consortium in its initial planning and development activities.

1.0 Concerns

- 1.1. The Kentucky Intra-State Consortium project for the preparation of personnel to work with Kentucky's handicapped children should give every evidence of a cooperative effort.
- 1.2. The consortium should attempt to represent all educational agencies serving handicapped children.
- 1.3. Information to be used in guiding consortium activities should come from a variety of sources including parents, LEA's, SEA's minority groups, community leaders, etc.

- 1.4. The magnitude of the cooperative effort should be confined within the constraints imposed by the project's goals and objectives.
- 1.5. Consideration and planning should now be initiated for establishing procedures for continuing the project after termination of the Special Project Grant.

2.0 Recommendations

- 2.1. Executive and advisory boards should be formed in accordance with proposal guidelines and implemented as soon as possible.
- 2.2. Advisory board membership should represent all agencies with an interest in and/or serving handicapped children. (These to include parents, regular education, special education, administration, psychology, medicine, etc.)
- 2.3. Initial consortium development should follow the grant proposal guidelines as well as the recommendations of this conference.
- 2.4. Plans developed by the consortium should be circulated to all training institutions in order that they may be included in training grant applications for the following years.
- 2.5. A Comprehensive Needs Assessment must be initiated to determine the types of personnel and necessary skills needed to provide effective services to handicapped children. This needs assessment, conducted principally with handicapped children, would help to determine the educational programs to be developed at the LEA, SEA, and IHE levels of training. Specifically, the needs assessment should be aimed at:
 1. Identifying and specifying competencies needed by professional and nonprofessional personnel to effectively educate and train handicapped children.
 2. These competencies would form the basis for competency-based programs to be used in both preservice and inservice levels of personnel training.
- 2.6. Development of a Management Information System that would be used to develop, guide, and monitor the consortium's cooperative program.
 1. Obtain and maintain a current census report of Kentucky's handicapped population.
 2. Identification of all existing personnel and programs in the state of Kentucky that are currently providing services to handicapped children. This to include program and services offered by LEA's, SEA's, IHE's, and private agencies.

3. Identification of cooperative service and training programs that currently exist between different agencies service the handicapped children.
 4. Identification of overlapping and repetitive programs between agencies serving the same population of handicapped children.
 5. Identification and specification of manpower needs to adequately serve Kentucky's handicapped population. This to include manpower needs by geographic location, i.e., rural, suburban, urban, etc.
 6. Development of a communication network between all the agencies serving handicapped children that allows for an interchange of agencies' activities and operational information. This would include information as to each agencies needs for additional manpower, program development, and training; or, the availability of manpower and training programs that could be used by other agencies. The principal purpose of this communication network would be to ensure that all agencies (LEA's, SEA's, IHE, etc.)
- 2.7. Development of a system for the identification, specification, and utilization of resources, (In-state, private and national) that would have direct benefit in meeting the consortium's goal for a cooperative effort.
1. Identification of LEA and SEA practica sites that could be shared by all IHE's.
 2. Identification of all training and program development resources from the IHE's that could be used by all LEA's, SEA's, and other IHE's as resources for preservice and inservice training development.
 3. Specification of procedures for how each in-state agency will provide or obtain assistance from the other.
 4. Specification of procedures for how in-state agencies can request and obtain assistance from federal and private resources. (Easter Seal; WHAS, ALRC, RRC, BEH, etc.)
- 2.8. Development of Cooperative Training Programs between all agencies.
1. Attempt to identify methods and procedures in which LEA's, SEA's, and IHE's can work together in development of training programs.
 2. Involvement of regular education and other educators-particularly administrators, district superintendents, and school principals with respect to developing training programs.
 3. Develop procedures for providing an array of practica experiences (e.g., urban, suburban, rural) into the training programs of all IHE's.

- 2.9. Identify those processes that interfere with providing cooperative services between agencies and specify procedures to counteract or compensate them.
- 2.10. Increase emphasis on programs for handicapped children at the secondary level should be effected.



CONSORTIUM STAFF

With the one year no-cost extension of the original Consortium grant, a new staff has been appointed for 1975-1976. Dr. Marvin Holmes, recently of Eastern Kentucky University, and newly appointed Assistant Professor of Special Education at University of Louisville, will be Consortium Director. Mrs. Thelma Barbre is the new Secretary and Gary McKim has been assigned as Objectives Coordinator.

EXECUTIVE BOARD MEETING

The Executive Board of the Consortium met on October 30, 1975, during the C.E.C. Workshop held in Louisville. This meeting focused on the products of the Consortium. Among the items discussed were:

1. Information File: This file has now been received by the Executive Board members. Any necessary revisions to the Information File will be made during follow-up data collection.
2. Graduating Seniors List: Major changes in the seniors list include earlier collection of data regarding the graduates; an indication as to whether or not they had accepted a teaching position; and that initials be used to identify the institutions rather than the present number system. Questionnaires were sent on November 5, 1975, to all Consortium institutions and the file is scheduled for distribution April 20, 1976.
3. Resource File: Modifications have been made to the Resource File questionnaire. A matrix will be included this year to make the file easier to use. Title IV (LEA) directors will be included in this year's mailing. Questionnaires were sent on October 31, 1975. The Resource File is scheduled for distribution May 15, 1976.
4. Available Positions File: This year all school systems will receive a copy of their response from last year to encourage a more complete compilation of available special education teaching positions in Kentucky. These questionnaires will be sent January 15, 1976.

CONSORTIUM IS DISCUSSED AT HEALTH, PHYSICAL EDUCATION AND RECREATION CONFERENCE

Dr. Holmes, Consortium Director, spoke to a group of HPER personnel at the State Convention at the Kentucky Association on Health, Physical Education and Recreation on November 15, 1975. The rationale, purposes, objectives and activities of the Consortium were presented and discussed during the session on Adaptive Physical Education. Although Consortium effort's have centered primarily on Special Education, personnel in related fields have expressed interests in both becoming involved in Consortium activities and in initiating similar pursuits within their respective areas.
