**ABSTRACT**

This index contains accession numbers from the ERIC and AIM/ARM (Abstracts of Instructional and Research Materials in Vocational and Technical Education) systems under which products of career education projects funded under Part C and Part D of Public Law 90-576 may be retrieved. The work is subdivided into four separate indexes, according to first and second rounds of Part C and first and second rounds of Part D, respectively. This publication is intended for use in conjunction with four volumes of abstracts, ED 063 520, ED 136 068, ED 099 518, and ED 099 523. These volumes contain abstracts of the original pilot projects' proposals. The index provides a listing of the grantee, project number, grant number, and the ED (ERIC) and/or VT (AIM/ARM) numbers of the available interim, supplemental, and final reports from each state and territory for each of the four volumes of abstracts. The listing is at times incomplete. An introductory section provides background in the growth of career education. Also included is a key to various codes used in the index and a section explaining in detail how to use the index and retrieve the documents for which ED and VT numbers have been provided. ## INTRODUCTION

Early in the 1970's, the career education movement began to emerge throughout the United States. This movement emerged and grew in response to a variety of societal needs which had become evident by the beginning of the decade. By 1977, about one-third of the State legislatures had enacted legislation dealing with career education and had appropriated State funds to facilitate the infusion of career education into ongoing educational programs. The Federal Congress had enacted specific legislation dealing with career education (Section 406 of Public Law 93-380) and 49 states and five territories, with Federal financial assistance, were developing state plans for the implementation of career education.

The growth and development of career education was sustained and supported from many sources, including local school districts, state educational agencies, and the business-labor-industry-professional-government community. One of the key sources of support for the career education movement has been the career education activities of the U.S. Office of Education. The role of the U.S. Office of Education in the conceptualization and development of career education has been described by Professor Edwin L. Herr of Pennsylvania State University in a recent publication.<sup>1</sup>

One of the earliest and most widespread of the U.S. Office of Education's efforts in career education was the support of career education pilot projects with funds obtained from Part C and Part D of Public Law 90-576. Part C funds, totalling \$18 million, were used to support two rounds of career education pilot projects. Each round was 18 months in duration and consisted of 56 grant awards (one in each state and territory of the United States). Part D funds, totalling approximately \$47 million, were also used to support two rounds of career education pilot projects. Each round was 36 months in duration, with 66 projects in the first round and 58 projects in the second round. In other words, during the first half of this decade a total of 236 career education pilot projects were supported with funds from Part C and Part D of Public Law 90-576. These pilot projects represented some of the earliest attempts to bring model programs of career education into operation in local school districts. An overall summary of this effort has been provided in a U.S. Office of Education document dated June 1972 and entitled *Development of Model Career Education*.

*Programs Under Part C and Part D of Public Law 90-576 (ED 065 712).* A discussion of the relationship of the Part C and Part D pilot projects to the overall career education movement can be found in two journal articles published in 1974 and 1976.<sup>2, 3</sup>

As career education moves ahead in the second half of the 1970's, it is obvious that much could be learned from the experiences of the early pilot projects undertaken under Part C and Part D. Abstracts of the Part C and Part D projects, compiled from the original proposals submitted by the grantees, are available in the ERIC system under the accession numbers ED 063 520, ED 136 068, ED 099 518, and ED 099 523. However, these abstracts are very brief and are based on the original plans proposed by the grantees rather than upon the actual accomplishments of the projects. A person wishing to gain insights from the actual experiences of the pilot projects would need to examine the interim, supplemental, and final reports which were submitted to the U.S. Office of Education by the grantees and which document the actual experiences and accomplishments of each project.

Many of these official reports, which have appendixes containing sample instructional materials, teachers guides, etc., have been entered into the ERIC and/or AIM/ARM systems and are available on microfiche to users of these systems. The problem is that it is very difficult for an individual user to locate the reports from among the thousands of documents stored in the ERIC and AIM/ARM collections. What has been needed to make this large body of information available to career educators is an index which would provide the ERIC and AIM/ARM accession numbers for the interim, supplemental, and final reports.

Such is the purpose of this index. The potential user can examine the abstract volumes (ED 063 520, ED 136 068, ED 099 518, and ED 099 523) and select from the abstracts certain projects which seem to be closely related to the user's area of interest. By referring to this index, the user can obtain the accession numbers of the interim, supplemental, and final reports for the selected projects. It is then a simple matter, with the accession numbers in hand, for the user to retrieve these specific reports from the ERIC and/or AIM/ARM systems:

## SUGGESTIONS FOR USERS

### Organization of Indexes

The indexes contained in this volume are a guide to help the user locate and review the products of selected projects funded under Part C and Part D of Public Law 90-576.

The four indexes presented here are divided into two categories: reports resulting from Part C pilot projects and reports resulting from Part D pilot projects. The Part C projects were funded for a period of 18 months and include a final report. Many of these projects also resulted in the development of curriculum materials, evaluation reports, and other supplementary materials. However, the only mandatory product was a final report and in many cases the "Supplementary Reports and Materials" field is blank. Part D projects were funded for three years and products should include a first and second year interim report as well as a final report. As in the case of Part C projects, the "Supplementary Reports and Materials" field may be left blank.

The user will see that, at times, the mandatory fields of first and second year interim reports and final report do not contain an ED or ED/VT number. Instead, these fields may contain an alphabetic single-digit code or a CE number with an alphabetic superscript. These codes are listed in a key at the end of this section and represent documents that: (1) could not be located in the ERIC and AIM/ARM systems; (2) have been accepted by the ERIC system but are still in process; (3) did not meet ERIC selection criteria and are included in a document collection of the National Center for Research in Vocational Education, Information and Field Services Division; (4) were reported as never received by the U.S. Office of Education; and (5) are only contained in the National Center's library.

One of the functions of the National Center for Research in Vocational Education is to act as a clearinghouse of information on projects supported by vocational education legislation. Recently, an effort was initiated to develop a "tracking system" to identify the research reports and products emanating from these projects, and to note their availability, that is, inclusion in the ERIC system. Documents that do not meet ERIC selection criteria are retained by the clearinghouse and are shelved by the ERIC inhouse accession (CE) number.

### Key to the Alphabetic Codes Used in the Indexes

- a Used as a superscript, this letter represents documents that are not in the ERIC system. They are available for onsite review at the National Center for Research in Vocational Education. Contact the Program Information Office for further information regarding these documents.

- b This letter represents documents that were unable to be identified or located in any system.
- c This letter represents documents that the U.S. Office of Education reports no record of ever receiving.
- d Used as a superscript, this letter represents documents that have been accepted by the ERIC system but are still in process and have not yet been assigned an ED number. To convert the CE number to an ED number, the user should consult the cross-reference lists included in future issues of *Resources in Education* (RIE).
- e Used as a superscript, this letter represents a very small number of documents that were not included in any system and are available only for onsite review at the National Center's library.

### How to Use the Indexes with the Four Abstract Volumes

This publication has been developed as a companion to four volumes of abstracts. Each of the four volumes present in-depth descriptions of the funded pilot projects. A user may review the abstracts of the projects and select the ones relevant to his/her interests and needs. Since the abstract volumes only discuss what the projects proposed to do, the user would necessarily need to review the products of the projects to determine what actually was accomplished. After selecting the projects that are of interest, the user would then turn to the appropriate index to identify the disposition of the products.

The four indexes represent, respectively, products resulting from the first and second rounds of Part C funding and the first and second rounds of Part D funding. The four volumes of abstracts also represent the first and second rounds of Part C and D funding.

1. Abstracts of Research and Development Projects in Career Education. ED 063 520. (First Round of Part C Funding).
2. Abstracts of Research and Development Projects in Career Education. Fiscal Year 1973 Program. ED 136 068. (Second Round of Part C Funding).
3. Abstracts of Exemplary Projects in Vocational Education. ED 099 518. (First Round of Part D Funding).
4. Abstracts of Exemplary Projects in Vocational Education. ED 099 523. (Second Round of Part D Funding).

By using this publication in conjunction with one or all of the four volumes listed above, a user can "track" or follow-up what originally was proposed by a project and what the actual outcomes were.

## How to Locate ERIC Microfiche Collections in Your Area

There are approximately 600 ERIC Microfiche Collections throughout the United States. Many of these are located in State Departments of Education and major universities. The ERIC System produces a directory listing the location, telephone number, contact person, status of the collection, type of equipment and services available, and the access hours of each. ## Locating Documents Within an ERIC Microfiche Collection

The documents, cited in the four indexes, that are available from the ERIC system have been listed in two ways: (1) a six-digit number preceded by the "ED" designation (e.g., ED 101 067) or (2) a six-digit number preceded by the "ED" designation followed by a six-digit number preceded by the "VT" designation (e.g., ED 109 467/VT 101 972). All documents of the first type ("ED" designation only) have been entered into the ERIC system individually. A user need only find the sequentially ordered ED number in the microfiche collection to obtain a complete copy of the document.

Documents of the second type ("ED" designation followed by a "VT" designation) have been entered into the ERIC system in sets. These documents were originally processed by the AIM/ARM system (Abstracts of Instructional and Research Materials in Vocational and Technical Education). A user would first locate the ED number within the microfiche collection. This ED number represents a set of documents that are VT numbered, arranged in ascending order, and filmed continuously. This means that each document usually will not begin on a separate card of microfiche. After locating the set ED number the user would look through the set until the desired VT numbered document is located.

## How to Obtain Documents from the ERIC Document Reproduction Service (EDRS)

Individually numbered ED documents may be purchased in microfiche and/or paper copy from EDRS. Documents contained in ED/VT microfiche sets are available *only* as sets. This means that if a single ED/VT numbered document is desired, the entire set must be purchased to obtain it. These ED/VT sets are available only in microfiche. An EDRS order form is included at the back of this publication and lists complete ordering instructions. Since reproduction and mailing costs are ever increasing, it is wise to check the current price of a document with EDRS before ordering.
