ABSTRACT

This group of six library guides, designed to introduce the student to some of the bibliographical tools available in various subject areas at the Folger Library, is not intended to be a complete listing, but rather a selective introduction to the many sources of information available to the beginning researcher. Information is provided on the use of the card catalog, Library of Congress subject headings, call numbers, and Dewey Decimal Classification related to the specific topic being presented. The researcher is further directed to atlases, bibliographies, biographical sources, dictionaries, dissertations, government publications, handbooks, indexes and abstracts, manuscripts, microforms, newspapers and periodicals, style manuals, audiovisual sources, yearbooks, and other reference materials. Subjects included in this group are Communication and Rhetoric, Communication Disorders, Economics, Forestry and Wildlife, Information on Women, and Social Welfare. (PAA)

It is by no means a complete list: A Reference Librarian is available to assist in the location of additional information and direct you to Fogler Library holdings.

BOOKS AND THE CARD CATALOG

The card catalog, located on the first floor opposite the Circulation/Reserve Desk, is a general index to the Library's book collection. In it books are listed alphabetically by *author, title, and subject.*

Subject Headings

All call numbers are on the upper left hand corner of the catalog card. The first line of the call number is particularly important. It indicates whether the material is in the general collection or in a special area.

Copying the entire call number as it appears on the catalog card will facilitate locating the material in the Library. Large yellow charts near the card catalog give the location of books bearing these numbers and designations.

These abstracts of doctoral dissertations are issued monthly in two sections. Part A (Humanities and Social Sciences) includes speech, theater, language and languages, linguistics, etc. Part B (Science and Engineering) includes human development, mental health, audiology and psychology. Each volume has a key word title index and an author index. Author indexes are cumulated annually. (v.1-13, 1938-53 are in Microform Room. Ask for D632.)

Provides author and subject approaches to dissertations included in the first 29v. of Dissertation Abstracts International. Covers years 1938-1969. Index reference gives order number as well as volume and page numbers for the abstract. A comprehensive subject index appearing in each volume and a table of contents for each volume facilitate use. It is superseded by the Comprehensive Dissertation Index, though it will continue to be useful for those who prefer reading text instead of microfiche.

International in scope with European and U.S. psychologists as authors of signed articles. Material ranges from short definitions to long articles with bibliographies. Good for brief identification of concepts in psychology.

International Encyclopedia of the Social Sciences. 17 vols. David L. Sills, ed. 1968. v.17 is the Index for the set. Many articles have bibliographies.

The articles and bibliographies in this encyclopedia emphasize analytical and comparative aspects of the topics covered. It's predecessor, Encyclopedia of the Social Sciences (Ref H40 A2 E5) is still useful for historical material.

This basic book on rhetoric is organized into four sections: basic theory; message development for public speaking and formal writing; message communication in small groups and everyday encounters; and ethics in communication. catalog. Indexes and Abstracts are the keys to this type of literature.*

*An Index is usually arranged by subject and provides a citation to the
article. This includes the title of the article, the author's name, the
title of the journal, volume number, pages, and date. An Abstract citation
provides similar information but includes a short summary of the article.
The subject headings used in these indexes and abstracts are similar to
those used in the card catalog.*

*The Indexes and Abstracts described below should be of particular interest
to the student of Communication and Rhetoric. Most of them are located
in the Index Room which is adjacent to the Reference Room. An asterisk
indicates computer searches are available.*

Publishes abstracts relating to the growth and development of children
and provides more coverage in this area than does Psychological Abstracts.
Includes sections on cognition, learning, perception, psychiatry and
clinical psychology.

The primary emphasis is on education journals but it is useful for topics

The basic index to literature in the field and the one that should perhaps be checked first. Covers books as well as journals. Cumulative subject and author indexes shelved nearby. Computer Searches available. 1967+.

Readers Guide To Periodical Literature. 1900+
A cumulative index of 160+ popular, nontechnical periodicals. Articles listed alphabetically by author, title and subject. Catalog subject headings used.

Index AI 3 S62 (Reference Table)
Social Sciences Index. 1974+
Interdisciplinary author and subject index to journals in the social sciences. Organized like the Readers' Guide. Book reviews may be found at the end of each issue.

Part I consists of outstanding articles of fifteen journals in Speech Communication listed separately by Journal, issue by issue. Part II is the Subject Index; part III is on Index of Contributors. Covers articles from 1915 - 1974.

The Master Periodical List is a computer print-out listing the journal titles, newspapers and indexes held by Fogler Library, Bangor Community College and the Darling Center. Copies of this list may be found in the Reference Room, the Index Room and through-out the stacks. Consult this print-out when you have found the citations that you need in the indexes and abstracts.

JOURNALS

A list of the Journals held in Speech Communication at Fogler Library is distributed from the Periodicals Desk. Communication and Rhetoric covers a number of disciplines. You may, therefore, wish to pick up other folders in related fields.

Government Documents:

The Government Documents Department, located on Level 1B, is a valuable source of information. The tool which provides access to the collection is called the Monthly Catalog of U.S. Government Publications. Materials on Speech Communication and research relating to child development will be found in this department. A Government Documents Librarian will be happy to assist you.

Information File:

This file is located in a series of metal filing cabinets along the north wall of the Reference Room. It includes the latest information on a particular subject from the most authoritative sources possible. Check the authority file for appropriate key words.

The Learning Materials Center:

LMC, located on Level 3, houses an educational resources collection composed of a Juvenile Collection, Teen Collection, Textbooks, Curriculum Guides, Vertical Files, and an Audio-visual Collection. Many of these items are not listed in the main catalog. LMC has its own catalog. Curriculum guides and Vertical File materials have subject listings. There are Librarians available to assist you in using these materials.

Special Collections:

The Special Collections Department is one of the primary sources for the Study of Maine's past, present, and future. Manuscript items, rare books, Maine authors, and University of Maine theses are examples of holdings in Special Collections. Some items pertaining to Speech Communication are the Theatre Collection materials, graduate theses written by Speech Communication students, and the textbooks and manuscripts by Hershel Bricker. The Department has its own card catalog. A Librarian will help you find additional material.

APA Publication Manual. American Psychological Association. 1974. Originally prepared for contributors to the journals published by the APA, this manual now contains a section on student papers. Useful if APA journals are used in term papers.

Ref LB 2369 C3 (Reference Desk)

Campbell & Ballou. Form and Style: Theses, Reports, Term Papers. 4th ed. 1974. Written to assist students in the preparation of term papers, research reports, and dissertations. Illustrates style and placement of footnotes, bibliographic references, etc. Includes new section on handling tables, figures, and computer materials.

MLA Handbook for Writers of Research Papers, Theses, and Dissertations. 1977. Also called the MLA Style Sheet. Is used for scholarly research reports and university press material. This form is prescribed by most graduate schools for M.A. theses and doctoral dissertations.

Strunk & White. Elements of Style. 3rd ed. 1979. A concise, interesting style book for the beginning writer. It contains rules of English usage, principles of composition, and a "chapter on writing."

Turabian, Kate. Students Guide for Writing College Papers. 3rd ed., 1976. Most popular style manual. Contains sections on numbers and punctuation which did not appear in earlier editions. Companion Volume: A Manual for Writers of Term Papers, Theses and Dissertations. (Ref LB 2369 T8 Desk)



You may want to know ...

That the library has over 40 journals in speech and speech related topics. There are booklets listing these journals in alphabetical order in the Periodicals Room. Take one and go from A to Z. It is a good way to become familiar with current literature in the field.

That a computer search may be run on your topic. Check with a Reference Librarian who will tell you how this is done and what it will cost.

That the Interlibrary Loan Dept. will help you obtain material that is essential to your paper, but is not in the Fogler Library holdings.

That you should check with the Circulation Department if you do not locate a book on the shelf.

That a Reference Librarian will be happy to help you with material described in this booklet and with any other questions you may have about the library.

More than 100 years of dissertations arranged by discipline and key words. Supplements are issued annually. Serves as a subject index for Dissertation Abstracts International.

These abstracts of doctoral dissertations are issued monthly in two sections. Part A (Humanities and Social Sciences) includes speech, theater, language and languages, linguistics, etc. Part B (Science and Engineering) includes human development, mental health, audiology and psychology. Each volume has a key word title index and an author index. Author indexes are cumulated annually. (v.1-13, 1938-53 are in the Microform Room. Ask for D632.)

Provides author and subject approaches to dissertations included in the first 29v. of Dissertation Abstracts International. Covers years 1938-1969. Index reference gives order number as well as volume and page numbers for the abstract. A comprehensive subject index appearing in each volume and a table of contents for each volume facilitate use. It is superseded by the Comprehensive Dissertation Index, though it will continue to be useful for those who prefer reading text instead of microfiche.

Supercedes Exceptional Child Education Abstracts. May be used for computer searches. Abstracts cover education of gifted and handicapped. Arranged numerically. Author and subject cumulative indexes. Computer searchable 1966+

Index Medicus. 1960+

Only articles related to biomedicine are included. Indexes, journals and monographs. Contains Medical Subject Headings Index, Bibliography of Medical Reviews indexed by author and subject, and cumulated Index Medicus author and subject Indexes. Is computer searchable through Medline 1966-

LLBA: Language and Language Behavior Abstracts. 1974+

Covers scholarly articles in Language and Language Behavior. Has headings under communication sciences, hearing, linguistics, psychology, etc. with sub-headings. Includes abstracts from 1000+ sources. Author indes.

The basic index to literature in the field and the one that should perhaps be checked first. Covers books as well as journals. Cumulative subject and author indexes shelved nearby. Computer Searches available. 1967+-

Part I consists of outstanding articles of fifteen journals in Speech Communication listed separately by Journal, issue by issue. Part II is the Subject Index; part III is an Index of Contributors. Covers articles from 1915 - 1974.

The Master Periodical List is a computer print-out listing the journal titles, newspapers and indexes held by Fogler Library, Bangor Community College and the Darling Center. Copies of this list may be found in the Reference Room, the Index Room, and through-out the stacks. Consult this print-out when you have found the citations that you need in the indexes and abstracts.

A list of the Journals held in Communication Disorders at Fogler Library is distributed from the Periodicals Desk. Communication Disorders covers a number of disciplines. You may, therefore, wish to pick up other folders in related fields.

The Document Depository, located on Level 1B, is a valuable source of information. The tool which provides access to the collection is called the Monthly Catalog of U.S. Government Publications. Materials on Deafness, Speech, and research relating to child development will be found in this department. A Documents Librarian will be happy to assist you.

Information File:

This file is located in a series of metal filing cabinets along the north wall of the Reference Room. It includes the latest information on a particular subject from the most authoritative sources possible. Check the authority file for appropriate key words.

The Learning Materials Center:

LMC, located on Level 3, houses an educational resources collection composed of a Juvenile Collection, Teen Collection, Textbooks, Curriculum Guides, Vertical Files, and an Audio-Visual Collection. Many of these items are not listed in the main catalog. A Librarian will be happy to help you locate materials.

Special Collections:

The Special Collections Department is one of the primary sources for the Study of Maine's past, present, and future. Manuscript items, rare books, Maine authors, and University of Maine theses are examples of holdings in Special Collections. Some items pertaining to Communication Disorders are State Documents, and graduate theses written by Speech Department students. A Librarian will help you find additional material.

You may want to know ...

That the Library has over 40 journals in speech, or speech related subjects. There are booklets listing these journals in alphabetical order in the Periodicals Room. Take one and go from A to Z. It is a good way to become familiar with current literature in the field.

That a computer search may be run on your topic. Check with a Reference Librarian who will tell you how this is done and what it will cost.

That the Interlibrary Loan Dept. will help you obtain material that is essential to your paper, but is not in the Fogler Library holdings.

That a Reference Librarian will be happy to help you with material described in this booklet and with any other questions you may have about the Library.

That you should check with the Circulation Department if you do not locate a book on the shelf.

GUIDE TO SOURCES: ECONOMICS

SCOPE

This guide is designed to introduce the student of economics to some of the major sources of information available in the Fogler Library. The bibliographies, dictionaries, encyclopedias, handbooks, indexes, and other specialized tools in the Reference Room can supply needed information or direct you to sources that contain it.

CARD CATALOG

The card catalog is the key to books and other library materials. It functions as an index to a major portion of the resources found in the Library.

Each book or item included in the card catalog has an *author* card, a *title* card, and one or more *subject* cards. There are many subject headings related to the study of Economics. A few examples are listed below.

SUBJECT HEADINGS

Library of Congress Subject Headings is a two volume guide to the headings used in the card catalog. It can lead you from an incorrect subject heading to a correct one. Knowledge of this tool will save time and may also open new avenues of approach to your subject. Copies are located at the card catalog and behind the Reference Desk. A Reference Librarian will be glad to show you how to use it.

CALL NUMBERS AND CLASSIFICATION

Most of the books in Fogler Library are classified in the Library of Congress Classification System (LC) which is based upon letter and number combinations. The call number of a book classified in this system is shown below:

- Ref Location symbol - Indicates the book is in Reference
- HB Class - Economics
- 61 Subclass - Encyclopedias. Dictionaries
- M16 Derived from author's name

There are still volumes in the Library classified in the Dewey Decimal System (DDC) which was used prior to 1967. These books, though older, may still be useful. Example:

- 331.4 Class - Economics. Labor. Women.
- F56 Derived from author's name

All call numbers, LC or Dewey; are found in the upper left hand corner of the catalog card. Copy the entire number. Large charts near the card catalog give the stack location of books bearing these numbers.

Topics of current interest, preliminary reports of fieldwork, and other research are found in journals and other serial publications. Periodical indexes and abstracts are the keys to this type of literature.

An Index is usually arranged alphabetically by subject and supplies bibliographic citations to articles in magazines, books, pamphlets, etc. The citation for a periodical article contains the following elements:

- Name of author(s)
- Title of article
- Name of journal
- Volume number and date
- Inclusive page numbers

An Abstract supplies all the above, plus a summary or description of the article.

CARD CATALOG

The card catalog is the key to books and other library materials. It functions as an index to a major portion of the resources found in Fogler Library.

INFORMATION ON WOMEN

This information sheet has been compiled to assist the user in finding materials on Women. Many areas in the Library are involved. Check the direction charts on the wall by the card catalog for the location of a specific area. New materials are received frequently. A Reference Librarian is available to assist in the location of additional information and direct you to Fogler Library holdings.

BOOKS AND THE CARD CATALOG

The card catalog, located on the first floor opposite the Circulation/Reserve Desk, is a general index to the Library's book collection. In it books are listed alphabetically by *author, title, and subject.*

Subject Headings

All call numbers are on the upper left hand corner of the catalog card. The first line of the call number is particularly important. It indicates whether the material is in the general collection or in a special area. Copying the entire call number as it appears on the catalog card will facilitate locating the material in the Library. Large yellow charts near the card catalog give the location of books bearing these numbers and designations.

Abstracts and Indexes are the keys to Journal articles. An index is usually arranged by subject and provides a citation to the article. This includes the title of the article, the author's name, name of the journal, volume number, page and date. An abstract provides the same information as an index, plus a short summary of the article. The subject headings used in these indexes and abstracts are similar to those used in the card catalog.

Most abstracts and indexes are in the Index Room which is adjacent to the Reference Room, or on tables in the Reference Room. A few may be found in the Documents Depository.
