ABSTRACT

Registration data from six Hawaii community colleges were examined to determine the characteristics of those students enrolled in credit programs during Summer 1980. Data were collected and analyzed on headcount enrollment and students' age; sex; program; status as continuing, new, or transfer students; citizenship; permanent and local residence; and semester hours carried. Major findings revealed that 3,047 regular students were enrolled in credit courses, representing a 9% increase from the previous summer's enrollment of 2,807. Further analysis of the data indicated that: (1) the number of males decreased from the previous year by nine students, while the number of females increased by 242; (2) 30% of the students were liberal arts majors, 28% were in vocational programs, and 41% were unclassified; (3) the majority of the students enrolled were continuing students; (4) the mean student age was 26.5 years; and (5) the students carried an average load of 4.1 credit hours and generated 12,485 semester hours. The study report presents findings for each campus and compares results with data collected each summer since 1976. (JPI)

THE 1980 SUMMER SESSION COMMUNITY COLLEGES

This report is a brief summary of selected data on students enrolled in the summer credit programs of six community colleges.¹

Sources of Data

Most of the data cited in this report were abstracted from the Student Enrollment Reports (SERs) dated July 1, 1980. Data for these reports were derived from student applications and class registrations. Headcount enrollment figures in non-credit and community service programs (Table 1), however, were provided by the deans of instruction, coordinators of programs and/or registrars of the various campuses.

Highlights

1. Headcount Enrollment, All Students (Table 1)

Enrollment in credit and non-credit programs for the summer term total 13,239. Of this figure, registrations in "other programs" number 10,135 (77%) and 3,104 (23%) in "regular credit programs". Included in the count of "other programs" are registrations in such programs as Hawaii State Senior Centers, job-experience, Kalihi-Palama Education Center, etc.

2. Selected Characteristics of Classified and Unclassified Students (Tables 2 and 3)

The enrollment of 3,047 regular students represents a 9% increase from last summer's enrollment of 2,807. Individual college enrollment figures show that enrollment increased at five campuses (ranging from 4% to 160%) and remained stable at one campus.

- a. Sex: Although there are slightly more males than females this summer (1,532, 50% compared to 1,502, 49%), a comparison with last summer's figures show that the number of males decreased by 9 students whereas the number of female students increased by 242. (This is the first time the number of female students almost equalled that of male students.)
- b. Program: 30% of the students were liberal arts majors; 28%, vocational majors; and 41%, unclassified. The comparable figures last summer were 35%, 31% and 33%, respectively. Individual campus patterns differ markedly: the proportion of liberal arts majors ranged from 10% to 50%; vocational education majors, from 3% to 42%; unclassified, from 33% to 82%.

- c. Registration Status: As in past summers, "continuing" students (1,941, 64%) comprise the bulk of the students followed by "transfer" students (562, 18%) and "new" or "first-time college" students (359, 12%). Further analysis of the 562 transfer students shows: (1) over half, 291, 52%, are transfers from within the University system; (2) 19, 3%, are transfer students from other Hawaii institutions; and (3) 143 or 25% are from Mainland institutions. Particularly noteworthy is that transfers from Manoa number 190, 88 of whom are attending Leeward Community College and 58, Honolulu Community College. The remaining 44 students are attending Maui Community College (38) and Kauai Community College (6). (Data on "last college attended" were missing for 109 transfer students.)
- d. Citizenship and Permanent Home Address: Well over 90% of the students are U.S. citizens with Hawaii State permanent home addresses.
- e. Age: The mean age of 26.5 years is the lowest in five summers. Noteworthy is that the mean age of the summer session students is about 2 years older compared to the regular students of the Fall 1979 semester (24.8 years).
- f. Local Address: Data for the Oahu campuses show that students are attending colleges near their homes: 66% and 78% of the students at Honolulu and Kapiolani, respectively, had Honolulu local addresses; 81% of the Leeward students and 96% of the Windward students live in the locality of their campuses.
- g. Student Semester Hours: Regular credit students carry an average of 4.1 credits and are generating 12,485 student semester hours. (Last summer, students averaged 3.9 semester hours for a total of 11,030 student semester hours.) Two-thirds of the SSHs are in general education courses.

Summary

An increase (9%) in the number of regular credit students is shown for the community college system. Especially noteworthy is that female students increased both numerically and proportionately, compared to previous years.

A notable difference between the summer student and the regular semester student is age. Compared to the regular semester student (24.8 years old), the summer student is older (26.5 years old) by about two years.

APPENDIX A

DEFINITIONS

Headcount Enrollment All Students

The sum of all students enrolled in regular credit courses and other programs. This may be a duplicated headcount for the Community College System.

Registration Status

Continuing Student

A student registered at this campus the previous semester.

Returning Student

A student returning to this campus after an absence of one or more semesters, and did not attend another institution of higher education in the interim.

First-time Student

A student enrolled for the first time at this campus, who was never enrolled at an institution of higher education except as an early admit.

Transfer Student

A student who was enrolled at another college/university campus prior to attending this campus.

Special Student

Early Admit

A qualified high school student enrolled in regular credit courses while completing high school graduation requirements as well.

Total Student Semester Hours

The sum of semester hours taken by all students registered in all regular credit classes excluding audited semester hours. (Semester hours taken in Continuing Education classes are excluded.)

Student Semester Hour(s) - The number of credit hours one student registers for per class. Usually student semester hours are fixed by the credit value assigned to a class, but sometimes they are variable depending on the work expected of the student.
