Consultation: A collection of references from education and psychology was developed for the professional practitioner in counseling, school psychology, personnel services, and educational administration. There has been a great deal of interest in recent years surrounding consultation in the schools. A number of authors in education and psychology have provided important theoretical papers on the topic. Many research-oriented projects have yielded valuable information on the critical variables and conditions for successful consultation.
