ABSTRACT

A series of tables are presented, providing a student profile based on unduplicated headcount enrollments for 1983-84 and illustrating enrollment trends. The first section looks at general enrollment trends, providing information for the college as a whole and by campus. These tables provide 5-year summaries of annual unduplicated credit and noncredit enrollments, full-time equivalents (FTE), and enrollment by gender, full-time/part-time status, discipline, and end of term student counts. The next series of tables considers ethnic enrollments by average credit load, student declaration of degree type, gender, and age. The last group of tables focuses on trends among new and continuing students, looking at full-time/part-time enrollments, FTE, average credit load, enrollment status, new freshmen enrollments, gender, cumulative credits earned, and residency. Accompanying analyses point to a 8% decline in the absolute numbers of students between 1979 and 1984; a trend toward increasing credit loads which peaked in 1981-82 and reversed itself in 1982-83; and a persisting male to female ratio of 4:5. 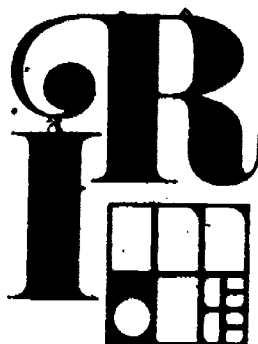

**Annual Student Profile
Summary Data on Unduplicated Enrollment
for the Academic Year 1983-84**

General Enrollment Trends

The Annual Student Profile provides unduplicated enrollment summary data for the entire academic year with respect to such major variables as credit/non-credit enrollments, semester credit FTEs, and average credit load. These variables are presented in college-wide and campus tables. Comparisons of the major variables are made against ethnicity, degree type declaration, gender, age, full-time/part-time status, enrollment codes (J, L, M), and residency, all across years.

Tables 1-3 are five-year summaries (1979-1984) of credit or non-credit enrollments, each with its own unique variations. Table 1 shows full-time equivalents (FTE) and average credit load comparisons for credit enrollments. College-wide over the past five years, there has been a steady decline in absolute numbers of students (8.0%). The trend of increasing average credit load peaked in 1981-82 and reversed itself in 1982-83. In comparing the past two years, it is evident that a 0.4 decrease in average credit load resulted in a considerable drop of FTEs (1,514). For the second consecutive year, the average credit load drop at Wolfson Campus was relatively large. Though Wolfson enrollments are growing, their FTEs are shrinking. Relatively small fluctuations characterize Medical Campus data. On North and South, declines are gradual and consistent across headcount, FTE, and average credit load.

The counterpart of Table 1 credit enrollment is the non-credit enrollment of Table 2. Credit load is not a concept applicable to the non-credit area. Non-credit enrollments in this table include courses in the broad Community Instructional Service discipline and overlap with the non-credit portions of the occupational and developmental disciplines. If the 1981-82 HELP grant influence were removed, the sharp downward trend of student enrollments, college-wide, becomes more neutral. FTEs in 1983-84 have settled back to pre-HELP levels. North and Wolfson show declines in both

enrollments and FTEs, but South shows a moderate headcount recovery. Medical Center offers no non-credit courses but generates FTEs that are associated with Supplemental Education Units (SEU) for laboratory and tutorial services related to credit areas.

Beginning in 1983-84, all data in the Annual Profile that are reported to the State Department of Education are categorized not by the usual academic year, but by the State Reporting Year. The State Reporting Year runs, in this case, as Spring 82-3/Summer 82-4/Fall 83-1/Winter 83-2. Whenever it occurs, the data are asterisked. In this report, the only data so affected are non-credit data. This term reformatting was State mandated to accommodate legislative needs.

Table 3 contains headcount by gender. College-wide, even beyond the five-year summary, the trend has been well-fixed in female enrollment dominance. The ratio (male:female) continues to persist at approximately 4:5. North is nearly balanced in its mix of genders with the other campuses heavily female, particularly at Medical Center (1:3).

Tables 4-8 deal with more detailing by gender of credit enrollments, average credit load, and age. College-wide (Table 4), the heaviest average credit load (12.1+) was carried by the younger students (ages 14-30) across years. This younger group generated more than 83% of the total semester credits. Males carried more semester credits (6.3%) than females in this age range. For all campuses (Tables 5-9), the first three age categories mirror college-wide data with regard to the concentration of semester credits. Deviations from college-wide data follow. On South Campus (Table 6), 81.1% of semester credits are generated by those 25 years or younger. On Medical Center Campus 88.9% of the semester credits come from the age 40 and below age categories. Those age 40 and below carry an average credit load of 12.0 to 21.3. Within each of these age categories on Medical, the average load is heavier than on any of the other campuses.

Table 9 presents trends in full-time/part-time enrollments. Full-time has been defined as 30 or more semester credits annually. In 1983-84 part-time enrollments increased proportionately such that the ratio of

full-time to part-time is now nearly 1:7 college-wide. Wolfson Campus has a 1:9 full-time/part-time ratio and Medical Center's ratio is roughly 1:5.

Tables 10-14 summarize FTEs by discipline for M-DCC and its campuses. Non-credit FTEs are not applicable to the Advanced and Professional discipline. College-wide in 1983-84 (Table 10), non-credit FTE in the occupational and developmental disciplines amounted to 936 of all funded FTEs (3.0%). This is down somewhat from the previous year. The balance of FTEs are credit FTEs. (Credits and their concomitant FTEs are related to disciplines through the assignment of a specific discipline code to each and every course.

There are two types of non-credit course fundings -- FTE and non-FTE. Non-FTE funded courses are confined to certain non-credit courses. They include those under the broad Community Instructional Service disciplines. These CIS courses accounted for 2.1% of all discipline course funding. Continuing the pattern of past years, North Campus (Table 11) generated the bulk of the college-wide non-credit occupational and developmental FTEs (63.8%) in 1983-84. South Campus (Table 12) was highest in funded FTEs (41.9%) among campuses. Medical Campus (Table 14) generates mainly credit FTEs.

Tables 15-19 give both credit and non-credit FTEs by closing term. As noted earlier in Table 2, configurations for the 1983-84 non-credit data are by State Reporting Year. For the most part college-wide (Table 15), headcount for both credit and non-credit FTEs are largest during the Fall term. With each successive academic term, there is a corresponding decrease of FTEs. Within the Fall term over the past three years, FTEs have been dropping primarily due to decreases of non-credit FTEs. The latter accounts for 66.3% of the Fall FTE drop. Absolute and proportional drops in non-credit FTEs are greatest in the Fall term. A corollary to the non-credit FTE is the non-credit headcount. Non-credit FTE and non-credit headcount parallel each other trendwise and can be traced to North Campus (Table 16) for 59.5% of the college-wide FTE decline. On Wolfson Campus, the increase of headcount could not offset the decrease in FTE (22.8% of college-wide FTE drop).

Ethnic Enrollment Trends

Tables in this section deal with various aspects of ethnic enrollments. These include average credit load by age and degree type declaration by gender. College-wide (Table 20), the pattern of decreasing white non-Hispanic and black non-Hispanic enrollments is obvious such that for 1983-84, the proportions are 33.5% and 15.9% respectively. Hispanic enrollments, as cited in a number of past studies, continues to increase. It is now 48.6% of college-wide proportions. Through a five-year headcount decrease, average credit load has remained fairly constant. The average credit load (ACL) in the past year dropped somewhat college-wide and can be attributed to declines among white non-Hispanic and Hispanic credit loads. For black non-Hispanics, the ACL was constant. Among the major ethnic groups, ACL is lightest among white non-Hispanics and heaviest among Hispanics.

On North Campus (Table 21), the 0.3 decline in ACL is traced to white non-Hispanics and Hispanics. Though black non-Hispanic enrollments have declined, the ACL has risen slightly. Data for South Campus (Table 22) show a slight overall decline in number of students and ACL. Unlike the other two major ethnic groups, black non-Hispanic enrollments are rising somewhat, but the ACL has dropped a complete semester hour. This is the reverse of North Campus data for this ethnic category. As an entirety on Wolfson Campus (Table 23), enrollments over the past three years have risen, but the ACL has fallen 2.2 average semester credits. This may indicate a shift in full-time/part-time proportions. The average credit load on Medical Campus (Table 24) has stabilized after a period of moderate declines. While white non-Hispanic enrollments are still the majority category (41.2%), the proportions have diminished over the past five years. Conversely, Hispanic enrollments are expanding and have risen to 32.3% in the last academic year. Black non-Hispanic proportions fluctuated as much as 4.6% in five years.

Tables 25-29 present ethnic gender enrollment by degree type (as declared by the student). College-wide data (Table 25) reveal proportional

relative stability with respect to the Associate in Arts and Associate in Science degrees across years. The slight Associate in Arts degree shifts that have occurred are into the non-degree category. Roughly three-quarters of the students declare a degree intent. Proportional stability can also be seen in North and South Campus data (Tables 26, 27). However, on Wolfson Campus (Table 28), Associate in Arts declarations have decreased by 5.0% while the Associate in Science and non-degree types have increased across almost all ethnic groups. Associate in Science declarations have increased on Medical Campus (Table 29) largely among white non-Hispanic and black non-Hispanic. These proportional changes were the result of moves out of the non-degree classification.

Tables 30-34 deal with ethnic enrollment and average credit load by age ranges. College-wide (Table 30), 61.1% of the credit student population is 25 years or younger. Within group comparisons show that 69.7% of Hispanics are in this younger group, followed equally by black non-Hispanics and white non-Hispanics at approximately 53% within group. The heaviest credit load is also carried by this younger group with Hispanics carrying the greatest average number of semester credits, followed closely by black non-Hispanics. Miami-Dade Community College served nearly 25,000 students in the above 25 age categories in 1983-84.

New and Continuing Student Trends

The last section of tables in this report presents enrollment code status in relation to FTE and average credit load, credit earned ranges, and residency. The significant enrollment statuses in these tables are New Freshman (J), New Transfer (K), Continuing (L), and Former M-DCC Student (M). Continuing (L code) is defined as a previous New Freshman who re-matriculated within four successive semesters. A Former M-DCC Student (M code) is one who returned to M-DCC after an absence of at least a year. Table 35 (college-wide) depicts a loss of 1,590 new freshmen (9.6%) over the comparison year. Full-time enrollments in the four noted code categories declined. The increases in both the Continuing and Former part-time categories were insufficient to offset the more pervasive decrease across enrollment code and full-time status. FTEs among these four enrollment status codes decreased by 1,423.4 over the comparison year. The average credit load for New Freshmen increased an iota while those of the other enrollment codes decreased. North, South, and Medical Campus (Tables 36, 37, 39) data repeat college-wide patterns. While Wolfson Campus (Table 38) part-time and total enrollments are higher, FTEs are lower; average credit loads are consistently lower across all code categories.

Table 40 depicts New Freshmen enrollments (J code) across campuses and college-wide over the past five years. College-wide, the drop from 1979-80 to 1983-84 of 5,966 students represents a 28.6% decrease. In 1980-81 "Js" as a percent of annual campus enrollments peaked and has since become a smaller percent of campus enrollments with each successive year. North Campus trends reflect college-wide trends. Wolfson's upper and lower ranges of percent of annual campus enrollment (39.4%-28.4%) exceed, on both ends, college-wide percentages (30.3%-23.2%). While Wolfson has the greatest proportional percentage of new freshmen among campuses, Medical has the smallest proportional percentage of new freshmen in relation to other enrollment codes (17.5%-14.8%). Overall at M-DCC, the downward trend over the last three years represents an actual headcount decrease rather than just proportional changes with continuing students.

Full-time/part-time enrollments with regard to gender and cumulative credits earned comprise the next set of tables (Tables 41-45). The college-wide data (Table 41) show that 52.0% of enrollments had 23 or fewer earned cumulative credits (freshmen class code). This is considerably more than the 23.2% new freshmen (J) seen in Table 35. The differential here consists of part-time continuing students. Freshmen (0-23 cumulative credits) make up more than half of the part-timers (56.9%). Full-time freshmen (18.6%) make up less than one-fifth of the full-time category. Sophomores in the 48 and above credit range (both part-time and full-time) make up more than one-fourth (26.7%) of enrollments. Campus data (Tables 42-45) are left to the reader to examine.

The last set of tables (Tables 46-50) center on full-time/part-time status as it relates to gender and residency. In spite of the enrollment drop in 1983-84, Dade County enrollments increased nearly 3%. Out-of-state enrollments also increased, however slightly. Refugee enrollments (within category) dropped dramatically (79.7%). The residency code for refugees (code 6) refers to students who had to pay out-of-state tuition fees because they had not satisfied the twelve-month residency requirement. The sharp decline, in this case, indicates that only 20% of refugees had to pay out-of-state fees.
