ABSTRACT

Two bibliographies list over 200 sources of information on Latin American women living in the United States and in Latin America. The first bibliography cites books, chapters from books, journal articles, pamphlets, dissertations, and theses dealing with the lives and politics of Mexican-American, Cuban, Puerto Rican, and Central and South American women who are living in the United States. Only English language materials published since 1970 are included. Politics has been interpreted in the broadest possible sense to include the politics of the domestic as well as the public sphere. Listings are organized by the following categories: general works; Chicanas; Cubanas; Puertorriquenas; and statistical portraits, bibliographies, and reviews of the literature. Addresser of selected sources are provided. The second bibliography cites books, chapters in books, and journal articles on women's political roles in Latin America. Only English language materials published since 1974 are included. The bibliography is divided into three sections: general; national studies (in alphabetical order by country); and bibliographies and reviews of the literature. (RM)

THE LIVES AND POLITICS OF LATINAS IN THE UNITED STATES: A SELECTIVE BIBLIOGRAPHY

This bibliography lists books, chapters from books, articles, pamphlets, dissertations, and theses for the study of the lives and politics of Latinas in the U.S. -- Chicanas, Cubanas, Puertorriqueñas, and women from Central and South America. Only English-language materials published since 1970 have been included. As sources are very hard to come by (particularly for Cubanas, Puertorriqueñas, and women from Central and South America), politics has been interpreted in the broadest possible sense -- to include the politics of the domestic as well as the public sphere. Available sources on Latina women are often included even if not specifically on politics, and sources on politics are in some cases listed even if offering little specifically on women. This bibliography must be viewed, then, as just a beginning, hopefully an impetus to the further research that is needed on Latina politics in the U.S.

WOMEN AND POLITICS IN LATIN AMERICA: A SELECTIVE BIBLIOGRAPHY

This bibliography cites books, chapters in books, and articles on women's political roles in Latin America. Only English-language materials are included, and only those published since 1974. For pre-1974 references, the researcher should consult Meri Knaster's comprehensive Women in Spanish America: An Annotated Bibliography from Pre-Conquest to Contemporary Times and other bibliographies and reviews listed at the end of this document.

This bibliography is divided into three sections: "General," which includes materials treating Latin America as a whole; "National Studies," in alphabetical order by country; and "Bibliographies and Reviews of the Literature." Politics is broadly defined to include governmental and public policy roles of women, women's participation in resistance movements and community actions, and theoretical analyses of sex, race, and class as dimensions of women's political lives and attitudes. Some historical items are included, but the emphasis is on the present. Although some materials from the fast-growing field of "women and development" are listed, the coverage of socio-economic issues is far from complete.

Researchers are further cautioned that women's political participation in Latin American countries is seldom separable from larger political concerns and movements. Because this bibliography lists only materials that explicitly address women's roles, it paints a very incomplete picture of Latin American women's political lives. It is intended as a jumping-off point only.
