ABSTRACT

Results of the Residence and Migration Survey of college students for fall 1984 are summarized, based on the annual Higher Education General Information Survey (HEGIS). Data were reported by 2,883 of the 3,331 accredited institutions in the HEGIS universe. Attention was focused on: where state residents attend college, student in-migration from other states, students migrating from foreign countries, and net migration of students by state. Data include the number of first-time students enrolled in HEGIS institutions by state of residence, attendance in state or out of state, and institutional control (public/private); and the number of first-time students from foreign countries, by full-time or part-time attendance status, institutional control, and state of college attended. It was found that about 86% of first-time students attended college in their "home" state, and 14% went out of state. Texas and North Carolina led all states in the proportion of student residents who remained in their home state to attend college, followed by Arizona and California. (SW)

## Residence and Migration of College Students, Fall 1984

Of the approximately 3.4 million students enrolled for the first time in the Nation's institutions of higher education in fall 1984, 468,000 students, or about 13 percent, crossed State lines to attend college. These data are from the survey "Residence and Migration of College Students - Fall 1984," part of the 19th annual Higher Education General Information Survey (HEGIS) conducted by the Center for Education Statistics.

The Residence and Migration survey gathers data on students taking credit courses at an institution for the first time at the undergraduate, graduate, first-professional and unclassified levels. The data in this report represent responses from 87 percent of all accredited institutions of higher education (see appendix for more technical information). Data from the fall 1986 Residence and Migration survey, part of the Center's new Integrated Postsecondary Education Data System (IPEDS), will be available next summer.

Several concepts describe residence and migration of first-time students in colleges. This report focuses on four measures:

- Where State residents attend college;
- Student in-migration from other States;
- ~~Students migrating from foreign countries;~~
- Net migration of students, by State.



Where State Residents Attend College

For this survey, the home State was defined as the State in which the student was residing when first admitted to an institution at their current student level. Data can be used to show where students from a State (or State residents) attend college. Table 1 shows the distribution of State residents by their attendance of college in-State or out-of-State, and by control of the colleges attended.

Approximately 86 percent of first-time students attended college in their "home" State, and 14 percent went out of State. The majority of students remaining in-State chose to attend public institutions (table 1). Students who went out-of-State were about evenly divided in their choice of public and private colleges (figure 1).

Texas and North Carolina led all States in the proportion of student residents who remained in their home State to attend college (94 percent). Arizona followed with 93 percent and California with 92 percent remaining in-State (table 1). States with the highest proportions of residents who left their home State to attend college were the District of Columbia (47 percent),<sup>1</sup> New Hampshire (39 percent), New Jersey and Alaska (37 percent each), and Delaware (33 percent).

<sup>1</sup> About 43 percent of first-time students from the District of Columbia went to college in the adjacent States of Maryland and Virginia.

## Student In-Migration from Other States

In the District of Columbia, 7 out of 10 first-time students came from other States in fall 1984.<sup>2</sup> About 40 percent of the first-time students in Delaware, Vermont, and New Hampshire were from other States. California, New Jersey, and Nevada, however, drew only 6 percent of their students from other States. The States with highest and lowest proportions of in-migration of first-time college students from other States (as a percent of total first-time enrollment) were:

The number of first-time students who migrated into each State to attend college and the percent of student enrollment they compose for that State are shown in table 2.

## Students Migrating From Foreign Countries

In the fall of 1984, 86,600 citizens of foreign countries enrolled as first-time students in the United States (3 percent of all first-time students). Five States enrolled nearly 35,000 (40 percent) of these students (table 3). California and New York each enrolled more than 10 percent of all foreign students. Texas, Florida, and Massachusetts also had substantial numbers of new foreign students.

More than 12 percent of first-time students in the District of Columbia came from foreign nations. This was about three times more than the next two highest States, Louisiana and Florida, with 4.3 and 4.1 percent, respectively. Less than 1 percent of first-time students in Nevada and Maine were from foreign countries.


<sup>2</sup> About 36 percent of the first-time students enrolled in colleges and universities in the District of Columbia came from the surrounding States of Maryland and Virginia.

## Net Migration of First-time Students

Net migration is the difference between the number of first-time students coming into a State to attend college and the number of first-time students that left their home State to attend college elsewhere. A State has a net gain if more students migrate into the State than left the State. A net loss results when more students leave the State to attend college than come into the State. Table 4 shows the net migration of all first-time students for each State, including and excluding students from foreign countries and the outlying areas.


With foreign students included, Massachusetts, the District of Columbia, Texas, North Carolina, and Arizona showed the largest net gain of students, ranging from nearly 10,000 to more than 16,000 students. New Jersey registered a net loss of more than 36,000 students, by far the largest loss of any State. Illinois and Connecticut had net losses of about 14,000 and 9,000, respectively (figure 2).

When foreign students are excluded, net migration changes for some States. In California, a 5,000 net gain becomes a 4,000 net loss (table 4), due to the large number of foreign first-time students enrolled. Other States showing large changes in net migration are: New York (-750 to -10,100), Florida (6,400 to 300), and Texas (14,500 to 7,600). States with the highest and lowest net migrations, excluding foreign students, are shown in figure 3.

## Description of Survey

The data in this report are from the Residence and Migration survey, conducted in fall 1984 by the Center for Education Statistics as part of the Higher Education General Information Surveys (HEGIS XIX). Data include the number of first-time students enrolled in each HEGIS institution in the fall 1984, by State of residence, status (full- or part-time), and level of program (undergraduate, graduate, first-professional, and unclassified). About 7 percent of respondents supplied residence data inconsistent with reported enrollment data on the HEGIS 1984 Fall Enrollment survey.

Data were reported by 2,883 of the 3,331 accredited institutions in the HEGIS universe. No imputations were made for the 448 nonresponding institutions because this survey had not been conducted since 1981. Data for 1981 were not considered to be representative of residence and migration patterns in 1984.

The Residence and Migration survey provides data on migration patterns by State, and are available only from a national survey. However, data for each State are only as good as the data provided by institutions in that State. The response rates for this survey, by State, are shown in the appendix table A.
