ABSTRACT

The 37 funded programs described in this brochure involve bibliographic control, collection development, and preservation of library materials at research libraries, and are designed to make rare materials accessible through bibliographic control and networking. The description of each funded project includes the responsible agent conducting the research library project; the individual responsible for administering the project for the sponsoring institution; the major area of project activity; the amount of money awarded for use during the grant period; the U.S. Department of Education control number; and an abstract summarizing the project goals and activities. Appended tables summarize funding, major activities, and joint projects, and a map showing the states that have benefited from Title II-C since 1976 is included. (EW)

Foreword

"The expansion in the scope of educational and research programs and the rapid increase in the worldwide production of recorded knowledge have placed unprecedented demands upon major research libraries, requiring programs and services that strain the capabilities of cooperative action and are beyond the financial competence of individual or collective library budgets."

With these words, Congress, in the Education Amendments of 1976, launched the HEA Title II-C, Strengthening Research Library Resources Program. In the ten years since its enactment, the accomplishments of this program, which span the continent and, in some instances, the world, are many-faceted and exciting. Imagine a walk through the Newspaper Archives of the Boston Public Library with its 35,000 volumes of original newspapers. Or a visit to an exhibit from the revitalized Poster Collection in the Hoover Institution Archive, a prized historical treasure representing notable artists from around the world that documents the efforts of official and underground agencies to mobilize the public in time of crisis. Or discovering through an on-line search that microform copies of the medieval Slavic manuscripts you need are held at Ohio State University and are available for use on site or through interlibrary copying. These activities and many others of equal import have been supported with HEA Title II-C funds.

This brochure describes briefly the projects funded in fiscal year 1987, including valuable summary data in table form which provide further insight into program activities. As in previous years, this slate reflects a diversity of subject matter and design in the effort to make rare material accessible through bibliographic control and networking, through preservation, and through augmentation of already strong and unique collections. Making rare material accessible is not cost free. The Title II-C money has provided the incentive for sharing.

Abstract

The American Antiquarian Society (AAS) possesses the world's best collection of early American imprints and newspapers. From 1955 to about 1965 its staff edited the microform series *Early American Imprints: First Series (Evans)*, published by Readex Microprint Corporation, which included the text of every available book, pamphlet, and broadside printed in the United States from 1640 to 1800. This microform series has proven to be of great value to scholarship, but full access to it has been hampered by a lack of adequate cataloguing. AAS will continue to produce full MARC cataloging of the microform set, which will be entered into national databases and made available to individual libraries.

The Library of the American Museum of Natural History will continue to microfilm, restore, and conserve some 80 unique scientific and historic ledgers, scrapbooks, field diaries and notebooks, and specimen catalogs from scientific expeditions, fieldwork, and laboratory work, which form a unique record of the development of science and a major scientific institution in the United States. These records are used daily for the curation of collections and in scientific research; therefore, hard copies will be provided, while the unique manuscripts, some dating from 1815, will be preserved, catalogued into OCLC, and made accessible to the scholarly community.

The Boston Public Library will continue its program of preserving all Massachusetts newspapers on microfilm. Papers to be in most need of immediate preservation attention (revealed by a survey of over 2,000 repositories) will be filmed and a positive copy will be returned to the cooperating institution. The negative will be stored in the Library's ultrasecurity vault, a positive copy made available for public use by the Library, and the original papers wrapped in acid-free paper and placed in storage. Film will be checked to make sure it meets preservation microfilm standards. Regularly updated editions of *Newspapers on Microfilm in the Boston Public Library* will be produced and distributed.

Abstract

The John Hay Library at Brown University is one of the major libraries in the United States devoted exclusively to special collections. Foremost among its collections are the Harris Collection of American Poetry and Plays, the McLellan Lincoln Collection, and the Anne S. K. Brown Military Collection.

This project will begin the retrospective conversion of the monographic holdings of the John Hay Library using the services of an outside retrospective conversion vendor. Over 70,000 bibliographic records will be converted, of which 50,000 will be from the Harris Collection of American Poetry and Plays and 20,000 from the other collections in the John Hay Library. The conversion work will be done under contract by the OCLC RETROCON Service and the records created will also be tape-loaded into the Research Libraries Information Network (RLIN).

This project will complete the preservation microfilming of Ethnic Newspapers held by the Center for Research Libraries (CRL).

The Center for Research Libraries will microfilm all ethnic newspaper files in its collection that are not already preserved on film. It will include all titles held by CRL which cover the ethnic groups from Southern, Central, and Eastern Europe that emigrated to the United States in large numbers in the late 19th and early 20th centuries. Included will be titles in Arabic, Chinese, Danish, French, German, Japanese, Norwegian, Persian, Spanish, Swedish, and Yiddish. A total of 92 titles have been identified that are in need of preservation.

Abstract

This is the third and final year of this project, which will continue to improve accessibility and availability of the Dartmouth College Library collections in theatre and the performing arts, consisting of monographs, periodicals, newspapers, scripts, libretti, programs, playbills, scrapbooks, slides, sheet music, and other materials providing primary source materials for research in the performing arts. The collections contain some 48,000 individual items falling into four major categories: (1) plays, (2) playbills, (3) nonbook materials, and (4) sheet music.

Machine-readable records in the MARC format will be prepared and the records made available in the RLIN and OCLC shared cataloging databases and in the Dartmouth On-line Catalog. The shelf life of the materials in these collections will be extended throughout the application of various conservation and preservation operations.

Abstract

George Washington University's Gelman Library will provide bibliographic control and finding aids for research resources relevant to the history and culture of Washington, DC. The project is in response to a 1985 National Historical Publications and Records Commission-sponsored study revealing that access to the rich research resources in Washington, DC was hampered by severe deficiencies in bibliographic control, finding aids, and interinstitutional cooperation.

The project will determine, on a collection-specific level, the existence, condition, and current accessibility of resources in specified public and private institutions in the Washington metropolitan area. Gelman Library will build an interinstitutional subject database on bibliographic information to facilitate research. The project will also provide recommendations for ongoing interinstitutional coordination of bibliographic control and collection processing.

Abstract

The Harvard University Library will improve bibliographic control of its collection of master negative microfilms preparatory to publication of special lists for input into national databases. It will also film some 270,000 pages of valuable research materials that are too rare or fragile for lending. Specific collections to be filmed are in business (10K reports of the Securities and Exchange Commission), church history (American Unitarian Association letterbooks and records of the Society for Printing Theological Education), history of higher education (Harvard Commencement parts and exhibitions, 1649 to date), and a pilot project in European newspapers. This grant will disseminate information on what has been accomplished, and will further the development of a sound program for addressing the urgent problem of deteriorating research materials.

The Indiana University Libraries will increase nationwide bibliographic access and availability of Indiana University's extensive collection of operatic records by cataloging 50,000 sound recording titles of operas and opera excerpts new to the music library's collection, using the OCLC database. Bibliographic data for 30,000 monographs in the Melville J. Herskovits Library of Africana will be converted to machine-readable form. These 30,000 records represent the last remaining cataloged titles in the Herskovits Collection for which machine-readable data is not available. An additional 1,500 titles, for which only brief cataloging is currently available, will be upgraded to full cataloging standards. These titles will be selected according to their value to the research community and the degree to which full cataloging will enhance intellectual access to them. All 31,500 bibliographic records will be made available on tape to the major North American bibliographic network, thus affording scholars nationwide with readily available access to the resulting information. Abstract

This project will preserve and provide on-line bibliographic access to the unique collection of medieval and medieval tradition (13th through 20th century) Slavic Cyrillic manuscripts in microform in the Hilander Research Library of Ohio State University (OSU). OSU will continue to catalog the collection on the OCLC system, employing the standard MARC format, observing all conventions of AACR2. The Ohio University Alden Library will increase national accessibility of significant research resources on Southeast Asia by cataloging and inputting 4,000 titles into the OCLC international on-line union catalog. Included will be over 3,500 titles from the Library of Congress Jakarta Office Southeast Asia Microfiche, 1981-1985, as a Major Microform Project (MMP), and continuing a previous MMP project covering 1978-80. As an MMP, records will be available also to the other national centers holding the fiche. With one-half the monographs and one-quarter of the serials acquired from Indonesia available only in this fiche collection, full bibliographic access is essential for research on the world's fifth most populous nation. The library has focused primarily on materials covering Indonesia, Malaysia, Singapore, and Brunei, and to a lesser extent, Thailand and the Phillipines.

Morris Library will catalog seven First Amendment Freedom collections—including the Ralph E. Abstract

The Hoover Institution possesses a Poster Collection totalling approximately 68,000 items: illustrated wall placards, official proclamations, and propaganda of various other types. The newspaper collection also serves as a frequent primary source for scholarly investigation. The papers are of particular significance since they represent, in many instances, the only available record dealing with specific events during times of political unrest or development.

In order to preserve these holdings, the Hoover Institution will continue a brittle document preservation program that includes two basic components for dealing with the two separate groups of materials. Color slides (use copies plus preservation copies) are made of the posters, using Kodachrome film. Selected posters receive applied treatment, and all posters are encapsulated, catalogued, and indexed on-line. The newspapers are being microfilmed, with subsequent catalogue entries in RLIN.

Abstract

This project will preserve and broaden access to the Hoover Institution's collection of contemporary published sources on the Russian Revolution. The project entails microfilming and cataloging all primary source material published between 1905 and 1930 for the study of the Russian Revolution and Civil War.

The Hoover collection on the 1917 revolution, the Provisional Government, and the Civil War is probably the greatest such collection in the West. The collection also includes important material on the First Russian Revolution of 1905.

Abstract

The Library of the State Historical Society of Wisconsin is processing its "Cutter Pamphlet" collection into its current pamphlet collection, which is being fully catalogued and carefully conserved with material collected from 1967 to the present. The Cutter Pamphlets are a general collection of unbound ephemera, emphasizing United States and Canadian social and cultural history, collected by the Library from 1854 to 1966. Much of the collection is not fully catalogued and much shows signs of wear and deterioration.

This project is making the collection more accessible to researchers by preserving by appropriate methods materials in need of basic conservation measures, and by entering full MARC records into OCLC for all items not now in that database.

The Libraries of the State University of New York at Buffalo will create 5,500 machine-readable records for monographs in the microform sets that comprise the *Latin American Documents* collection.

Titles in this collection are primarily 19th and 20th century publications in all subject areas that are in the public domain. The collection also includes later editions of works originally published in the 16th, 17th, and 18th centuries which are recorded in Jose Toribio Medina's *Bibliotheca-Hispanoamericana, 1493-1810*.

Records created during the project will be entered into the Research Libraries Information Network (RLIN) and tape loaded into OCLC. The items in this collection will be available through interlibrary loan. The SUNY at Buffalo Libraries will provide access to items which are no longer available in paper editions or which exist in very fragile physical condition.

Abstract

This project will make known and usable to scholars everywhere two collections of Japanese books that are unique outside of Japan. One is formerly of the Mitsui Library, published between 1868 and 1949, and the second group is contemporary Japanese literature and criticism selected from the personal library of Endo Shusaku, one of Japan's most distinguished living writers. These two collections will be catalogued and the bibliographic records will be sent to RLIN, OCLC, or both. Conservation care will be given as needed to the Mitsui books and to a collection of 2,877 Japanese manuscript titles (over 7,000 volumes) dating from the 14th to the early 20th century so that their usable life can be extended for many more centuries.


