**ABSTRACT**

## About This Directory

The transition period for handicapped youth, as defined by the U.S. Department of Education, includes preparation in the secondary school, coordinated support efforts needed upon graduation, additional postsecondary education and/or adult services, and the initial years of employment. The transition from school to working life involves a range of choices about career options and an array of services and experiences that lead to employment. Effective transition addresses the quality and appropriateness of services designed for individual circumstances and needs.

As part of the transition initiative to assist handicapped youth to move effectively from school to adult working life, the HEATH Resource Center -- National Clearinghouse on Postsecondary Education for Handicapped Individuals, has been collecting and cataloguing information on current transition programs for secondary and postsecondary handicapped individuals. HEATH's Campus Resource File currently contains specific program and contact information on almost 200 transition programs throughout the United States.

In addition to available information on specific transition programs, HEATH has published this National Directory of Transition Specialists (1986). The Directory, organized by state, identifies the persons responsible for coordinating and/or overseeing transition initiatives in the state agencies of education\* and vocational rehabilitation\*. The survey indicates that transition 'activity' in a particular state is as varied as the array of titles and the actual number of person(s) designated as the transition specialist by a particular state agency.

This Directory is for parents, professionals and disabled persons interested and concerned about the critical transition period from high school to adult working life. The persons listed in the Directory can be contacted for information on current transition activities as well as future transition services being planned in a particular state.
