ABSTRACT

Documenting the 1995 spring session, this report provides resolutions considered by the Academic Senate for the California Community Colleges. The three sections of the report detail 72 resolutions that passed, 7 that were referred, and 9 that failed. The resolutions that passed are further divided into the following sections: (1) the Academic Senate and local senates, including roles and responsibilities and direct election of area representatives; (2) accreditation, related to training faculty to serve on accreditation teams and standards; (3) affirmative action/cultural diversity, including workshops and opposition to legislation to repeal affirmative action; (4) articulation and transfer; (5) budget and finance related to transfer services and growth funds; (6) counseling; (7) curriculum, including an integrated approach to multicultural education and academic freedom; (8) faculty development, including staff development and Assembly Bill 1725 workshops; (9) general concerns, such as facilities maintenance, civil action on discrimination, and an education effort between the Colleges and Thailand; (10) grading; (11) intersegmental issues of collaboration and cooperation; (12) matriculation; (13) professional standards; (14) students, including fees, grading, and appointment to the Board of Governors; and (15) vocational education. The second section provides the resolutions that were referred in the areas of the Academic Senate and its procedures; general concerns, such as equal education opportunities; and student funding. Finally, section 3 presents resolutions that failed in areas dealing with the Academic Senate, articulation and transfer, distance learning, faculty development, general concerns, and students. Lists of attendees, acronyms used, and policies on faculty nominees for the Board of Governors are appended. (KP)



- C. The Resolutions Committee meets to review all pre-session resolutions and combine, re-word, append, or render moot these resolutions as necessary.
- D. Members of the Senate meet during the session in topic breakouts and give thoughtful consideration to the need for new resolutions and/or amendments.
- E. After all Session presentations are finished each day, members meet during the resolution breakouts to discuss the need for new resolutions and/or amendments. These resolution writing sessions are organized by topic to facilitate discussion. Each resolution or amendment must be submitted to the Resolutions Chair before the posted deadlines each day. There are also Area meetings at the Session for discussing, writing, and amending resolutions.
- F. The Resolutions Committee meets again to review all resolutions and amendments and to combine, re-word, append, or render moot the resolutions as necessary.
- G. The resolutions are discussed and voted upon in the general sessions on the last day of the Plenary Session.

**1 ACADEMIC SENATE**

**1.1.0 Senate Delegate Roles and Responsibilities**  
**S95 Joan Stroh, Southwestern College**

Whereas it is important that delegates to sessions of the Academic Senate for California Community Colleges be informed of their roles and responsibilities, and

Whereas the importance of maintaining the integrity of a true representative process in forwarding business at sessions cannot be over emphasized,

Therefore be it resolved that the Academic Senate for California Community Colleges adopt the paper, "Senate Delegate Roles and Responsibilities" and refer it to the local senates for implementation.

**1.2.0 Materials Fees**  
**S95 Fran Lozano, Hartnell College**

Whereas the issue of materials fees remains a crucial one for California Community College students,

Therefore be it resolved that the Academic Senate for California Community Colleges urge the Executive Committee to implement Resolution 20.10 F94 calling for a survey of materials fees charged to community college students.

**1.3.0 Communication with Local Senates**  
**S95 Marie McCarthy, College of Marin**

Whereas the faculty of the California Community Colleges has, through the local academic senates, established the Academic Senate for California Community Colleges, Inc., in order to promote the best interests of higher education in the state and to represent the faculty in all California Community Colleges at the state level, and

Whereas Article VII, Section 3, of the Bylaws stipulates that "in order to provide adequate communication with the faculty . . . the Senate shall circulate among each and all faculty in the California Community Colleges such materials as agendas and minutes of its meetings, committee reports and other pertinent information on pending matters," and

Whereas local senates must remain informed on activities and issues addressed by the Executive Committee which acts "on behalf of the Academic Senate in the period between general sessions, transacts business, and performs other functions not inconsistent with the intent, purposes, and provisions of the Bylaws and Senate Rules" (Article V, Section 6),

Therefore be it resolved that the Academic Senate for California Community Colleges reaffirm the importance of monthly summaries of Executive Committee minutes, such summaries to be produced by the past president and posted on InfoNet within two weeks of the approval of those minutes, and

Be it further resolved that the Academic Senate for California Community Colleges reaffirm the importance of monthly presidential updates of senate issues and activities, such updates to be posted on InfoNet with hard copies mailed to local senate presidents, and

Be it finally resolved that the Academic Senate for California Community Colleges provide local senate presidents with monthly updates of activities and issues addressed by Academic Senate standing committees, such updates to be posted on InfoNet.

**1.4.0 FACCC/Senate Relationship**  
**S95 Steve Ruis, American River College**

Whereas FACCC's prime function is to represent the community college faculty in the legislative arena, and

Whereas the community college faculty need to make the best use of its resources,

Therefore be it further resolved that Academic Senate for California Community Colleges support membership and participation in FACCC by all community college faculty, and

Be it further resolved that the Academic Senate for California Community Colleges work collaboratively with FACCC when it becomes appropriate to draft legislation, and

Be it finally resolved that the Academic Senate for California Community Colleges reaffirm its relationship with the Faculty Association for California Community Colleges as stated in the paper "Academic Senate/FACCC Relationship" adopted by Resolution 1.2 at the Spring 1992 session.

**1.5.0 Direct Election of Area Representatives**

**S95** Bruce Hanson, Fullerton College

Whereas currently the entire Executive Committee is elected on an at-large basis, and

Whereas by having a mixture of "at-large" and "area" representatives, the Senate would more closely resemble local senates which are comprised of both divisional representatives and senators-at-large, and

Whereas electing Area Representatives by region would allow a greater responsiveness by these representatives to their own local area senates, by affording an opportunity for more members to participate on the Academic Senate Executive Committee, since it would allow those with only local reputations to win a place (and so a voice) on the State Executive Committee, and

Whereas locally elected Area Representatives would be carrying forward local concerns, the Senate Executive Committee as a whole would be better informed on local matters,

Therefore be it resolved that the State Academic Senate's Election Rules and Procedures be amended to allow Area Representatives to be elected directly by area members.

[NOTE: This resolution will begin the process for changing the Bylaws and rules.]

**1.6.0 Shared Governance**  
**S95 Dwight Lomayesva, Riverside College**

Whereas AB 1725 legislated the rightful role of faculty in academic and professional matters, and

Whereas the Association of California Community College Administrators (ACCCA) has recently surveyed its membership on their opinion of shared governance, and

Whereas ACCCA's legislative agenda appears to be directed at changing some aspects of AB 1725, including shared governance,

Therefore be it resolved that the Academic Senate for California Community Colleges recommend the Executive Committee research and assess the Association of California Community College Administrators' (ACCCA) position on shared governance and develop strategies to reaffirm and maintain the primacy of the role of faculty in academic and professional matters, and

Be it further resolved that the Executive Committee inform and update local senates on this matter.

**1.9.0 Board of Governors Faculty Nominating Procedures**  
**S95 Elmer Bugg, Santa Monica College**

Be it resolved that the Academic Senate for California Community Colleges adopt the proposed "Policy and Procedures on the Faculty Nominees for the Board of Governors."

**1.10.0 Part Time Faculty Inclusion on All Academic Senates**  
**S95 Margaret Desmond Hughes, Butte College**

Whereas the welfare of the California community college student is dependent on full-and part-time faculty, and

Whereas part-time faculty must have the same degrees and certificates for employment as full-time faculty, and

Whereas full-time faculty's perceptions are not necessarily those of part-time faculty,

Therefore be it resolved that the Academic Senate for California Community Colleges urge local senates to include part-time faculty as local academic senate members.

**1.11.0 Governance Breakout**  
**S95 Sondra Saterfield, Canada College**

Be it resolved that the Academic Senate for California Community Colleges conduct a breakout session at the Fall 1995 Session to assist local senates in writing or rewriting effective shared governance agreements.

**1.12.0 Hayward Award Process**  
**S95 Margie Ruzich, Palomar College**

Be it resolved that the Academic Senate for California Community Colleges encourage the Area Representatives to include a student representative on the final selection committee for the Hayward Award..

**1.13.0 Election of North and South Representatives**  
**S95 Bruce Hanson, Fullerton College**

Whereas currently the entire Executive Committee is elected on an at-large basis, and

Whereas electing regional representatives directly by members of that region would allow a greater responsiveness by those representatives to their local senates, and

Whereas regionally elected representatives would be carrying forward regional concerns to the Executive Committee better informing the Executive Committee on local matters,

Therefore be it resolved that the Academic Senate for California Community Colleges direct the Executive Committee to amend the Election Rules and Procedures to allow direct election of the North and South Representative by their respective regions.

[NOTE: This resolution will begin the process for changing the By Laws and rules.]

**1.16.0 Campus Visits by the Executive Committee**  
**S95 Lynda Corbin, San Diego Mesa College**

Whereas local senates are struggling with the implementation of the components of AB 1725, and

Whereas many local senates do not currently have a process in place for disseminating information about the mandates,

Therefore be it resolved that the Academic Senate for California Community Colleges direct the Executive Committee to make scheduled visits in addition to technical assistance visits to local senates to respond to the needs of the local senates regarding their responsibilities to implement the mandates of AB 1725, and

Be it further resolved that the Academic Senate for California Community Colleges direct the Executive Committee to compile a list of resource persons with knowledge of the specific mandates in AB 1725 to be distributed to local senates.

**2 ACCREDITATION**

**2.1.0 Training Faculty to Serve on Accreditation Teams**  
**S95 Mark Snowwhite, Crafton Hills College**

Whereas faculty participation on visiting teams is essential to the accrediting process, and

Whereas faculty members who serve on accreditation visiting teams for the first time do not feel sufficiently experienced to serve effectively,

Therefore be it resolved that the Academic Senate for California Community Colleges direct the Executive Committee to enter into dialogue with the Accrediting Commission for the purpose of developing a process by which the Academic Senate can help prepare faculty members to participate on accreditation visiting teams and develop a pool of promising faculty members for such training.

**2.2.0 Implementing Accreditation Resolution from Spring 1984**  
**S95 Tom Whitlock, Cerritos College**

Whereas in Spring 84 the Academic Senate passed a resolution requesting that all communications concerning each successive step in the accreditation process and follow-up that are sent by the Accrediting Commission to the Chief Executive Officer also be sent to the local academic senate president, and

Whereas this policy has not been fully implemented,

Therefore be it resolved that the Academic Senate for California Community Colleges reaffirm the resolution of Spring 1984 and direct its President to forward this resolution to the Accrediting Commission and also direct the Executive Committee to establish a wider policy for the involvement of local academic senates in choosing the institutional chair/co-chairs for the accreditation and self-study processes, and

Be it further resolved that the Academic Senate for California Community Colleges direct its President to forward this policy to the Accrediting Commission suggesting that local academic senates appoint faculty to accreditation self-study teams.

[NOTE: The following is the text of the Spring 1984 resolution: "Request that all communications concerning each successive step in the accreditation process and follow-up that are sent by the Accrediting Commission to the CEO also be sent to the local Academic Senate."]

**2.3.0 Training for Self Studies**  
**S95 Lynda R. Corbin, San Diego Mesa Community College**

Whereas the accreditation process is becoming integral to the ongoing operations of California Community Colleges, and

Whereas the Academic Senate is exploring ways to train faculty in their responsibilities on visiting teams, and

Whereas local faculty serving on standards committees during the self-study process at their colleges need direction and clarity in producing such an important document, and

Whereas local training procedures for faculty serving on standards committees may be inconsistent,

Therefore be it resolved that the Academic Senate for California Community Colleges explore the appropriateness and need for training and informational sessions for faculty serving on standards committees and for faculty writing local self-study reports and report back to a future session.

**2.4.0 Accreditation Standards**  
**S95 Sally Flotho, Golden West College**

Whereas new national standards for accreditation are being proposed, and

Whereas these are described as "threshold" standards to build on, and

Whereas historically "thresholds" or "minimum" standards tend to become ceilings, and

Whereas our current standards have helped ensure the high quality of community colleges in California,

Therefore be it resolved that the Academic Senate for California Community Colleges ask the Accrediting Commission to maintain the specificity in the current standards.

**3 AFFIRMATIVE ACTION/CULTURAL DIVERSITY**

**3.1.0 Reasonable Accommodations**  
**S95 Marie McCarthy, College of Marin**

Whereas the resolution "Be it resolved that the Academic Senate for California Community Colleges urge local senates to assist their faculty to become fully informed about the Americans with Disabilities Act (ADA) and about the implications of this Act as it affects community colleges" was passed at the Fall 1993 session, and

Whereas local academic senates have had minimal information provided to them by the Academic Senate to help them in this resolve, and

Whereas ADA issues regarding "reasonable accommodations" at the community college level are becoming an important and every day part of local faculty activities,

Therefore be it resolved that the Academic Senate for California Community Colleges direct the Executive Committee to provide appropriate and useful information addressing "reasonable accommodations" and other related Americans with Disabilities Act (ADA) subjects to local senates for dissemination to faculty, and

Be it further resolved that the Academic Senate for California Community Colleges urge local senates to work collaboratively with their campus Disabled Students Programs and Services faculty to provide an understanding of the ADA rules and regulations.

**3.2.0 Affirmative Action Workshops**  
**S95 Sally Flotho, Golden West College**

Whereas the Academic Senate for California Community Colleges has historically supported affirmative action in all avenues of human endeavor including hiring, education, and societal issues, and

Whereas affirmative action programs assist in giving women, minorities, and disabled persons an equal opportunity in hiring, education, and receipt of government contracts, and

Whereas affirmative action programs help to diversify the workforce, and

Whereas affirmative action programs were implemented to correct the results of past discrimination,

Therefore be it resolved that the Academic Senate for California Community Colleges reaffirm our support of affirmative action and direct the Executive Committee to present information and workshops to provide accurate information about affirmative action programs,

Be it further resolved that the Executive Committee include in such workshops the rationale and data used by those who oppose affirmative action.

**3.3.0 Support Affirmative Action**

Whereas affirmative action programs do not use quotas, lower standards, or support any type of discrimination, and

Whereas attempts are now being made to eliminate affirmative action programs, even though elements of discrimination continue to permeate the American society,

Therefore be it resolved that the Academic Senate for California Community Colleges support continued efforts to maintain affirmative action programs as long as discrimination exists.

Whereas AB 211, AB 727, AB 833, SB 940, SB 983, and ACA 2, would repeal affirmative action if the legislation were enacted,

Therefore be it resolved that the Academic Senate for California Community Colleges oppose proposals in the current language of AB 211, AB 727, AB 833, SB 940, SB 983, and ACA 2 as they exist on April 2, 1995, which eliminate affirmative action.

**4 ARTICULATION AND TRANSFER**

**4.1.0 Articulation and Common Course Numbering**

Whereas the Academic Senate for California Community Colleges recognizes problems community college students have moving from community college to community college (intra-system transfer) because of lack of articulation and common course numbering,

Therefore be it resolved that the Academic Senate for California Community Colleges support statewide efforts to promote articulation and use of common course numbering among community colleges.

**4.3.0 Transfer Center Advisory Committee**

Whereas collaboration and communication are essential among faculty working in areas like transfer, included as one of the eleven areas specified as appropriate for senate involvement under "student preparation and success," and

Whereas the Title 5 required Transfer Center Advisory Committee is not necessarily a senate committee,

Therefore be it resolved that the Academic Senate for California Community Colleges urge local senates to take an active role in the Title 5 required Transfer Center Advisory Committee at their colleges; and

Be it further resolved that the Academic Senate for California Community Colleges direct the Executive Committee to develop guidelines for use by local senates in creating senate transfer committees.

**4.4.0 Assessment of Transfer Support Activities**  
**S95 Fran Lozano, Hartnell College**

Whereas Title 5 includes "student preparation and success" as one of the eleven areas in which local senates are to be primarily relied upon, and

Whereas student equity requires the assessment of the success of programs in terms of student outcomes, one of which is transfer rate,

Therefore be it resolved that the Academic Senate for California Community Colleges urge local senates to monitor assessment of transfer support activities at their colleges, so that 1) they can assure that components of effective assessment of transfer programs are being implemented, 2) all constituents, including students, are being involved in assessment, and 3) the results of assessment of transfer programs are widely distributed to faculty.

Whereas the Academic Senate and the Chancellor's Office have supported the concept of articulation with historically black colleges and universities,

Therefore be it resolved that the Academic Senate for California Community Colleges affirm its support for the continued investigation of articulation with historically black colleges and universities.

**4.7.0 Concurrent Enrollment with University of California**

**S95 Norm Simpson, San Bernadino Valley College**

Whereas faculty representatives of the University of California at Riverside and several local community colleges identified incomplete sequences of courses as a major deterrant to success of transfer students, the main problems being topic sequencing and the poor meshing of semester versus quarter class scheduling, and

Whereas the only avenue currently open to community college students is taking classes through extension at the University of California campus while completing these sequences, and

Whereas students enrolled through extension pay higher fees, compete with University of California students in regular classes, and receive no grade or unit credit,

Therefore be it resolved that the Academic Senate for California Community Colleges urge the Academic Senate of the University of California to adopt a policy allowing community college students to concurrently enroll at the University of California campus while completing a course sequence at the community college.

**4.8.0 Project ASSIST**  
**S95 Bill Scroggins, Chabot College**

Whereas the Academic Senate for California Community Colleges has long supported quality articulation and transfer, and

Whereas Project ASSIST, which has as its goal the development of an articulation database, has so far been able to include less than 30 community colleges in that database and has been criticized for administrative and technical inefficiencies, and

Whereas the Chancellor of the California Community Colleges has withheld over \$300,000 of the legislatively mandated \$589,000 for Project ASSIST (in the 1994-95 fiscal year) which may cause the collapse of the ASSIST program, and

Whereas the Chancellor has not involved the Academic Senate in the discussion of this clearly academic and curricular matter,

Therefore be it resolved that the Academic Senate for California Community Colleges reaffirm its commitment to quality articulation and transfer and reaffirm the development of an articulation database capable of course equivalency checks and student progress checks, and

Be it further resolved that the Academic Senate for California Community Colleges request that the Chancellor conduct an evaluation of ASSIST incorporating representatives of the appropriate consultation groups including the Academic Senate for California Community Colleges, and

Be it further resolved that the Academic Senate for California Community Colleges request of the Chancellor that funding for ASSIST be continued at its legislatively mandated level until such evaluation has been conducted, and

Be it finally resolved that the Academic Senate for California Community Colleges request that the Board of Governors take no action on the status of ASSIST until a recommendation has been developed through the consultation process.

**4.9.0 Two to Four Year Transfer Curriculum**

Whereas the Academic Senate supports students in their quest to facilitate transfer, and

Whereas courses exist in the context of a major program education model (GE package) and serve as an historical record of development of an educational program and philosophical model, and

Whereas a college's integrity is contingent upon its ability to control its curriculum,

Therefore be it resolved that the Academic Senate for California Community Colleges affirm its commitment to the essential elements of academic integrity, academic freedom, articulation, and resources while pursuing common course numbering.

#### 4.12.0 Cross-enrollment

S95 Bill Scroggins, Chabot College

Whereas SB 1914 (Killea, 1994) enables cross-enrollment of students among the three higher education segments, University of California, California State University, and California Community Colleges, and

Whereas SB 1914 requires that this system of cross-enrollment be on a space-available basis for a maximum of one class each term at a maximum cost of \$10 to students with no FTES generated for the class either for the home or host institution, and

Whereas such a cross-enrollment system, if equitably structured, could greatly enhance student opportunities for learning,

Therefore be it resolved that the Academic Senate for California Community Colleges support the concepts of cross-enrollment as presented in SB 1914 (Killea, 1994), and

Be it further resolved that the Academic Senate for California Community Colleges encourage local senates to make every attempt to establish cross-enrollment programs with neighboring UC and CSU campuses under the SB 1914 program and include the following specific implementation provisions:

- 1) Existing and future cross-enrollment and concurrent enrollment agreements which specifically target certain students or certain programs or courses are exempt from student participation under the 1914 agreement,
- 2) Space available basis for enrollment is defined as available for student enrollment under SB 1914 agreement only at the end of the add period and only if the total enrollment is less than the stated class size for the course, and
- 3) Only baccalaureate courses (upper and lower division not those which are remedial or developmental) are available for student enrollment under the SB 1914 agreement, and
- 4) The annual college report of participation in the program shall not require special MIS data elements or tracking and the report shall only contain simple demographic data including: name, host and home institution, term and year, course name and number, units attempted and completed, and grade, and
- 5) Eligibility status for admission to the host institution is not a factor in determining the student's participation in the SB 1914 program and established procedures, consistent with those applied to regular students, are applied to determine if students have met course prerequisites, and
- 6) Participation in the SB 1914 cross-enrollment program is limited to California residents, and

Be it finally resolved that the Academic Senate for California Community Colleges publicize and promote participation of community colleges in the SB 1914 program through its regular publications and announcements and in its regular communications with other community college organizations.

Therefore be it resolved that the Academic Senate for California Community Colleges encourage local senates to convene a committee of transfer function services to enable the senates to more effectively support transfer function services.

**5.1.0 Transfer Services**

Therefore be it resolved that the Academic Senate for California Community Colleges urge local boards of trustees to provide sufficient faculty and support staff to assure successful transfer services.

**5.3.0 AB1593 - Community College Investment Fund for Innovation**

Whereas AB 1593 would create in the State Treasury the Community Colleges Investment Fund for Innovation for the primary purpose of stimulating instructional innovations and paying for the professional development of faculty in learning new instructional approaches for a diverse student population, and

Whereas such a fund is good in principle, AB 1593 is silent on the amount of the fund and on whether the source of the fund would affect general fund appropriations,

Therefore be it resolved that the Academic Senate for California Community Colleges take the position that AB 1593 be amended to indicate the Community Colleges Investment Fund for Innovation be funded separately from the general fund appropriations.

Therefore be it resolved that the Academic Senate for California Community Colleges oppose any legislation or regulation which would fund enrollment growth in one district by reducing the amount of funding which would otherwise be allocated to another district.

Be it further resolved that the Academic Senate for California Community Colleges urge the Board of Governors to seek legislation or regulation to allow growth funding only to the extent that it would not reduce that which would otherwise be allocated to another district.

Therefore be it resolved that the Academic Senate for California Community Colleges direct the Executive Committee to establish a standing committee for counseling and library faculty issues.

Be it further resolved that the Academic Senate for California Community Colleges omit the word "severe" as part of the definition of developmental disabilities on page 23 of the paper entitled and "An Integrated Approach to Multicultural Education", and

Be it finally resolved that the Academic Senate for California Community Colleges include in the paper "An Integrated Approach to Multicultural Education" the definition for Learning Disabilities in the list of definitions under "Persons with Disabilities", such definition to be supplied by California Association for Postsecondary Education of the Disabled (CAPED).

Whereas the individual teaching faculty is ultimately responsible for the motivation, instruction, and evaluation of each student in his or her care,

Therefore be it resolved that the Academic Senate for California Community Colleges uphold the primacy of the instructor to design and deliver instruction based on the course outline of record for which that instructor is responsible, and

Be it further resolved that the Academic Senate for California Community Colleges oppose any and all attempts by the administration to direct or command an instructor to teach in a particular way which violates academic freedom.

- (a) Improvement of teaching.
- (b) Maintenance of current academic and technical knowledge and skills.
- (c) In-service training for vocational education and employment preparation programs.
- (d) Retraining to meet changing institutional needs.
- (e) Intersegmental exchange programs
- (f) Development of innovations in instructional and administrative techniques and program effectiveness.
- (g) Computer and technological proficiency programs.
- (h) Courses and training implementing affirmative action and upward mobility programs.
- (i) Other activities determined to be related to educational and professional development pursuant to

criteria established by the Board of Governors of the California Community Colleges including, but not necessarily limited to, programs designed to develop self-esteem", and

Whereas most college staff development programs have generally accepted the wording of item (i) as having been interpreted as including "programs designed to develop self-esteem", and

Whereas the words "including but not necessarily limited to programs designed to develop self esteem" have been used as rationale to provide staff development programs in the areas of self esteem, and

Whereas the organization 4C/SD (California Community College Council for Staff Development) feels that self-esteem programs including wellness are significant, appropriate, and valuable parts of full and rich staff development and Flex Calendar programs,

Therefore be it resolved that the Academic Senate for California Community Colleges recommend that the Board of Governors approve self-esteem and wellness programs as authorized uses of staff development funds.

Therefore be it resolved that the Academic Senate for California Community Colleges support the concepts in AB 821 as they exist on April 2, 1995.

Whereas AB 978 repeals the Education Code effective January 1, 1997,

Therefore be it resolved that the Academic Senate for California Community Colleges oppose the concepts in AB 978 as they exist on April 2, 1995, and recommend to the legislature that Education Code sections in need of revision or repeal be considered on a case-by-case basis.

Therefore be it resolved that the Academic Senate for California Community Colleges take the position that AB 444 be amended to require charter colleges to follow legislation and regulations which govern the California Community Colleges.

Be it finally resolved that the Academic Senate for California Community Colleges direct the Executive Committee to explore the development of a process to facilitate faculty exchanges and internships in the California Community Colleges-Thailand Education effort.

Whereas the intent language of AB 1725 Section 4 (b), states, "If the community colleges are to respond creatively to the challenges of the coming decades, they must have a strong and stable core of full-time faculty with long-term commitments to their colleges," and

Whereas the establishment of minimum qualifications for hire has removed any distinction between the quality of classroom instruction based on full versus part-time hiring status, and

Whereas the use of full-time faculty teaching overloads reduces the availability of full-time faculty for academic and professional shared governance duties outside the classroom with no basis for expecting improved instruction in the classroom,

Therefore be it resolved that the Academic Senate for California Community Colleges urge the Board of Governors and other bodies to seek legislation and/or establish regulation that will change the formula for calculating the recommended minimum 75/25 ratio of full-time to part-time faculty such that full-time faculty overloads will be counted as WSCH taught by part-time faculty, and report their findings at a future session.

## **Policy and Procedures on the Faculty Nominees for the Board of Governors**

### **Board of Governors' Nomination Timeline and Procedures:**

1. In September, Standards & Practices, a committee of the Academic Senate, will develop the timeline for Board of Governor nominations. The chair of the committee will draft announcement for Executive Committee approval no later than the September Executive Committee meeting
2. No later than September 15th, a call for nominations will be sent to each campus through the senate president. At the same time, all previous nominees will receive an announcement inviting them to activate their file.
3. The first Rostrum of the academic year should include candidate qualifications requirements and the nomination process.
4. Nominations will close by Oct. 31.
5. Applications will be initially screened by the Standards & Practices committee using a set of established criteria and when possible, the Standards & Practices committee will forward a minimum of five recommended applicants names of recommended applications will be forwarded to the of the Academic Senate President by the middle of November for scheduling of interviews.
6. The President of the Academic Senate will convene an interview committee consisting of five Executive Committee members, of which one shall be the Chair of the Academic Senate's Standards & Practices committee, by the middle of November for the purpose of screening applicants and selecting three candidates to be forwarded to the Governor's Office. Interviews of the candidates recommended by Standards & Practices committee shall take place at the December meeting of the Executive Committee. Three candidates will be selected for recommendation to the Governor's Office as candidates to fill the Board of Governors appointment.
7. The President will transmit the interview committee's recommendation to the Governor's office by mid-December and all candidates will be notified of the outcome of the nomination process.
8. Standards & Practices will review the process yearly and recommend any changes by March of the academic year.

## **Nomination Process:**

Appendix C

1. Nominations may be made by:
  - a) any college or district senate
  - b) Executive committee of the Academic Senate for California Community Colleges.
2. Any faculty member previously nominated who wishes to be reconsidered must submit a letter of intent and may update his/her application packet if necessary.
3. All nominations must be endorsed by a local/district senate or the Executive Committee. A letter of support from the candidate's local senate is desirable.
4. An applicant must submit:
  - a) Resume
  - b) Statement of why he/she would be an effective member of the Board of Governors. This would include, but not be limited to:
    - 1) commitment to students and mission of community colleges, and
    - 2) reference to qualifications for the position.
  - c) Letter of endorsement from the applicant's local senate is desirable.

## **Qualifications:**

1. Candidates must be full-time, tenured faculty members.
2. Candidates must have campus-wide leadership experience at the local level, serving in the local academic senate as an officer, Executive committee member, committee chair or in some other capacity that demonstrates knowledge of local senate and college operations.
3. Candidates must have statewide organizational experience, preferably with the Academic Senate, serving as an officer, Executive Committee member, committee chair or on some other capacity that demonstrates knowledge of statewide educational issues and California community college system operations. Candidates may list involvement in discipline-related statewide organizations and special activities that qualify them for the position.
4. Candidates must demonstrate the ability to present a reasoned argument in educational policy and demonstrate a knowledge of statewide educational issues.
5. In order to independently represent all the faculty of California community colleges, a faculty member appointed to the Board of Governors must agree upon appointment to resign from the executive board of any statewide community college organization excluding discipline related professional organizations. The Academic Senate will only forward the name of those candidates who agree to the above requirement.
