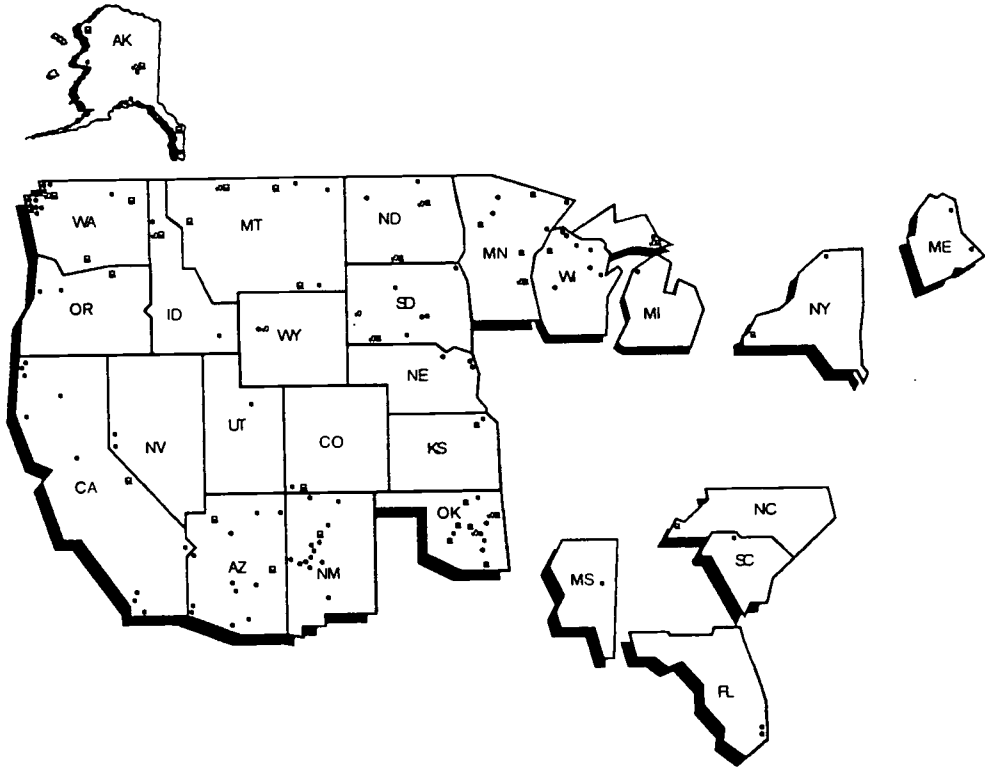
ABSTRACT
