

## ABSTRACT

This report provides a description of open-enrollment programs, including tables showing the number of applications and transfers by grade, by race, and by special education status. In addition, the report provides summary information, such as the number of school districts in which more than 3 percent of the students transferred out, the number in which more students transferred into the district than out of the district, and vice versa. The report also provides information about appeals of school district denials of open-enrollment applications, including reasons for denial, outcomes of the appeals, and the most common reasons that school-board decisions were overturned. The report includes information about the number of low-income parents who received transportation reimbursement, including the total amount of transportation reimbursement paid, the average reimbursement per student, and the average number of miles students were transported. ## INTRODUCTION

This report is prepared pursuant to sec. 118.51 (15) (c), Wis. Stats., which requires the Department of Public Instruction to:

Annually submit a report to the governor, and to the appropriate standing committees of the legislature under s. 13.172 (3), on the number of pupils who applied to attend public school in a nonresident school district under this section [the full-time inter-district public school open enrollment program], the number of applications denied and the bases for the denials, and the number of pupils attending public school in a nonresident school district under this section.

The report provides more than the minimum statutorily-required information required by the statute, including: a description of the program, tables showing the number of applications and transfers by grade, by CESA, by race, and by special education status. In addition, the report provides summary information such as the number of school districts in which more than 3% of the students transferred out, the number in which more students transferred into the district than out of the district (and vice versa), etc.

The report provides information about appeals of school district denials of open enrollment applications, including: reasons for denial, outcomes of the appeals, and the most common reasons that school board decisions were overturned.

The report also provides information about the number of low-income parents who received transportation reimbursement, including the total amount of transportation reimbursement paid, the average reimbursement per student and the average number of miles students were transported.

Seven appendices provide much of the above data on an individual school district basis.

## I. DESCRIPTION OF THE FULL-TIME OPEN ENROLLMENT PROGRAM

1997 Wisconsin Act 27 created the first statewide inter-district open enrollment program in Wisconsin.<sup>1</sup> The program consists of two parts: full-time inter-district open enrollment and part-time inter-district open enrollment. This report addresses only the full-time program.

### A. Applications, Approval and Denial, Reapplication

Beginning in the 1998-99 school year, students in grades kindergarten (including 4-year-old kindergarten) to 12 may apply to attend any public school district in the state. Parents may apply for children to attend prekindergarten, early childhood education and school-operated day care only if the child's resident school district offers the same type of program and if the child is eligible for the program.

The statute sets out a specific schedule for application, notification of acceptance and denial, appeal, and notification of intent to attend.<sup>2</sup>

School districts may deny students' applications only for specific criteria set forth in the statute:

- A nonresident school district (the district the student wishes to attend) may deny a student's application only for the following reasons (and only if specified in school district policy):
  - If space is not available in the school, program, class or grade the student would attend. If there are more applications than there are spaces available, the nonresident school district must accept or reject applications on a random basis, except the school board must give preference to students who are already attending school in the nonresident school district and to their siblings.
  - If the student has been expelled during the current or two preceding school years (or whether disciplinary proceedings are pending) for certain violent offenses.<sup>3</sup> In addition, a school district may deny a student's enrollment if the student is currently serving an expulsion that extends into the school year for which the student has applied for open enrollment.<sup>4</sup>
  - If the student has been referred for a special education evaluation, but has not yet been evaluated.
  - If the special education and related services required by a student's individualized education program are not available in the school district or if there is no space in the special education program or related services required by the student's individualized education program.
  - For school districts that participate in the chapter 220 integration transfer program, if accepting the student would increase racial imbalance in the school district.
- A resident school district (the school district in which the student resides) may deny a student's application only for the following reasons (and only if specified in school district policy):

- The school board may limit the number of students transferring out of the school district under open enrollment to a specified percent of its enrollment. In the 1998-99 school year, the statute permitted a resident school board to limit transfers out to 3% of its enrollment. This percent increases one percent each year until it reaches 10% in the 2005-06 school year, after which there is no limit on the percent of students who may transfer out.
- If the costs of the special education and related services required by the student's individualized education program would impose an undue financial burden on the resident school district.
- For school districts that participate in the chapter 220 integration transfer program, if accepting the student would increase racial imbalance in the school district.

Once a student is accepted into a nonresident school district under open enrollment, the student may be required by the nonresident school board policy to reapply one time—and one time only—prior to the beginning of middle school, junior high school or high school.

Open enrolled children with disabilities may be required to return to the resident school district:

- If the student's newly-created or revised individualized education program requires special education or related services that are not available in the nonresident school district;
- If there is no space in the special education and/or related services required by the newly-created or revised individualized education program; or
- If the cost of providing the special education and/or related services required by the newly-created or revised individualized education program imposes an undue financial burden on the resident school district.

## **B. Appeals**

If an application was denied by either the nonresident or resident school district, the parent or student may appeal the denial to the Department of Public Instruction within 30 days of receiving the notice of denial. The Department is required to uphold the school board's decision unless the Department finds that the decision was arbitrary or unreasonable.

## **C. Funding**

Funding for regular education open enrollment is accomplished by transferring state aid from the resident to the nonresident school district. The amount of state aid transferred for each regular education open enrollment student is equal to the statewide average per pupil cost for regular instruction, co-curricular activities, instruction support services and pupil support services in the previous school year. For the 1998-99 school year, this open enrollment student transfer amount was \$4,543.

The money transferred under open enrollment is not considered in determining a school district's revenue limit. That is, a resident school district may not raise its tax levy to replace the loss of state aid for students enrolling in other school districts. Conversely, a nonresident school district receiving a student is not required to reduce its revenue limit by the amount of the state aid increase.

Funding for special education open enrollment is accomplished by a direct payment from the resident school district to the nonresident school district. The payment may either be calculated according to the statutory tuition calculation<sup>5</sup> or may be an amount agreed to by the school boards of the nonresident and resident school districts.

## D. Transportation

Transportation from one school district to another under open enrollment is the responsibility of the parents. The exception to this provision requires the nonresident school district to provide transportation if the individualized education program for a student with a disability requires that transportation be provided. (In this case, transportation is a related service, the cost of which may be billed to the resident school district as part of the tuition calculation.)

Parents of low-income students (that is, students who are eligible for free or reduced-price meals under the federal school lunch program) may apply to the Department of Public Instruction for reimbursement of the cost of transporting the child to and from school under open enrollment. The maximum amount of reimbursement per child is three times the state average transportation cost per student. The maximum amount per student was \$986.22 in the 1998-99 school year.

Either the nonresident or the resident school district *may* choose to provide some transportation to open enrollment students. However, the nonresident school district is prohibited from picking up or dropping off a student within the boundaries of the student's resident school district. Only the nonresident school district may receive state categorical transportation aid [sec. 121.58 (2), Wis. Stats.] for transporting open enrollment students.

## II. SUMMARY DATA ON APPLICATIONS; APPROVALS AND DENIALS; AND TRANSFERS

The following tables provide data on open enrollment applications and school district actions on the applications. Some notes on the data:

- Unless otherwise noted, the total number of applications to transfer into a district includes duplicates, while the total number of applications out does not include duplicates. Some students applied to attend multiple school districts. For example, if a student lives in Milwaukee and applies to attend Menomonee Falls and Wauwatosa, there would be two applications to transfer in—once to Menomonee Falls and once to Wauwatosa. However, the student would only be counted once as an applicant to transfer out of Milwaukee.
- The number of transfers includes only those students who actually transferred from one school district to another. Since a student can attend only one school district at a time, the number of actual transfers does not include duplicates.
- District and statewide “enrollment” means the enrollment of resident students on the third Friday in September, 1997. This is because the percent limitation that resident school districts may impose on transfers out is based on that enrollment. As a result, applications and transfers are compared to enrollment for the September prior to the school year in which the student transfers under open enrollment.
- The data are shown with little or no written analysis. Given that this was the first year of the open enrollment program, the Department believes that in most cases it is too early to draw conclusions from the data.

Data by individual school district are contained in the appendices.

## By Race

Data on transfers by race should be interpreted cautiously, for several reasons. First, not all parents indicated the child's race on the application form. Second, some parents indicated more than one race, so some students may be double-counted. Finally, the chapter 220 integration transfer program in the Milwaukee area permits minority students to transfer out of Milwaukee to suburban districts and white students to transfer into Milwaukee from suburban districts. Thus, a number of inter-district transfers take place outside of the open enrollment program and are not included in the statistics for open enrollment. Since more minority students than nonminority students transfer under the chapter 220 program, the apparent disparity in participation of minority students in inter-district transfer programs may appear greater than if chapter 220 transfers were included.

### C. Special Education Applications and Transfers

Students with disabilities may apply for open enrollment and may not be denied because of their disability. They may be denied for the reasons indicated previously in this report. A student is counted as a "special education" student for open enrollment purposes if the student is receiving special education or related services in accordance with an individualized education program or if the student has been referred for an evaluation to determine whether the student has a disability that requires special education or related services.

### III. APPEALS

#### A. The Appeals Process

If a student’s application is denied by either the nonresident or resident school district, the student may appeal the denial to the Department of Public Instruction within 30 days of receiving the notice of denial. The Department is required to uphold the school board’s decision unless the Department finds that the school board’s decision was arbitrary or unreasonable.

Upon receipt of an appeal, the Department sends a letter to the school district that denied the application requesting the record of the decision. The record of the decision consists of the school board’s policy for approval or denial of full-time open enrollment applications; any administrative procedures used to determine approval or denial; any school board minutes, tapes or transcripts; any committee minutes, tapes or transcripts; and any other information pertaining to the denial of the appellant’s application. Both the appellant (parent and/or student) and the respondent (school district) are given the opportunity to submit arguments (briefs).

The Department’s role in deciding appeals under the open enrollment program is to ensure that the required statutory procedures were followed, that the school board’s policy is in accordance with the statutes, that the school board’s decision was based upon one or more of the statutorily-defined grounds and the school board’s policy to the extent that the policy is in accordance with the statutes, and that the school board’s decision was neither arbitrary nor unreasonable.

## B. Appeals Data

Two hundred and forty-six (246) appeals of school board denials were filed with the department for 1998-99 open enrollment applications. Data on the types of appeals and their dispositions follows:

The two most common reasons for overturning school board decisions were:

- The Milwaukee School Board's denials based on "increasing racial imbalance in the district" that instead had the effect of requiring open enrollment to "enhance racial balance," and
- Inadequate records submitted to support school board decisions.

### *Milwaukee Public School District Racial Imbalance*

School districts that participate in the state's desegregation program (referred to as Chapter 220) are required to deny any application into or out of the school district that would increase racial imbalance in the school district. The Milwaukee Public School District (MPS) denied all applications for minority students to transfer into the district and all applications for nonminority students to transfer out of the district. The department found that:

... MPS's attempt to limit open enrollment transfers solely on the basis of the 30% criterion [that determines whether a district is eligible to participate in chapter 220] changes the standard set in the statute, from one that prohibits open enrollment from *increasing racial imbalance* to one that requires it to enhance racial balance. ... Under s. 118.51 (7) (a), Stats., there is no requirement to determine whether any open enrollment transfer contributes to the racial balance of a district nor any authority to make a decision on an application on that basis. The fact that all minority students were approved to leave (which would have the effect of decreasing racial imbalance) while all nonminority students were

denied to leave, underscores that the effect of Milwaukee's administrative guidelines is to require open enrollment to enhance racial imbalance. This is not authorized by statute. The use of the chapter 220 criterion does not distinguish between maintaining racial balance, decreasing racial balance or increasing racial balance....

(from a number of decisions in appeals of MPS denials on the basis of racial imbalance)

The Milwaukee School Board appealed the Department's decision to Milwaukee County Circuit Court. A settlement between the school district and the Department agreed that the school board would amend its policies to consider whether any transfers could be allowed without increasing racial imbalance in the district. The terms of the settlement allowed all students who had already transferred as a result of the Department's decision to remain in the nonresident school districts under open enrollment.<sup>6</sup>

### *"Complete Void of Information for the Department to Review"*

Since this was the first year of open enrollment, neither school districts nor the Department had any experience with the application process or the appeal process. A number of school districts submitted an inadequate record to support their decisions. Often the only record offered by the school district was a copy of the board's policy stating that the district would "consider space" (or other permitted criteria) in acting on the application. Such a record would provide no information about how or even whether the school board made an actual determination about whether it had space. In such cases the department found:

... A school district's decision to deny an open enrollment transfer may not be arbitrary or unreasonable. See sec. 118.51 (9), Stats. "Arbitrary or capricious action on the part of an administrative agency occurs when it can be said that such action is unreasonable or does not have a rational basis. Arbitrary action is the result of an unconsidered, willful and irrational choice of conduct and not the result of the 'winnowing and sifting' process. State ex rel. Smits v. City of DePere, 104 Wis. 2d 26, 37-38 (1981), quoting Olson v. Rothwell, 28 W. 2d 233, 239 (1965). The test for whether an agency's determination is arbitrary is whether it can be said that such action does not have a rational basis. See Incorporation of Town of Pewaukee, 186 Wis. 2d 515 (Ct. App. 1994)

There is a complete void of information for the Department to review. The district provided no information regarding the enrollments at the district, grades or schools involved. In light of this void, there is no way to conclude that the decision was not an unconsidered, willful and irrational choice of conduct or that it is the result of the 'winnowing and sifting' process. Without evidence of rational analysis and a sifting and winnowing of that information, the decision by the school district is arbitrary.

(from a number of decisions in open enrollment appeals)

### **C. Improvements in the Appeal Process**

The Department recognized that when a school board's decision was overturned based on an inadequate record, the decision might have been upheld if the district had submitted an adequate record. For this reason, the Department held workshops in January, 1999, and provided information to school districts about how to compile

<sup>6</sup> For 1999-2000 school year applications, the school district applied its new policies that permitted one nonminority student to leave the district for every four minority students who applied to leave. However, following school board elections in March, the Milwaukee School Board adopted yet a new policy that defined racial balance more broadly and allowed many more nonminority students to leave. The school board reversed the previous denials and all nonminority students who applied to transfer out of the Milwaukee School District in the 1999-2000 school year were approved to do so.

and submit a record in an open enrollment appeal. In addition, the Department's request for the record in appeals of denials of 1999-2000 open enrollment applications was more specific to the type of appeal and provided more explanation about the exact information that was required. As a result, the records submitted to the Department for appeals of 1999-2000 open enrollment denials were more complete and in most cases provided satisfactory evidence in explanation of school boards' decisions. Specific information about appeals of 1999-2000 open enrollment denials will be provided in the legislative report for that school year.

#### IV. FUNDING

Funding for regular education open enrollment is accomplished by transferring state aid from the resident to the nonresident school district. The amount of state aid transferred for each regular education open enrollment student is equal to the statewide average per pupil cost for regular instruction, co-curricular activities, instruction support services and pupil support services in the previous school year. For the 1998-99 school year, this open enrollment student transfer amount was \$4,543.

A total of \$9,579,946 was transferred from resident to nonresident school districts on behalf of regular education students (see Appendix B for district list of amounts transferred). Data are not available on the amount of tuition that was paid by resident school districts to nonresident school districts for the open enrollment of 171 students who received special education.

#### V. REIMBURSEMENT FOR TRANSPORTATION COSTS OF LOW-INCOME PARENTS

Low-income parents (that is, parents of students who are eligible for free or reduced-price meals under the federal school lunch program) may apply to the Department of Public Instruction for reimbursement of the cost of transporting the child to school under open enrollment. The statute provides that the maximum amount of reimbursement per child is three times the state average transportation cost per student. This was equal to \$986.22 per student in the 1998-99 school year.

Parents who requested transportation reimbursement were required to submit a claim to the department that provided information about family size and income (to determine eligibility) and information about the cost of the transportation. Reimbursement was equal to 19 cents a mile (when transportation was provided by a family vehicle) or the actual cost of the transportation (when transportation was provided by other means, such as public transportation or contract with the school district).

## VI. SURVEYS

During the 1998-99 school year, the Department surveyed school district superintendents and a random sample of parents who had applied for open enrollment (separate and different surveys were sent to superintendents and to parents). The purpose of the surveys was to seek input regarding the implementation of the program in order to determine whether changes should be made related to the administration of the program.

Ninety-nine parents (of 295 who were sent the survey) responded to the questionnaire. Eighty-four percent of the questionnaires returned were from parents whose applications had been approved by the nonresident school district. The parents who responded to the survey showed overall satisfaction with the application process and with the program as a whole.

One hundred thirty seven school district superintendents also responded to the survey. Although generally satisfied with the administration of the program, the superintendents also made a number of suggestions and comments for improved administration of the program. The amount of administrative work associated with the program is a concern and one the Department continues to address.

The above surveys provided valuable information to the department and resulted in both some administrative changes and in the introduction of legislation to make some amendments to the program. The Department is also reviewing its administrative rules and expects to propose changes to improve program administration and to provide clarification of questions that have arisen during the first two years of the program's existence.

The Department is aware of two other surveys that have been conducted regarding open enrollment. The Public Policy Forum, a Milwaukee research organization, conducted a survey of school district administrators in December, 1998, and a survey of parents in December, 1999. The surveys ask a number of questions pertaining to the administration of the program. In addition, the surveys ask questions relating to parents' reasons for wishing to participate in open enrollment.
