ABSTRACT

This paper provides data on the Comprehensive School Reform Demonstration (CSRD) program in the mid-continent region. Started in 1998 and part of the Mid-Continent Research for Education and Learning and Model Developers Plan, the CSRD program aims to increase student achievement by assisting schools across the country to implement successful, comprehensive school reforms. Seventeen comprehensive school reform models were identified as examples of strategies a school might adopt. To date, all states in the Mid-Continental Regional Educational Laboratory's central region (Colorado, Kansas, Missouri, Nebraska, North Dakota, South Dakota, and Wyoming) have completed initial rounds of CSRD funding, with South Dakota and Missouri completing second and third rounds. Thirty-two school-reform models are being implemented in 92 sites. Some of the challenges identified by model developers are the isolation felt by schools in a district where no other schools are engaged in reform efforts and the lack of support among some teachers who do not recognize the stages of implementation of a new initiative, especially the inevitable implementation dip. Four tables present data on the number of different program models being implemented in each state, the distribution of models across states, model developers in the McREL region not under CSRD, and numbers of alternative models. Comprehensive School Reform Demonstration Program Mid-continental Regional Educational Laboratory CSR D MODEL DEVELOPERS ACTIVITY AND PLAN

The Mid-continent Research for Education and Learning and Model Developers Plan is a living document. It is periodically updated to reflect new CSR D LEA funding and activity. Its primary purpose is to enable McREL staff to:

- track the funding and progress of CSR D LEA funded sites;
- identify and determine the distribution of models in use in the region; and
- develop collaborative strategies and establish communication links with the region's model developers.

McREL Regional Comprehensive School Reform Demonstration Program

The Comprehensive School Reform Demonstration (CSR D) program, begun in 1998, aims to increase student achievement by assisting schools across the country to implement successful, comprehensive school reforms. Seventeen specific Comprehensive School Reform models were identified in the legislation as examples of strategies a school might adopt. This did not preclude LEAs from adopting other models or developing their own. To date, all states in McREL's central region (Colorado, Kansas, Missouri, Nebraska, North Dakota, South Dakota, and Wyoming) have completed initial rounds of CSR D funding with two states (South Dakota and Missouri) completing second and third rounds. Presently, thirty-two different school reform models are being implemented in ninety-two sites in the Central Region. Nine of the thirty-two models are identified as *alternative models*. The *alternative models* are models not listed in Legislation or either NWREL's *Catalogue of School Reform Models* (NWREL, 1998), or the AIR's *An Educator's Guide to Schoolwide Reform* (Educational Research Service, 1999). Eighteen of the ninety-two sites selected *alternative models*. McREL is finalizing a study of the *alternative models* in the central region. This study will examine the CSR D sites that selected *alternative models* and their approach to comprehensive school reform. It is anticipated that the findings will help McREL tailor specific technical assistance for these sites.

McREL will continue to convene the CSR D SEA Network Forums as an avenue to discuss issues relative to technical assistance needs and CSR D model implementation and to strengthen communication and collaborative links with model developers. Some of the challenges identified by the model developers from previous SEA Network Forums are:

- Some schools feel a sense of isolation from being in a district where no other schools are engaged in reform efforts
- Some teachers do not recognize the stages of implementation of a new initiative, especially the implementation dip which effects some teachers negatively
- Educators tend to want to choose one component to implement rather than all of the necessary component for success
- Some school improvement plans incorporate too many goals in their school improvement plans which effect successful implementation of the model

McREL is currently planning to convene the next CSRD SEA Network Forum, July 2000. It is anticipated that a wide representation of model developers from the central region will participate in this event.

Tables 1 and 2 summarize CSR activity in the Central Region by state and model respectively. In addition, Table 3 summarizes models in use across the region, but not under the CSRD Initiative. The last table, Table 4 identifies selected alternative models in the central region.
