ABSTRACT

This report shows the results of 1998 student opinion survey at Rogue Community College (RCC) (Oregon). Results of the survey provide broad insight into strengths and weaknesses of the college's programs, services, and image. As part of the additional questions that RCC incorporated into the survey, students were given the opportunity to offer written comments on any topic they wished. This report summarizes what the 141 students who offered comments communicated and provides all verbatim comments. This year, the ACT Student Opinion Survey was conducted among students at the Grants Pass campus and Riverside Center. Grants Pass students most often remarked on classes and programs (27%) followed by faculty/staff and general comments (each 14%). In terms of classes and programs, students most often voice a desire for more variety/class times (23%), and more evening and summer classes (10% each). Not surprisingly, the parking situation was mentioned most often by Riverside Center students (27%). The vast majority of remarks on parking are negative (96%). Nearly four out of five (78%) of the remarks regarding faculty/staff are positive. All remarks on food service indicate a need for improved/expanded facilities. Many other comments relate to a desire for child and health care, and a possible need for better traffic control. (Contains Sample Summaries and Addendum Questionnaire.) (JA)

1998 ACT Student Opinion Survey

OVERVIEW

Every other year, RCC conducts a standardized survey of student opinions on a variety of subjects. Results of the survey provide broad insight into the strengths and weaknesses of the college's programs, services, and image. Results are also compared with other community colleges in Oregon and community colleges nationwide. As part of the addendum questions that RCC incorporated into the survey, students were given the opportunity to offer written comments on any topic they wished. This report summarizes what students communicated and provides all verbatim comments.

METHODOLOGY

This year the ACT Student Opinion Survey was conducted among students at the Grants Pass campus and Riverside Center from May 6 through May 19, 1998. Questionnaires were distributed and completed during class time using a representative cross-section of classes. A rainbow-colored RCC pencil was given as a token incentive to each participating student. Six members of IETF administered the survey in the various classes.

As a reflection of the approximate proportions of total college enrollment at the two sites, 62% (248) of the questionnaires were completed at the Grants Pass campus, while 38% (151) of the questionnaires come from Riverside Center, for a total of 399 survey documents. The target sample for each class was based on the proportion of its enrollment in relation to total enrollment for all classes surveyed. A sample summary is attached to this report.

Seventy-eight (31%) of the Grants Pass respondents and sixty-three (42%) of the respondents from Riverside Center offered written comments. Details of these remarks are presented in the text and tables that follow.

EXECUTIVE SUMMARY

Grants Pass Campus

Grants Pass students most often remarked on classes and programs (27%), followed by faculty/staff and general comments (each 14%). The table on the following page details other topics mentioned.

In terms of classes and programs, students most often voice a desire for more variety/class times (23%), and more evening and summer classes (10% each). More than half (56%) of the faculty/staff comments are favorable, and more than eight out of ten (81%) of the general comments are positive. All but one of the eight comments relating to computer labs express a desire for more open lab availability. Most remarks about the bookstore relate to too-high textbook prices, and all comments on food service, registration, and financial aid at the Grants Pass campus are unfavorable. Remarks on smoking usually indicate a distaste for smoking outside of building doorways. Other comments cover a wide range of issues.

(While these remarks provide valuable qualitative information, it should be kept in mind that the number of responses in any one topic area is too low to accurately indicate a need for change. Data from the main part of the ACT survey should provide more reliable information based on adequate sample sizes.)

EXECUTIVE SUMMARY

Riverside Center

Not surprisingly, the parking situation was mentioned most often by Riverside Center students (27%). Fifteen percent (15%) of the comments were general in nature, and 14% of the remarks center on classes and programs. The table on the following page provides detail on other topic areas.

Although the vast majority of remarks on parking are negative (96%), one student thinks "the parking problem is getting a little better." Nearly all (93%) of the general comments are favorable. In terms of classes and programs, students most often voice a desire for more variety/class times (50%). Nearly four out of five (78%) of the remarks regarding faculty/staff are positive. Comments regarding financial aid at Riverside Center are favorable. All remarks on food service indicate a need for improved/expanded facilities. Many other comments relate to a desire for child and health care, and a possible need for better traffic control. Other remarks cover a wide range of issues.

(While these remarks provide valuable qualitative information, it should be kept in mind that the number of responses in any one topic area is too low to accurately indicate a need for change. Data from the main part of the ACT survey should provide more reliable information based on adequate sample sizes.)

It would be nice if more classes were offered in the summer! I have to wait until Winter to take the final class to get my degree, and I really don't want to wait.

It would be nice to have more options in the summer!

The limited times offered for some classes is a scheduling problem.

It is difficult for me to get a class schedule that is easy to work with. Many of the courses that I need to take are not offered on the Mon/Wed schedule. Those are the only two days that I can attend!

This term the classes I needed were only offered at one time during the week. The same class should be offered at least two times per term on each campus, especially computer classes.

I would really like to see the self-defense class back. I was in it once before, and it was canceled from lack of students. Numbers should not be important in a class like that because of its importance to myself and others.

Rogue needs to develop an athletic program. More students from Southern Oregon would attend if athletics were offered.

The Physical Therapy Assistant program needs to begin.

I hope to see RCC connected to SOU – in other words, a student could take classes at both schools. I also hope to see the PTA [Physical Therapy Assistant] program installed.

It would be nice if we had a Dental Hygiene program. We have Nursing, Massage Therapy, and computer technology and auto – but no dental program.

I would like to see more music programs.

I wish there was a Photo class to go with Journalism.

I wish the Networking & Graphics program would have been available while I was attending instead of being instituted the fall after I leave.

Better curriculum on using hand-held calculators. Special purchasing options (lower prices) and one-credit class on how to use calculators (WalMart has better prices).

The computer science courses should always take place in a lab with computers, not just in some building in Coates Hall. It would be nice to see some direct application work/career-oriented projects in programming. [*Telephone followup:* The projects are too general. I think they would be better and more helpful if they were more specifically project-oriented.]

RCC needs to offer more degree programs.

I'd love to see this college grow and offer more classes, including more upper-division classes.

Attendance policies need to be changed. I have a good GPA, but this term it will suffer due to attendance policies. There are times when I cannot make it to class.

Some classes, such as Human Sexuality, should not be mandatory.

I'm not fond of the group learning. I've had some bad experiences.

I think the Nursing program is very unfair. First, you can only apply once a year. Second, there are so few accepted. It's very discouraging.

Do not cut back CWE hours for medical transcription/medical office – as a supervisor who oversees the CWEs, the 198 hours are necessary to full training for the job force! I would hire fewer students without this training.

The instructors in my major (Automotive) are the best instructors in the world. [*Telephone followup:* Chris Simper goes out of his way to help you understand. He will stay on his own time, and not tell you "it's in the book" or come see him later. During lecture, he makes sure everyone understands – he'll explain it again or demonstrate until everyone understands. He's thorough about his job and knowledgeable in all his areas. He's one of the best instructors I've ever been around.]

I enjoy the learning environment, and the instructors seem caring. I really enjoy Mr. W. Peterson and Math 60 with Mr. Robertson.

All teachers should take the time to answer questions in class and not keep referring students to the Learning Center. Some students don't have time to be at the Learning Center.

The new first-year Spanish teachers in 1997-1998 were a disappointment. My instructor for Math 243 was a terrible teacher. He didn't know how to use or explain Excel. I felt as though I learned nothing in that class.

My first term was Winter 98. My Psychology instructor's grading was unfair. He is a very degrading individual, and he is only a job counselor, not a psych instructor. I feel I was "robbed" of my education for that subject and actually lost money because I had to withdraw.

I do not appreciate the attitude the teachers take in trying to be politically correct in response to sexual orientation. I don't like the way the issue is forced down my neck (i.e., it seems to me every paper, book, class talks about it more than anything else).

There are instructors here who should not be teaching – you know who they are! The size of their classes should make it pretty obvious. Some of us are stuck anyway!

Financial Aid

More help needed for Financial Aid office.

Food Service

I like how there was more food to choose from. I don't like the cafeteria now.

The cafeteria doesn't have enough vegetarian items to choose from, and there is only one day a week that meat isn't cooked in the french fries oil.

The cafeteria food is unpleasant.

If I could change any one thing, I would really improve the cafeteria.

[*Telephone followup:* The cafeteria should offer more healthy choices. The salad bar is okay, but there are not enough items and it's sometimes not fresh. The prices are okay. I'd like to see a Subway type of setup, where you could build your own sandwich and not have to just take the pre-made ones.]

Prices are too high in the cafeteria.

Cafeteria service is bad! Very bad!! Can you hire people that work, please. Waiting 15 minutes for a pizza that is cooked and sitting on the counter is unsatisfactory.

I feel that the students at this facility could benefit greatly from the addition of ... child care and a health clinic.

Classes/Programs

I feel many of the classes are just as good as those I have attended [at SOU].

I think 2-hour blocks for each class is acceptable, or at least 1-1/2 hours at the least.

I would like to see classes that begin with a new book – continue with that book until the class is finished, or after another class and continue with that book. Especially computer classes like Excel, Access, operating systems, etc.

I believe with the number of students attending Rogue who plan on transferring to obtain their teaching degree, more classes should be offered for that discipline.

Our time and money were wasted as we had to get a sitter. It was also too late for him to take another class. Very dissatisfied.

Possibly somewhere to sit outside (to study or talk to people).

It would be nice to have a few benches so that some can sit outside. A few planter boxes to brighten up the place would also be nice.

Tables in the student lounges. Thank you.

We do need more study room. At Riverside Center, the study area is not big enough.

I think it would be very helpful to students to put in a crosswalk across Riverside Boulevard extending from 9th Street.

There are serious problems with trying to cross the streets to classes here, especially near D Building. My teacher, myself, and his child were almost run over in the crosswalk.

Bartlett and 8th near D Building – intersection needs a light – extremely dangerous.

Although I commend Mr. DeBoer for his part in this location selection – I strongly feel with the closure of the Phoenix campus – locating in South Medford (possibly the K-Mart building or the old Ernst location) would have been a better answer. Traffic, parking and access to food outlets would have been better.

How about a new site?! One which is strictly RCC.

Faculty/Staff

The staff and instructors have been helpful, friendly and informed. Coming back to school has been a wonderful experience.

Howard Fulmer was a great find! Thank you.

All of my instructors are great. I really feel that I'm learning what they teach me. Mrs. Bryan is a great teacher. I've really enjoyed her class.

I have only taken two classes per term for the past year, and I must comment on the math teachers. They have been extremely concerned with the students' succeeding. I find this remarkable. They have a real genuine concern.

I would like to see more morning courses so that I would be able to attend more courses while working. One of the problems I have faced is that some of the classes I would like to take have prerequisites that are too late in the day for me to take, while the classes themselves are early enough for me to take.

More evening courses please!

Better class scheduling for evening.

The CS101 lecture is a waste of time.

Need to expand evening classes and computer labs. CS101 is not what I thought. It is long, boring and the same thing every week. That class is to teach students about computers by the book chapters, not what is said now.

Classes should be on a semester basis, not quarterly.

I think that RCC could do more to promote the educational and vocational training opportunities it offers to the minority population in the Rogue Valley.

Computer Labs

Need more computer lab time available.

More access to computers at all times of the day would be very helpful to us students with busy and schedule-packed days.

Counseling

I did not have good luck with the advisors – just returning back to college after 20 years – I felt quite rushed through that process. No personal concern or at least very little.

Some teachers have seemed to have had problems with me for some strange reason. But other than that, no other comments. [*Telephone followup:* There was a little argument between a teacher and a student – really silly. My math teacher is rude. He won't help when asked, just says it's in the book or see him later.]

The non-teaching staff at Riverside are wonderful, friendly and professional. The staff at Grants Pass are RUDE, and do not know what is going on; very unprofessional!

Financial Aid

Brenda in F.A. doing a great job!

Financial aid office (Brenda) at Riverside is great; however, the one in GP is not.

An employee in Grants Pass made a huge error concerning my financial aid, which caused my rent and utility bills to be several days late. That campus said they made the mistake, but I don't believe any recourse action was issued towards the employee. I did not appreciate the lack of concern and compassion from them towards me. I did not need to go through that kind of stress. [*Telephone followup:* They kept trying to lay it back on me, saying my paperwork was not done, so my check wasn't included in the check run. I kept saying I had copies of my paperwork in my hand, but they wouldn't listen. They kept hassling me. They weren't helpful. No one cared. Finally they admitted it was their mistake. I had to drive all the way out to Grants Pass to pick up my check. I didn't expect this from my college experience.]
