ABSTRACT

This pamphlet notes how active family involvement in education can benefit children's achievement, attitudes, schools, and teachers. It describes how families and schools can work together to contribute to the education process. The pamphlet details the components of a family-school partnership promise to work together, exchange information, share decision-making, and collaborate for children's learning. The pamphlet also includes a form for joining the Partnership for Family Involvement in Education and delineates materials available from the U.S. Department of Education providing guidelines for getting families involved in education. Finally, the pamphlet describes ways parent organizations and schools can support family involvement in education by: (1) opening the lines of communication and making families feel welcome as equal partners; (2) giving teachers the tools to reach out to families; (3) setting high expectations for children by helping them enroll in challenging courses; (4) using technology to link parents to the classroom; (5) overcoming language barriers; and (6) encouraging communities to join family-school partnerships.

FAMILY-SCHOOL PARTNERSHIP PROMISE

Families and schools across America increasingly are accepting mutual responsibility for children's learning. When families are involved in children's learning, at school and at home, schools work better and students learn more. Schools and families are working with employers and community organizations to develop local partnerships that support a safe school environment where students learn to challenging standards. By working together, exchanging information, sharing decision making, and collaborating for children's learning, everyone can contribute to the education process.

Coming together as families, local school board governance, administration, teachers and school staff, we form this partnership and affirm the importance of family involvement in children's learning. We pledge to:

- **Share responsibility** at school and at home to give students a better education and a good start in life.
- **Help schools** to welcome families; to reach out to families before problems arise; to offer challenging courses; to create safe and drug-free learning environments; to organize tutoring and other opportunities that improve student learning; and to support the inclusion of families in the school decision-making process.
- **Help families** to monitor student attendance, homework completion and television watching; to take the time to talk with and listen to their children; to become acquainted with teachers, administrators and school staff; to read with younger children and share a good book with a teen; to volunteer in school when possible; and to participate in the school decision-making process.
- **Promote effective, two-way communication** between families and schools by schools reducing educational jargon and breaking down cultural and language barriers and by families staying in touch with the school.
- **Provide opportunities for families** to learn how to help their children succeed in school and opportunities for school staff to work with families.
- **Support family-school efforts to improve student learning** by reviewing progress regularly and strengthening cooperative actions.

GREAT WAYS TO GET INVOLVED

- *America Goes Back to School* encourages everyone to go back to a school each fall to share their talents and experiences. A free kit is available to help you organize an event and start a long-term partnership between your local school and community organizations and businesses.
- *Think College Early* encourages students to take the tougher courses they need to be prepared to go to college, starting in middle school, and to inform parents of the necessary sequence of courses their child needs to take, such as algebra in the eighth grade and chemistry by eleventh or twelfth grade, as well as the financial planning needed to help pay for college.
- *America Reads Challenge: Read*Write*Now!* encourages children to read and write 30 minutes a day and to work with a learning partner. Age-appropriate activities and materials are available to help children work on their reading skills with parents, teenagers, and other caring adults.
- *Priority on After-School Extended Learning*. Partner members have placed new emphasis on the importance of providing before- and after-school activities that extend learning for children in a safe, drug-free environment.

HOW PARENT ORGANIZATIONS AND SCHOOLS CAN SUPPORT FAMILY INVOLVEMENT IN EDUCATION

Open the lines of communication and make families feel welcome as equal partners. Written materials to parents should be concise, easy to read, and free of educational jargon that parents may not understand. Schools often seem unwelcoming to family members, and parents often feel that educators talk down to them. Parents and educators need to help bridge this critical gap.

Give teachers the tools to reach out to families. Staff development can help teachers understand the benefits of family involvement and give them strategies for improving two-way communication between home and school.

Set high expectations for children by helping them enroll in challenging courses. Expect and encourage children to take tough academic courses. Help them take algebra by the end of the eighth grade. Encourage parental participation in school improvement efforts and after-school programs to give students extra academic help and enrichment activities in a safe environment.

Use technology to link parents to the classroom. New technologies such as voice mail systems, homework hotlines, and the Internet can all help bring parents and schools closer together. Many teachers still don't even have the old "technology" of a telephone in their classrooms. Finding resources for these technology tools can be a collaborative effort.

Overcome language barriers. Schools and parent organizations need to make special accommodations to reach parents whose first language is not English. Translate materials, make translators available for verbal communication in the parents' first language, and offer bilingual voice-mail systems for families.

Encourage communities to join family-school partnerships. Parents and community members can come together to help combat safety problems in the neighborhood around the school. Schools can partner with community groups, businesses, or religious organizations to offer after-school activities. Partnerships can lead to many effective programs that benefit the students and their families.
