# Australian Vocational Education and Training Statistics

### **H**IGHLIGHTS

- There were 1.67 million students enrolled in the public VET system in 2007.
- Around one in nine people aged 15 to 64 years participated in the publicly funded VET system in Australia in 2007.
- The number of apprentices and trainees in-training as at 31 December 2007 was 405 500.
- 89.2% of graduates were employed or in further study approximately six months after their training in 2007.
- Total operating expenditures in Australia's public VET system was \$5490.6 million in 2006.







### Proportion of students by highest current qualification<sup>5</sup>, 2006–07





## Apprentice and trainee training rates by selected characteristics, 1998 and 2007





#### OPERATING REVENUES<sup>14</sup>, PUBLIC VET SYSTEM, 2005-06





#### OPERATING EXPENDITURES, PUBLIC VET SYSTEM, 2005-06



#### PROPORTION OF GRADUATES<sup>16</sup> BY KEY OUTCOME MEASURES<sup>17</sup>, 2007





#### NOTES ON TABLES AND GRAPHS

- In 2004 there was a large decrease in VET activity in the New South Wales adult and community (ACE) sector due to problems with software compatibility associated with the introduction of new systems by many of their providers. There were significant improvements in the NSW ACE reporting system in 2005, evident in increases in the reported number of female students and students in the older age groups (45–64 years and 65 years and older).
- 2 In 2006 New South Wales reported activity for workplace learning and the NSW Adult Migrant English Service (AMES) Skillmax Program for the first time.
- 3 Full-time and part-time study mode is based on total hours of delivery. In 2006 this excluded hours associated with continuing enrolments in all states and territories, except Victoria.
- 4 Participation rates are derived by calculating student numbers in the age group as a percentage of the estimated residential population in the corresponding age groups. Figures for all years are based on Australian Bureau of Statistics (ABS) population figures, catalogue number 3201.0.
- 5 For consistency of reporting, senior secondary education has been excluded from Australian Qualifications Framework (AQF) qualifications. It has been included as part of 'Other recognised courses' in the non-AQF qualifications grouping. As a result, the number of qualifications completed in AQF and non-AQF qualifications may not match those previously reported in earlier publications.
- 6 Industry skills councils represent particular industries and groups of training packages. #### Notes

- 7 Because data for qualifications completed in 2007 are based on preliminary data submissions, they are not presented in detail in this publication. Preliminary estimates indicate that there was a total of 281 200 qualifications completed in 2007 (compared with a preliminary estimate of 263 000 qualifications completed in 2006). The 2007 data will be revised upwards in the 2008 edition of this publication to accommodate further notification of qualifications completed.
- 8 The number of apprentices and trainees in-training are those aged 15 years and over.
- 9 The data presented in this figure have been seasonally adjusted using X-11-ARIMA methodology and then are 7-point Henderson smoothed.
- 10 ASCO is the ABS Australian Standard Classification of Occupations (2nd edition).
- 11 Derived by calculating the number of trade apprentices (aged 15 years and over) in-training as at 31 December (NCVER data) as a percentage of employed persons (aged 15 years and over) as at November (ABS data). The ABS does not produce monthly estimates of employment by occupation, with data available on a quarterly basis only (i.e. February, May, August and November).
- 12 Trade employment refers to those persons aged 15 years or over employed in a 'Tradespersons and related workers' occupation (ASCO 2nd edition).
- 13 Derived by calculating the number of apprentices and trainees (aged 15 years and over) in-training as at 31 December (NCVER data) as a percentage of employed persons (aged 15 years and over) as at December (ABS data).
- 14 All figures use actual prices for the year.

- 15 Includes impairment losses, losses on sales of property, plant and equipment, borrowing costs and other operating expenses.
- 16 The term 'graduate' refers to students who are reported as having completed all requirements for a qualification and students who identify as having completed all requirements.
- 17 Data include TAFE, other government and private providers (and the vocational part of community education providers in New South Wales and Victoria).
- 18 Includes fully or partially achieved main reason.
- 19 Module completers are students who have successfully completed part of a course (at least one module) without gaining a qualification.
- 20 Employed or in further study for module completers is defined as employed after completing a module of VET or going on to further study at university as, by definition, the only further study captured for module completers is at university (4.5% of module completers went on to study at university).
- 21 Includes TAFE divisions of universities.
- 22 These findings are not applicable to module completers.
- 23 Employers were asked about their use of VET and other forms of training in the 12 months preceding their interview.
- 24 Nationally recognised training is defined as training other than as part of an apprenticeship or traineeship. For the purposes of this survey, apprenticeships and traineeships are reported separately.
- 25 Satisfied is a rating of 'satisfied' or 'very satisfied'.
