Australian vocational education and training statistics

Apprentices and trainees

March quarter

Highlights

There were 437 000 apprentices and trainees in-training as at 31 March 2010, an increase of 1.8% from the previous year.

In the 12 months to 31 March 2010, compared with the previous year:

- commencements increased by 1.5%, to 284 000
- completions increased by 4.0%, to 162 100
- cancellations and withdrawals decreased by 6.5%, to 123 200.

For seasonally adjusted data, comparing the March quarter 2010 with the December quarter 2009:

- commencements in trades occupations increased by 2.9%
- commencements in non-trades occupations increased by 1.7%
- completions increased by 0.3%
- cancellations and withdrawals increased by 1.1%
- in-training numbers increased by 0.5%.

Introduction

This publication presents estimates of apprentice and trainee activity in Australia for the March quarter 2010. The figures in this publication are derived from the National Apprentice and Trainee Collection no.64 (June 2010 estimates).

The most recent figures in this publication are estimated (those for training activity from the September quarter 2008 to the March quarter 2010). Estimates take into account reporting lags that occur at the time of data collection. Consequently, the figures in this publication may differ from those published in earlier or later reports.

Estimated data are presented in this publication on a seasonally adjusted, quarterly and 12-month ending series basis. The 12-month ending series is particularly useful in showing longer-term data trends, but is less useful in identifying turning points.

The seasonally adjusted data involve the use of a mathematical model to smooth out fluctuations due to seasonal influences. Seasonally adjusted data are useful to illustrate trends from one quarter to the next, but cannot be further disaggregated.

Overall trends

In-training

The number of apprentices and trainees in-training as at 31 March 2010 was 437 000, an increase of 1.8% from the 429 400 recorded one year earlier. In-training numbers increased in every state and territory with the exception of Tasmania.

For the 12 months ending 31 March 2010

Commencements

The number of commencements in the 12 months ending 31 March 2010 was 284 000, an increase of 1.5% from one year earlier.

Of this:

- trades commencements increased by 6.3%
- non-trades commencements decreased by 0.4%.

State and territory commencements in the 12 months to 31 March 2010, compared with the previous year, showed:

- New South Wales (+0.2%)
- Western Australia (+0.5%)
- Victoria (+3.4%)
- Tasmania (-3.4%)
- Queensland (+0.1%)
- Northern Territory (+4.8%)Australian Capital Territory (+5.7%)
- South Australia (+5.7%)

Completions

The number of completions in the 12 months ending 31 March 2010 was 162 100, 4.0% higher than the 155 800 completions recorded in the 12 months ending 31 March 2009.

Cancellations and withdrawals

The number of cancellations and withdrawals in the 12 months ending 31 March 2010 was 123 200, 6.5% lower than the 131 800 cancellations and withdrawals in the 12 months ending 31 March 2009.

Seasonally adjusted data

In-training

The number of apprentices and trainees in-training increased over the last three quarters, up 1.5% between the June quarter 2009 and the March quarter 2010.

Commencements

Trades commencements have increased over the last four quarters, up 20.2% between the March quarter 2009 and the March quarter 2010.

Non-trades commencements have increased over the last four quarters, up 9.1% between the March quarter 2009 and the March quarter 2010.

Completions

The number of completions have increased over the last four consecutive quarters, up 5.4% between the March quarter 2009 and the March quarter 2010.

Cancellations and withdrawals


Cancellations and withdrawals have increased over the last two quarters, up 2.2% between the September quarter 2009 and the March quarter 2010.





Figure 2 Commencements, completions and cancellations/withdrawals², seasonally adjusted¹, 2000–2010 ('000)

Terms

Australian Qualifications Framework (AQF) is a national framework of credentials that covers qualifications from certificate I through to a doctoral degree. For more details on the AQF, go to http://www.aqf.edu.au.

Australian and New Zealand Standard Classification of Occupations (ANZSCO) is a classification of the occupation of individuals. The classification is based on the Australian Bureau of Statistics publication, Australian and New Zealand Standard Classification of Occupations (1st edition, ABS cat.no.1220.0).

Cancellations and withdrawals refers to apprentices and trainees whose contract of training has been terminated prior to a successful completion. Cancellation and withdrawal figures also include contracts which have been transferred, due to a change in employer. 'Transferred' is a new contract status which was historically reported as a cancellation or withdrawal.

Commencements refers to apprentices and trainees starting a program of training. The date of commencement is the date that an apprentice or trainee's contract of training is registered or approved under the provisions of the relevant state/territory legislation.

Completions refers to apprenticeship or traineeship contracts of training in which all of the prescribed requirements have been met.

Contract status indicates the status of apprentice and trainee contracts of training, including the commencement, completion, and cancellation/withdrawal of contracts, and apprentices and trainees 'in-training'.

Existing workers refers to those apprentices and trainees who were employed by their current employer for more than three months full-time (or 12 months part-time/casual) prior to commencing their training contract.

Full-time apprentices or trainees are those whose ordinary hours of employment, including the training component, are at least the usual hours of employment for a full-time employee in that occupation.

Industry skills councils are organisations representing particular industries. For more information on industry skills councils, go to ">http://www.isc.org.au/>. For more information on training packages developed by industry skills councils, go to . For more information on training packages developed by industry skills councils, go to .

In-training refers to apprentices and trainees who are actively training, at the end of each quarter, under the terms of their training contract, and who have not completed, cancelled, withdrawn or suspended their training, nor had their training contract expire without meeting all of the prescribed requirements of their program.

Non-trades refers to those apprentices and trainees employed in occupations outside the trades. 'Non-trades' includes all occupations listed under ANZSCO 1st edition, with the exception of major group 3 (Technicians and trades workers).

Part-time apprentices or trainees are defined as those whose ordinary hours of employment, including the training component, are less than full-time. Part-time provisions vary across Australia and across occupations, with 'part-time' defined by each state and territory.

Seasonal adjustment refers to a mathematical model used in time series data to smooth out fluctuations attributable to seasonal influences.

Trades refers to those apprentices and trainees employed in trades occupations under major group 3 (Technicians and trades workers) of ANZSCO 1st edition.

Training duration indicates the amount of time that an apprentice or trainee takes to complete their contract of training from the time of commencement.

Training packages are a set of nationally endorsed standards, guidelines and qualifications for training and for recognising and assessing skills. For more details on training packages, go to http://www.ntis.gov.au.

12-month ending series refers to the total number of commencements, completions and cancellations/withdrawals within a 12-month period (i.e. summing the current quarter with the previous three quarters).

Data source

Information included in this publication is, unless stated otherwise, derived from the National Apprentice and Trainee Collection, no.64, June 2010 estimates, which is compiled under the Australian Vocational Education and Training Management Information Statistical Standard (AVETMISS) for Apprentice and Trainee Collection Specifications, Release 6.0, March 2008.

Estimation procedure

This publication contains figures on apprentice and trainee activity (such as commencements, completions and in-training) based on the date of effect rather than the date of processing. Due to lags in processing, the most recent figures in this publication are estimated (for training activity from September quarter 2008 to March quarter 2010). The estimation method involves weighting recently processed numbers based on average reporting lags. Because estimates are revised for up to seven quarters, figures for the last two years may differ from those published in earlier or in subsequent reports. Seasonal adjustments

Seasonally adjusted data in this publication are derived from table 2 for in-training, table 4 for commencements, table 6 for completions and table 8 for cancellations and withdrawals. These data are adjusted using X-11-ARIMA methodology and then are 7-point Henderson smoothed. The seasonally adjusted data used in figures 1–3 are available at http://www.ncver.edu.au/publications/2289.html>.

Due to lags in processing numbers, recent quarter activity is estimated. Proportions (percentages) may be subject to error as they are based on a sample, not the total population. Figures in bold are actual numbers.
