
2009-10 DEGREES AND CERTIFICATES COMPLETED AT CONNECTICUT HIGHER EDUCATION INSTITUTIONS

Increase in Degrees and Certificates

Students at Connecticut colleges and universities completed a record 38,912 degrees and certificates in 2009-10, up 2.3% from 2008-09. This increase represents the state's ninth consecutive year of growth, with a 30.8% increase since 1999-00 and a 42.6% increase since 1982-83.

Degree and Certificate Completions Related to Enrollment

As in previous years, the number of degrees and certificates earned was closely related to the full-time equivalent (FTE) enrollment from prior years. The surge in enrollment in the early part of the 2000s due to a large demographic cohort of traditional college-age students unsurprisingly translated into an increase in the number of degrees earned. Over the most recent 12 years, changes in FTE enrollment account for 98.9% of variation in the number of postsecondary awards conferred. This high level of association suggests that the number of degrees and certificates will continue to increase over the next three years to over 42,500 in 2012-13.



The dotted line for degrees and certificates for 2011-2013 represent a projection based on FTE Enrollment. Dotted circles represent the actual statewide FTE enrollment for 2008-09, 2009-10, and 2010-11. FTE enrollment for this chart is calculated on Fall headcount as 1 full-time student = 1 FTE and 1 part-time student = 1/3 FTE.

Consistent Distribution of Awards by Level over Time

While the total number of awards has increased significantly since 1982-83, the distribution of degrees and certificates among most award levels has remained relatively stable over time, except among associate's degrees. In 2009-10:

- 50.6% of awards were bachelor's degrees compared to 49.2% in 1982-83.
- 22.4% of awards were master's degrees compared to 20.1% in 1982-83.
- 4.7% of awards were doctor's degrees compared to 5.0% in 1982-83.

¹ Previous reports about completions have aggregated post-master's certificates with master's degrees. This report places post-master's certificates for all years in the category of graduate certificates or breaks them out separately.

• The largest change was observed among associate's degrees which represented 14.3% of awards, compared to 21.6% in 1982-83, although this decline was offset slightly by an increase in undergraduate certificates, which represented 4.6% of awards in 2009-10 compared to 1.8% in 1982-83.

Consistent Distribution of Awards by Higher Education Sector over Time

Similarly, the distribution of awards among higher education sectors also remained relatively stable over time, with largest changes occurring among two-year public colleges and the state's national independent universities. Across the state in 2009-10, students attending:

- regional independent institutions earned 30.6% of awards, compared to 28.1% in 1982-83.
- the University of Connecticut earned 18.1% of awards, compared to 16.8% in 1982-83.
- the Connecticut State Universities earned 18.0% of awards, compared to 18.0% in 1982-83.
- national independent universities earned 14.9% of awards, compared to 17.7% in 1982-83.
- Connecticut Community Colleges² earned 14.3% of awards, compared to 17.7% in 1982-83.
- two-year independent institutions earned 2.1% of awards, compared to 0.3% in 1982-83.
- other public institutions earned 1.8% of awards, compared to 1.5% in 1982-83.

Increase in Awards Earned by Students in Minority Race/Ethnicity Groups

A total of 7,198 degrees and certificates were earned by individuals from minority groups³ in 2009-10, representing 18.5% of award recipients, up from 18.4% in 2008-09. These figures indicate increased racial/ethnic diversity among college graduates compared to 6.2% of awards earned by minorities in 1982-83.

- Black, Non-Hispanic students earned 7.2% of awards in 2009-10 compared to 2.5% in 1982-83.
- American Indian or Alaska Native students earned 0.4% of awards in 2009-10 compared to 0.3% in 1982-83.
- Asian or Pacific Islander students earned 4.5% of awards in 2009-10 compared to 1.1% in 1982-83.
- Hispanic students earned 6.6% of awards in 2009-10 compared to 1.4% in 1982-83.
- White, Non-Hispanic students earned 65.1% of awards in 2009-10 compared to 91.3% in 1982-83.
- Award recipients whose race/ethnicity is unknown earned 10.3% of awards in 2009-10 compared to 0.0% in 1982-83; the marked increase in this group complicates how these figures are interpreted.

Women Continued to Earned More Degrees and Certificates then Men

For several decades women have earned more post-secondary credentials than have men, and this pattern continued in 2009-10, with women earning 22,983 or 59.1% of all awards. This percentage increased over the recent dip to 58.7% in 2008-09. Between 1989-90 and 2009-10, women attending Connecticut institutions earned over 100,000 more degrees and certificates than did men.

Degrees and Certificates by Discipline

Degrees and certificates awarded in the area of Health & Fitness outpaced growth in other areas, with the proportion of awards increasing from 10.0% in 1999-00 to 13.1% in 2009-10 (an annual difference of about +2,100 per year). Credentials awarded in Science, Technology, Engineering & Math fields also increase to slightly outpace growth in other areas, increasing from 12.6% of all awards in 1999-00 to 13.1% in 2009-10 (an annual difference of about +1,300 per year). Conversely, the proportion of awards conferred in education dropped from 10.5% in 1999-00 to 8.7% in 2009-10 (an annual difference of +250 per year) and the proportion of awards conferred in business dropped from 20.0% in 1999-00 to 17.3% in 2009-10 (an annual difference of about +1,000 per year).

² Completions in the State Technical Colleges in 1991-92 and prior years are grouped in this report with the Community Colleges.

³ For the purposes of this report, minority groups are considered to be students reported as Black, Non-Hispanic; American Indian or Alaska Native; Asian or Pacific Islander; and Hispanic. Percentage calculations include the number of students whose race/ethnicity is unknown in the denominator; the increase in this proportion of individuals over time adds some uncertainty into the interpretation of these figures.

About the Data

Data provide in this report were extracted from the Connecticut Department of Higher Education (CT DHE) completions database as of December 1, 2010. Data in this resource are collected from higher education institutions by CT DHE in conjunction with reporting to the federal Integrated Postsecondary Education Data System (IPEDS) as required by the Higher Education Opportunity Act. In Connecticut, higher education institutions report submissions for the IPEDS fall enrollment survey and the completions survey to CT DHE using a macro-enabled Excel workbook. Institutions report information for all other IPEDS surveys directly to the U.S. Department of Education. This workbook performs a number of quality control checks to improve data integrity. CT DHE then uploads data in a batch to IPEDS and institutions check submissions before locking the data. These data are also stored in a database at CTDHE for agency reporting. These data are accessible via the internet at http://www.ctdhe.org/database/Completions.htm, and these data very closely correspond to figures that appear in the IPEDS Data Center (http://www.nces.ed.gov/ipeds/datacenter/).

While these control processes and mechanisms improve data quality, reporting errors occasionally are still found by institutions or by CT DHE following the close of the official reporting period. IPEDS has a specific process for making adjustments to data from the prior year, but these procedures do not always require notification of CT DHE, and so in instances where institutions have made prior year adjustments, these data may not be reflected in CT DHE databases. Conversely, some adjustments have been made to DHE databases over time that may not be reflected in the IPEDS Data Center. Thus, minor discrepancies may be observed between data presented in this report and some figure obtained from the IPEDS Data Center as well as some previous reports issued by CT DHE.
