#### SUMMARY

This annual report updates the tuition and fee prices published by all of the public higher education institutions in the WICHE member states. It is the product of an annual survey administered to the State Higher Education Executive Officers (SHEEO) offices in each state, with a couple of exceptions. There is no centralized coordinating or governing body for the two-year colleges in Arizona or for the technical institutes in South Dakota. Therefore, personnel at the individual institutions in those two states responded to this survey. A copy of the survey instructions can be found in the appendix.

#### Changes to the Report

In response to feedback from WICHE constituents, this year's edition incorporates three significant changes: 1) the addition of enrollment-weighted tuition and fee averages by state; 2) the ability to download all data tables in excel format, most notably the tables that show each institutions' tuition and fees charges; and 3) a reduction in the total number of data tables to eliminate redundancy and streamline the report. Unlike unweighted tuition and fee averages, which treat each institution equally no matter how big or small it is, enrollment-weighted averages provide a truer estimate of the published price an average student faces based on enrollment patterns. Appendix E provides more information regarding enrollment weighting.

#### Key Findings

Unweighted average tuition and fees for resident undergraduates in 2010-11 at public four-year institutions in the WICHE region were \$6,186, an increase over the previous year of \$444 (7.7 percent). After adjusting for inflation, the change in average resident undergraduate tuition in the region was 6.3 percent over 2009-10. Tuition and fees for resident in-district students at public two-year colleges in the WICHE states, excluding California, averaged \$2,834 in 2010-11, an increase of \$189 (7.1 percent), or 5.7 percent after adjusting for inflation.

Non-resident undergraduates at public four-year institutions in the region paid an unweighted average of \$17,658 in 2010-11, an increase over the previous year of \$883 (5.3 percent). After adjusting for inflation, the change in average non-resident undergraduate tuition in the region was 3.9 percent over 2009-10. Non-resident students at public two-year colleges in the WICHE states averaged \$7,109 for tuition and fees in 2010-11, an increase of \$175 (2.5 percent), or a 1.1 percent increase after adjusting for inflation.

Tuition and fees for resident graduates in 2010-11 at public four-year institutions averaged \$7,737, an increase over the previous year of \$249 (3.3 percent). After adjusting for inflation, the change in average resident graduate tuition in the region was 4.7 percent over the 2009-10 school year. Average tuition and fees for non-resident graduates in 2010-11 at public four-year institutions in the region were \$17,765, an increase over the previous year of \$277 (1.8 percent). After adjusting for inflation, the change in average non-resident graduate tuition in the region was 3.2 percent over 2009-10.

Overall, the average percent change in resident and non-resident tuition and fees for four-year institutions were higher when tuition and fees were weighted by enrollment. The inverse was found for the average percent change in enrollment-weighted resident and non-resident tuition and fees for two-year institutions.

### Endnotes

- [1] Average annual increases in tuition and fees are presented with and without California (w/o CA).
- [2] California institutions were excluded from all calculations because the large number of two-year colleges and the historically low matriculation fee structure distort regional patterns.
- [3] In 2008-09, Alaska resident students are charged \$147 per credit hour for lower division credits, \$170 per upper division credits, and \$338 per credit for graduate credits, with no limit on the number of credits. The figures reported here assume a course load of 30/24 credit hours for undergraduate/graduate for two semesters.
- [4] Only for University of Alaska Fairbanks, all undergraduate and graduate students taking nine or more credits, all students living in university housing, and all students paying the Health Center fee must be covered by a health insurance plan. The student health insurance fee in 2009-10 is \$945 per year or \$352 per semester. However students who are covered by an alternative health insurance plan may waive the student health insurance plan.
- [5] Arizona charges additional fees for certain programs: law, pharmacy, nursing, engineering, selected master's degree programs, and undergraduate degree programs at ASU and the UA.
- [6] Rates shown for undergraduate resident students at ASU (all campuses) and NAU are for new students starting Fall 2010; different rates apply to existing students. For ASU, new undergraduate resident student rates will increase no more than 5% annually until 5 years after admission as a freshman; for NAU new undergraduate (resident and nonresident) student rates reflect a Block Tuition Program that keep base tuition rates unchanged (for each cohort) for 4 years.
- [7] California State University nonresident tuition is \$372 per unit at semester campuses and \$248 per unit at quarter campuses. 30 units reported for Full Time Undergraduate, 24 units for Full Time Graduate. Prior to 2010-11 there was a Full Time Maximum of 11, 160 which is no longer used.

- [10] California State University, Hayward announced in January 2005 that it would change its name to California State University, East Bay.
- [11] Undergraduate students at the University of California are required to show proof of health insurance, effective Fall 2001. Undergraduate totals do not include waivable health insurance fees.
- [12] University of California, Merced opened in 2005-06.
- [13] The resident undergraduate tuition amounts for all Colorado institutions do not include the \$1,860 voucher for which all Colorado residents taking a full-time undergraduate course load of 30 credit hours at public institutions in Colorado are eligible. Beginning with the 2005-06 academic year, Colorado implemented the College Opportunity Fund (COF). Instead of the direct appropriations to institutions, under COF all public institutions in the state will receive an estimated \$62 per credit hour on behalf of state residents who attend their institutions during the 2010-11 academic year as undergraduates and who apply for the voucher. Students are eligible for the COF voucher until they reach 145 credit hours of undergraduate study. The per-student allocation is set by the state's General Assembly during its budget process (http://www.collegeincolorado.org/COF/\_default.aspx).

- [14] Prior to 2003, Colorado State University-Pueblo was the University of Southern Colorado.
- [15] Higher rates apply to certain fields.
- [16] Upper division undergraduate students pay a higher tuition rate.
- [17] Effective AY 2003-04, Hilo discontinued its lower division tuition rate. Hilo undergraduate students previously enrolled in AY 2002-03 as classified freshmen or classified sophomores and continuing their enrollment in Fall 2003 as classified freshmen or classified sophomores were grandfathered in at a lower rate (\$1,792 for residents and \$7,408 for nonresidents) for AY 2003-04.
- [18] The 2005 Idaho Legislature changed state law (House Bill 231, Idaho Code 33-3717) regarding the charging of "tuition" to resident undergraduate students. Previously, Idaho statute did not allow the cost of instruction to be charged to resident undergraduates who were charged a "matriculation fee" instead. Beginning July 1, 2005, Boise State University, Idaho State University, and Lewis-Clark State College charge "tuition fees" instead of a "matriculation fee." Matriculation fees will continue to be charged to resident undergraduates at the University of Idaho because the Idaho constitution would have to be amended to effect a similar change at that institution.

- [43] Prince William Sound community college charges the same tuition and fees for residents and non-residents \$127 per lower division credit hour and \$144 per upper division credit hour. The figures reported here assume a course load of 30 credit hours for two semesters.
- [44] All amounts indicated include mandatory registration and technology fees wherever these fees are not broken out separately.
- [45] All tuition and fees are calculated on 24 credit hours annually.

- [46] All Residents, except Aims Community College and Colorado Mountain College:
- The resident undergraduate tuition amounts for all Colorado institutions do not include the \$2,040 voucher for which all Colorado residents taking a full-time undergraduate course load of 30 credit hours at public institutions in Colorado are eligible. Beginning with the 2005-06 academic year, Colorado implemented the College Opportunity Fund (COF). Instead of the direct appropriations to institutions, under COF all public institutions in the state will receive an estimated \$68 per credit hour on behalf of state residents who attend their institutions during the 2009-10 academic year as undergraduates and who apply for the voucher. Students are eligible for the COF voucher until they reach 145 credit hours of undergraduate study. The per-student allocation is set by the state's General Assembly during its budget process (http://www.collegeincolorado.org/COF/\_default.aspx).
- **[47]** All Community Colleges, except Colorado Mountain College: Higher rates apply to certain fields.
- [48] Aims Community College and Colorado Mountain College both have local district tax standing. This means that the schools have different tuition structure for "in-district residents", "in-state residents", and "out-of-state" students. The values presented are for "in-district residents."
- [49] Northeastern Junior College joined the Colorado Community College System in 1997-98 and Colorado Northwestern Community College joined in 1999-2000. Tuition and fees were adjusted to be consistent with other members of the Colorado Community College System. They no longer charge an out-of-district differential.
- [50] Community college tuition is charged on a per-credit basis for all enrolled credits effective academic year 2001-02. The amounts reported here are based on 15 enrolled credits per semester (30 per year). Note that for prior years, amounts were based on 12 enrolled credits per semester (24 per year). The per-credit rate (non-resident) for AY 2010-11 is \$281 for all campuses, except Maui Community College which charges \$441.
- [51] Resident tuition levels represent amounts charged to residents of the local district/county supporting the instituion.
- [52] Effective July 1, 2007, Community College of Southern Nevada will become College of Southern Nevada.
- [53] Tuition is reported for full-time lower-division courses only. Select baccalaureate programs are offered.
- [54] Effective July 1, 2007, Western Nevada Community College will become Western Nevada College.
- [55] Northern NM College is a Four Year college with Upper and Lower Tier Tuition Rates. Funding Formula calculations utilize the Lower Tier rates reflected in this Survey.
- [56] Tuition and fee rates assume a full-time load of 15 credits per semester.
- [57] Lake Region State College was formerly the University of North Dakota, Lake Region, and Williston State College was formerly the University of North Dakota, Williston. These name changes occurred in July 1999. Dakota College at Bottineau was formerly Minot State University, Bottineau Campus, until August 1, 2009. It was formerly North Dakota State University, Bottineau until July 1997.
- [58] Clatsop Community College capped charges at 12 credit hours prior to 1997-98.
- [59] Oregon Coast Community College is accredited through Chemeketa Community College.
- [60] District policy for Southwestern Oregon Community College allows a person to obtain residency in the district after residing in the district for 90 or more days.
- [61] Tillamook Bay Community College is accredited through Portland Community College.
- [62] Prior to 2006-07 full-time status for Southeast Technical Institute was reported as 12 credits per semester.

- [63] Additional required fees may be charged for facility, technology, and program costs.
- [64] Effective July 1, 2010, College of Eastern Utah became a subsidiary of Utah State University. The name of the institution is now Utah State University-College of Eastern Utah.
- [65] Sheridan College is more accurately referred to as Northern Wyoming Community College District (NWCCD).
- [66] A student who is a resident of another state is charged an out-of-state or nonresident fee per unit. The fee is set by each community college district and is in addition to the statewide per unit enrollment fee.
- [67] A student who is a citizen and resident of a foreign country can be charged an additional nonresident fee per unit strictly for capital outlay expenditures. The fee is set by each community college district but cannot exceed actual expenditures per Full-Time Equivalent (FTE) student in the prior fiscal year and also cannot exceed 50 percent of the regular nonresident fee.
- **[68]** These rates reflect the official Washington community college nonresident tuition rates. Individual community colleges have the authority to waive all or a portion of the nonresidential differential, and the majority of the colleges do exercise this waiver authority.
- [69] Maui Community College renamed University of Hawai'l Maui College effective Februrary 2010 to reflect the institution's four-year degree offerings. However, UH Maui College will continue to be included with the community colleges for reporting purposes.
- [70] Eastern Idaho Technical College's fee structure for non-resident students was changed.
- [71] Bates adopted the standard Community College tuition schedule this year. This necessitated a smaller increase to their resident tuition to bring it to the same level as the other CC's, and a reduction to their non-resident tuition to match the level of the CC's as well.
- [72] Compton Community College is now apart of El Camino College.
- [73] There are 3 new community colleges in California: Moreno Valley College, Norco College, and Woodland community College. These institutions have not been included in the report due to limited available data. Once more data are available, these institutions will be added to upcoming tuition and fee reports.

### Appendix A

### The Carnegie Classification of Institutions of Higher Education, 2005

The 2005 Carnegie Classification includes all colleges and universities in the United States that are degree-granting and accredited by an agency recognized by the U.S. Secretary of Education. The 2005 edition classifies institutions according to several different schemes. This publication relies on the "Basic Classification," which is the most similar to the traditional classification used in previous editions of the Carnegie Classification. The Basic Classification is based on their degree-granting activities in 2003-04 and, for doctorate-granting institutions, other measures of the intensity of their research activity. Definitions for the categories within the Basic Classification scheme are included verbatim from the Carnegie Foundation's website below. For detailed information on classification procedures, refer to the Carnegie Foundation's web-based interface, available at http://www.carnegiefoundation.org/classifications/index.asp.

#### **Doctorate-granting Institutions**

Institutions were included in these categories if they awarded at least 20 doctorates in 2003-04. Firstprofessional degrees (J.D., M.D., Pharm.D., etc.) were not counted for the purpose of this criterion, nor were doctoral degrees in audiology or rehabilitation and therapeutic professions, except when we were informed that the degrees were research doctorates. As in previous editions, these categories were limited to institutions that were not identified as Tribal Colleges or Special Focus Institutions.

*Level of research activity.* Doctorate-granting institutions were assigned to one of three categories based on a measure of research activity. It is important to note that the groups differentiate solely with respect to level of research activity, not quality or importance.

The analysis was examined on the following correlates of research activity: research & development (R&D) expenditures in science and engineering (S&E; "science and engineering" is defined by NSF to include the social sciences); R&D expenditures in non-S&E fields; S&E research staff (postdoctoral appointees and other non-faculty research staff with doctorates); doctoral conferrals in humanities fields, in social science fields, in STEM (science, technology, engineering, and mathematics) fields, and in other fields (e.g., business, education, public policy, social work).

#### Master's Colleges and Universities

Institutions were included in these categories if they awarded at least 50 master's degrees in 2003-04, but fewer than 20 doctorates (as defined above). Exclusively graduate-level institutions that awarded fewer than 50 master's degrees and fewer than 20 doctoral degrees were also included. Institutions with lower levels of master's degree production can be identified in the Graduate Instructional Program classification. As in previous editions, these categories were limited to institutions that were not identified as Tribal Colleges or Special Focus Institutions.

*Program size*. Master's program size was based on the number of master's degrees awarded in 2003-04. Those awarding at least 200 degrees were included among larger programs; those awarding 100–199 were included among medium programs; and those awarding 50–99 were included among smaller programs. The smaller programs group also includes exclusively-graduate-level institutions that awarded fewer than 50 master's degrees.

#### **Baccalaureate Colleges**

Institutions were included in these categories if bachelor's degrees accounted for at least 10 percent of all undergraduate degrees and they awarded fewer than 50 master's degrees (2003-04 degree conferrals). In addition, these categories were limited to institutions that were not identified as Tribal Colleges or as Special Focus Institutions.

Institutions where bachelor's degrees represent at least 10 percent but less than half of undergraduate degrees were assigned to the Baccalaureate/Associate's category.

Among institutions where bachelor's degrees represented at least half of all undergraduate degrees, those with at least half of bachelor's degree majors in arts and sciences fields were included in the "Arts & Sciences" group, while the remaining institutions were included in the "Diverse Fields" group.

#### Associate's Colleges

Institutions were included if their highest degree conferred was the associate's degree or if bachelor's degrees accounted for less than 10 percent of all undergraduate degrees. As in previous editions, these categories were limited to institutions that were not eligible to be classified as Tribal Colleges or Special Focus Institutions.

#### Special Focus Institutions

The special-focus designation was based on the concentration of degrees in a single field or set of related fields, at both the undergraduate and graduate levels. Institutions were determined to have a special focus with concentrations of at least 75 percent of undergraduate and graduate degrees. In some cases the percentage criterion was relaxed if an institution identified a special focus on the College Board's Annual Survey of Colleges, or if an institution's only recognized accreditation was from an accrediting body related to the special focus categories.

### Tribal Colleges and Universities

These colleges are defined as members of the American Indian Higher Education Consortium,

# Appendix D Procedure for Converting Current Dollars To Constant Dollars

The Higher Education Cost Adjustment (HECA), calculated by SHEEO, was used in Table 2 to adjust for the effects of inflation. The base year for the constant dollar conversions was 2010.

The formula for the constant dollar conversion is:

$$TF_{Constant} = \frac{TF_{Current}}{(HECA_{Current} / HECA_{Base})}$$

For example, the procedure to convert average resident undergraduate tuition in 2005-06 shown in Table 1, \$4,165, to 2010 constant dollars is as follows:

$$TF_{\text{Constant}} = \frac{4,165}{(100/89)},$$

where the HECA value for 2010 is 100 and the HE CA value for 200 is 89.

Since 1980, WICHE has collected tuition and fees data annually from public four-year and two-year institutions in its 15 member states. The data are generally provided by staff at system offices or at state higher education governing and coordinating board offices; a small number of individual institutions provide their data directly. Each year, respondents are asked to provide current published tuition and fees data for resident and nonresident undergraduate, graduate, and professional students in public four-year colleges and universities, and for resident and nonresident students in public two-year colleges. Data are charged to full-time students attending for the full academic year, except special sessions and summer terms. Respondents were asked to indicate tuition and mandatory fees separately. In addition, they are asked to verify and, if necessary, correct previously reported data.

The 2010 survey was mailed to state governing and coordinating board staff in June 2010. Surveys were returned by August 2010. The survey data were reviewed for possible errors, and problems were discussed with the staff in the appropriate office. This year's breakdown by institutional type used the "Basic Classification" of the 2005 revision to *The Carnegie Classification of Institutions of Higher Education*; more information on the Carnegie classification at http://www.carnegiefoundation.org/classifications/index.asp.

This year's edition provides enrollment-weighted averages of tuition and fees in addition to the unweighted averages historically reported. WICHE used the *Fall Enrollment* Survey from the National Center for Education Statistics' (NCES) Integrated Postsecondary Education Data System (IPEDS) to determine full-time equivalents (FTEs) for each public 2-year and 4-year institution in the West. The weighted averages used FTEs by institution as the weights and FTE was calculated as equal to the full-time enrollment plus 1/3 of the part-time enrollment as reported in IPEDS for the applicable year. 2010-11 enrollment weights used the 2009-10 FTE figure since the enrollment data are not yet available. The Fall 2000 FTE calculation for Cascadia Community College and Pierce College – Puyallup used data from 2001 when these institutions started reporting enrollment in IPEDS.
