**ABSTRACT**

Divided into three parts, this booklet is designed to assist guidance counselors and administrators in identifying financial programs which aid migrant students in obtaining a higher education within the State University of New York (SUNY) system. Part I lists 16 common student financial aid programs which are available within SUNY. These include grants or scholarships that do not have to be paid back, loans which do have to be paid back, work that provides assistance through hourly earnings, and benefits. The needs analysis services are explained. Booklets and other information available from the National Scholarship Service and Fund for Negro Students are listed. Part II contains information concerning general admissions requirements and college level credit by examination, i.e., Regents Scholarship Examination, Scholastic Aptitude Test, American College Test, College Level Examination Program, Education Opportunity Program (EOP), and Regents External Degree Program. The Educational Opportunity Centers are listed. Part III contains a list of SUNY colleges with information concerning admission requirements, financial aid, housing, and the EOP program. These include university and medical centers, arts and science colleges, specialized colleges, agricultural and technical colleges, and statutory and community colleges. A list of units within SUNY by county is appended. (NQ)

## FOREWORD

The first edition of this booklet was issued in August, 1974. The second edition was revised and issued in January, 1977 and reflects changes in the SUNY system up to that date.

## INTRODUCTION

Many and various persons involved in New York State Migrant Education Projects have long indicated a need for a comprehensive listing of the higher education financial aid opportunities available to migrant students. This booklet is designed to assist guidance counselors and administrators in identifying financial programs which would aid migrant students in obtaining a higher education within the State University of New York (SUNY) system.

This booklet, "College Level Financial Aid Opportunities for Migrant Students within the State University of New York," is divided into three parts. The purpose of Part One is to list the common student financial aid programs that are available within SUNY. The second part of this booklet contains information concerning general admissions requirements and college level credit by examination. Part Three contains a list of SUNY colleges with information concerning admission requirements, financial aid, housing, and the Education Opportunity Program.

Curriculum and fields of specialization leading to the Bachelors Degree, Associate Degree, or Certificate have been purposely deleted from this study. This kind of information is available in the individual college catalog and in the booklet, "Information and Application for Admission to Your College."

## INTRODUCTION TO PART ONE

Each college has a financial aid office which any prospective student may contact for counseling on appropriate financial assistance. The primary responsibility for meeting college costs rests with the student and his family. When determining a student's financial need, all available resources such as family contribution, student's own earnings and savings, scholarships, veterans benefits, Social Security benefits and similar types of assistance must be considered in calculating the resources available to the student. The total of all available resources is subtracted from the cost of attending college for the year and the difference, if any, constitutes the student's need.

A student, after a strict review of his situation for need analysis purposes, may be considered independent if he has been self-supporting for a considerable period of time. In such cases, the student would not be required to include family resources.

The types of financial aid available for college students explained in Part One of this booklet are grants or scholarships that do not have to be paid back, loans that do have to be paid back, work that provides assistance through hourly earning, and benefits. The need analysis services as well as the Education Opportunity Program (EOP) are explained.

## Grants

Basic Educational Opportunity Grant (BEOG) - This federal aid plan is designed to provide a minimum level of financial assistance to every student who needs it to attend a post-secondary educational institution. Up to \$1400 may be granted per year. The amount of the grant depends on the financial resources of the student and his family. Criteria for eligibility are:

1. Financial need must be established by means of the BEOG application which is available from high schools, offices of financial aid at the college or by writing:

2. The student must have begun post-high school education after April 1, 1973.
3. The student must be enrolled in an eligible program at an eligible college, university, vocational, or technical school and must be attending full-time.
4. The student must be a U.S. citizen, or be in the U.S. for other than a temporary purpose and intend to become a permanent resident or be a permanent resident of the Trust Territories of the Pacific Islands.
5. There is no academic requirement for this grant.

Supplemental Educational Opportunity Grant (SEOG) - This federal program is for students in exceptional financial need. Attendance must be at least half-time as an undergraduate at a participating college. Up to \$1500 may be granted depending on need and cost of attending college, but must be no more than  $\frac{1}{2}$  the total assistance given to the student. No student may receive more than \$4000 over a four-year period. Applications are available at the Financial Aid Office of the prospective college. There is no academic requirement.

Law Enforcement Educational Grant - Employees of law enforcement agencies attending college either full or part-time are eligible for grants of up to \$400 per semester. Apply through the Financial Aid Office of the college.

Nursing Scholarship Grant - This is a federal program for students with exceptional financial need who have been accepted for full-time attendance at a participating college or at a school of nursing. Up to \$2000 may be granted per year depending on need. Applications are available in the Financial Aid Office of each college.

## Scholarships

Regents College Scholarship - A student must be a New York State resident and qualify by taking the Regents Scholarship Examination, a competitive exam, during the senior year in high school. The award per year is \$250. The recipient must enroll as a full-time undergraduate student in a diploma degree or certificate program.

Regents Nursing Scholarship - A New York State resident who plans to attend college or a hospital school for basic nursing studies, must qualify through an exam taken in the senior year in high school. The award per year is \$250. Applications are available from:

Regents Awards for Children of Deceased and Disabled Veterans - The student must be a New York State resident, the child of certain deceased or disabled veteran and a full-time student. The award is \$450 per year. Applications are available from:

State University Scholarship - This scholarship insures that there will be no net tuition cost for a student in a low income bracket. It is available only to students at the state operated colleges whose family net taxable income is \$2000 or less. The student must be a full-time student in a participating college. The yearly grant is the difference between the amount of the grant from the Tuition Assistance Program and the tuition charge, so the student must apply to the Tuition Assistance Program first. There is no academic requirement for this award.

Tuition Assistance Program (TAP) - All New York State residents who are in full-time attendance at accredited colleges within the state are eligible to apply for this award. The actual amount awarded is based on the amount of tuition paid and the combined family New York State net taxable income for the last tax year preceding the academic year for which the student is applying. No award may exceed the amount of tuition to be paid. Applications are available from:

## Loans

National Direct Student Loan - This loan was formerly known as the National defense Student Loan. Students with financial need and attending college at least half-time may borrow from the participating college. The maximum loan for four-years of undergraduate study is \$5000, with no more than \$2500 total for the first two-years of college. No interest accumulates while in school. Repayment of 3% interests begins 9 months after leaving school with 10 years to repay. Repayment may be deferred for services in the Armed Forces or work in the Peace Corps or as a volunteer with VISTA. Up to 100% of the loan may be cancelled for full-time teaching in certain low income districts or for teaching the handicapped. Apply through the Financial Aid Office of the college.

Nursing Student Loan - Students enrolled at least half-time at a participating college or nursing school may borrow from the school up to a maximum of \$2500 per year. No interest accumulates while in school and repayment at 3% interests begins 9 months after graduation. There are 10 years to repay. In addition, up to 85% of the loan, plus interest may be cancelled for full-time employment as a professional nurse in any public or non-profit private institution or agency. The rate of cancellation is 15% of the amount of the loan for each complete year of employment. Apply through the college or hospital school. This program is subject to legislative revision.

Law Enforcement Education Loans - Law enforcement personnel attending college on a full or half-time basis may obtain loans of up to \$2200 per year. Repayment is at 7% interests, subject to 25% cancellation of each year of full-time law employment. Repayment begins six months from the date the borrower ceases to be a full-time student. Apply through the prospective college.

New York Higher Education Services Corporation Loan - Loans of up to \$1500 for the freshmen year and \$2000 per year for the remaining years can be acquired by a student in financial need. The student borrows from a participating commercial bank with repayment and 7% interest beginning 9 months after graduation with 10 years to repay. This is for New York State residents only. Applications and information are available after June 1 for students entering in the Fall from participating banks.

## Work

College Work-Study Program - Students who meet financial need requirements established by the federal government may work an average of 15 hours per week during the regular school year and 40 hours per week when college is not in session. Students are selected on need, and wages range from \$1.75 to \$3.00 per hour. Most colleges do not recommend work-study for the academically disadvantaged student, especially during the first year. This program is available to both half and full-time students. A maximum of \$1200 may be earned per year.

## Benefits

Social Security Benefits - Children of retired, disabled or deceased workers are eligible for Social Security benefits up to the age of 22 if they are unmarried, full-time students. Apply to the local Social Security Office.

Veterans Administration Benefits - Financial aid for veterans and for the wife and children of a veteran deceased or permanently disabled from service in the Armed Forces is available usually through the regional Veteran's Administration Offices. Most colleges now have local aid for veterans and also administer special programs to aid the veterans in entering college.

## Need Analysis Services

Most colleges participate in one of the following need analysis services to determine the ability of the student and his family to meet college costs. Specific instructions will be found in the college's catalogue and financial aid literature. Applicants are advised to attend to this soon after applying for admission. The services process the forms and send financial information directly to the prospective colleges the applicant noted as recipients. The two major organizations providing need analysis services to the colleges are:

1. College Scholarship Service (CSS) - If the college uses the CSS, then the financial aid applicant must submit a copy of the Parents Confidential Statement (PCS) to the CSS. If the student is self-sufficient, then he must submit a copy of the Students Financial Statement (SFS). The guidelines that determine the self-sufficiency are detailed on the SFS instructions. The PCS or the SFS form may be obtained from a secondary school, the college's Financial Aids Office or:

2. American College Testing Program (ACTP) - If the college participates in this program, a Family Financial Statement (FFS) is submitted to the ACTP. The FFS form may be obtained from a secondary school, the college's Financial Aids Office, or:

## INTRODUCTION TO PART TWO

Forty-five of the seventy-two degree-granting institutions of the University participate in a common admission application program. These campuses follow a common set of application procedures coordinated by the Application Processing Center (APC), which receives, processes and forwards all applications to the various campuses, where individual admission decisions are made.

Those colleges that participate in the common application form are noted in Part Three of this booklet. If a SUNY application is not readily available at your high school, write to the Director of Admissions at the institution in which you are interested. The colleges that do not participate in the common application program are also noted in Part Three. For the appropriate application materials, write the college you are interested in directly.

In general, two-year colleges do not close admissions. However, because some programs such as the health-related areas, experience a high level of demand, it is recommended that students submit their applications as early as possible.

In general, four-year colleges recommend that applications be received at APC prior to January 5 for the Fall term and prior to October 15 for admission to the Winter and Spring terms.

## Admission Requirements

Admission to SUNY is based on academic promise without regard to the applicant's race, color, sex, or national origin. To enter any State University Center or College, the candidate must have a high school diploma or equivalency diploma, be in satisfactory academic standing, or have qualifications which the admitting authorities may deem equivalent. Specific courses and other qualifications may be necessary for admissions, depending upon the program. The candidate must be physically fit as evidenced by a health report submitted by a family physician on a State University Health Report in advance of registration. Generally, colleges that participate in the common application program require that all freshmen applicants submit the scores from any one of the following examinations:

1. Regents Scholarship and College Qualification Test;
2. Scholastic Aptitude Test;
3. American College Test

## College Entrance Exams

All of the campuses of the State University participating in the common application program require all freshmen applicants to submit scores from any one of the following examinations:

1. The Regents Scholarship Examination (RSE) - This is a six-hour examination offered without cost to the student. It is the sole basis for awarding regents scholarships. The RSE, however, is generally not acceptable as an admissions examination for any private college in New York State or any public or private colleges outside of New York State. 2. The Scholastic Aptitude Test (SAT) - This is a three-hour examination offered at different times during the year. The results are acceptable to most public and private colleges within and outside New York State. For more information, write to:

3. The American College Test (ACT) - It is a three-hour examination offered at different times during the year. The ACT is acceptable as an admissions examination for entrance into all units of SUNY and is required for admissions or placement purposes by some two-year colleges within the SUNY system. The results are acceptable as an admissions test to most private colleges in New York State and most public and private colleges located in the northeast. For more information, write to:

A New York State resident, who is a freshman applicant (or a SUNY transfer under the Transfer Guarantee Program) who has been rejected by every college to which he has applied, may use this service. ## College Level Credit by Examination

College Level Examination Program (CLEP) - CLEP is a testing program of the College Entrance Examination Board (CEEB). It was conceived to serve the non-traditional student who has acquired knowledge through correspondence or university extension courses, educational television, adult education programs, on-the-job training, and independent study.

These tests are of two types: General Examinations and Subject Examinations. The General Examinations are comprehensive tests in five basic areas of liberal arts, English composition, humanities, mathematics, nature sciences, and social sciences/history. The CLEP Subject Examinations are tests of achievement in college subjects; some cover material studied in a full-year course and others are limited to the content of a one-semester course.

Through these examinations, a person may gain credit or waive course requirements for successful completion of these exams at participating colleges. For further information write to:

College Proficiency Examination Program (CPEP) - The CPEP exams are administered by the New York State Board of Regents. This program enables qualified individuals to earn college credit without classroom attendance. The examinations are offered by SUNY in more than 20 subjects. The exams are administered four times a year at conveniently located testing centers throughout the state. For further information write to:

## **Educational Opportunity Program (EOP)**

EOP is a special admissions program of the State University of New York. It serves students who are both educationally and economically disadvantaged, but who do have college potential. The students receive financial assistance developmental education, tutoring and counseling aimed at achieving their admission to and completion of a degree program at a two or four-year campus. EOP is not a financial aid program for the regular student. To be eligible, all the following criteria must be met:

1. Must be a resident of New York State;
2. Must have obtained a New York State high school diploma or its equivalent;
3. Must not be qualified to be admitted to the college under the normal admission standards, but must demonstrate a reasonable degree of academic potential for satisfactory completion of a degree or certificate program determined by the college's EOP Admission Staff;
4. Must be economically disadvantaged usually as determined by the criteria established for the Higher Educational Opportunity Program administered by the New York State Education Department.

For more information on EOP write to the EOP Director at the college you are considering apply to for the specific requirements of that college's EOP program.

## The Regents External Degree Program

This is a flexible program providing an alternate route to a college degree. Credit toward these degrees may be obtained by taking regular college courses from accredited institutions of higher learning, taking proficiency examinations, taking approved military educational programs, or by special assessment of knowledge gained from experience, independent study, or other non-traditional approaches to education. Six external degrees are offered: Associate in Arts, Associate in Science, Associate in Applied Science of Nursing, Bachelor of Science in Business Administration, Bachelor of Arts, and Bachelor of Science. There are no residency requirements to enroll in the program and no high school diploma is required. The total cost of a Regents External Degree, if the study is done independently, will be the exam fees which range from \$20 to \$150 each, the enrollment fee, annual records maintenance fee, and the graduation fee. ## Educational Opportunity Centers

The EOC program is part of the State University System providing a broad range of services to the disadvantaged. The centers are tuition free. Programs in basic education, high school equivalency, developmental education for college preparation, vocational training, and counseling and referral services are offered. Each EOC is administered by a local college associated with the State University. To take part in EOC programs, a person must be 18 or older, and be unemployed or under-employed. ## INTRODUCTION TO PART THREE

The University encompasses four university centers (two of which, Buffalo and Stony Brook, include health centers); two medical centers; 14 colleges of arts and science including a non-residential college; three specialized colleges; six agricultural and technical colleges; five statutory colleges; and 38 locally-sponsored community colleges. Together, they offer students a choice of more than 3,100 academic specializations, representing more than 1,500 different degree programs.

The general admission requirements to the seventy-two different public institutions is given in Part Two of this booklet. For specific admission requirements to a particular program at a SUNY institution consult the Director of Admissions at the institution or the college catalog for detailed information.

Part One of this booklet covers the common grants, scholarships, and loans that are available at SUNY institutions. Consult the Director of Financial Aid for additional information on the grants, scholarships, and loans administered by the institution.

Students are housed in college-operated residents halls, in private homes, and, on some campuses, in fraternity and sorority houses. Since the housing accommodations vary from college to college, applicants should consult the college catalog for detailed descriptions.

The locally-sponsored community colleges do not generally have residence halls since they are operated primarily for community students.

Part One of this booklet briefly discussed the Education Opportunity Program (EOP) of the State University of New York. For specific information on the EOP program at the institution you are considering, write to the Director of EOP.

## UNIVERSITY CENTERS

The four university centers located at Albany, Binghamton, Buffalo, and Stony Brook are moderately large campuses with 10,000 to 20,000 students offering graduate and undergraduate opportunities in many disciplinary areas, as well as many programs through the doctoral degree.

## COMMUNITY COLLEGES

There are 38 community colleges. These colleges offer two-year programs that are complete in themselves or prepare the student for further study at the upper division level. The community colleges are basically commuter colleges since they are attended chiefly by students from nearby areas. Jointly operated by the State University and their local sponsors, the community colleges offer comprehensive programs, both technological and occupational, as well as liberal arts courses which may be further pursued toward the baccalaureate degree.

The admissions standards are flexible; most community colleges have open door admissions and are called Full-Opportunity Colleges. If an applicant does not have the proper background for admission into a certain curriculum, he is usually accepted into the college at large. Admission is open to those without a high school diploma, and in accordance with State Education requirements, a person is eligible for an equivalency diploma after successful completion of 24 credits at the college.

All community colleges are required by New York State law to have every student who is a New York State resident file a Certificate of Residence with the college each academic year. New York State Education Law defines a New York State resident as a person who has resided in the State for a period of at least one year and in the county for a period of at least six months, both immediately preceding the date of such person's registration in a community college, or his application for a Certificate of Residence. Applications are available from the college (usually the Admissions or Financial Aid Office) or from the County Treasurer's Office. Students who fail to submit a Certificate of Residence would be required to pay the out-of-state tuition, which is usually double the amount of the New York State resident.
