

The AGRIS Coordinating Centre (ACC) is responsible for a coherent and dynamic operation of the system. AGRIS provides comprehensive bibliographic coverage of world agricultural literature. ACC receives, organizes, and processes the national bibliographic citations prepared by the participating centres and makes the integrated total data base available to them in two formats: (1) printed bibliography and (2) magnetic tape.

It maintains a broad network of national and international contacts, which derive from its approximately 1,200 contributing members, its Board of Directors, its Council of Organizations, and its status as the U.S. affiliate of Rehabilitation International, the only international organization concerned with all the world's handicapped, with affiliates in more than 70 countries. As the U.S. affiliate of Rehabilitation International, Rehabilitation International U.S.A. represents the United States rehabilitation community in international

rehabilitation meetings and conferences, as well as Rehabilitation International's own quadrennial World Congress.
