ABSTRACT

This compendium provides a guide to data collections in higher education focusing on sources that are national in scope, and updated and made available on a regular or periodic basis including surveys, data bases, reports, and statistical digests. These sources are divided into nine broad categories, each category contains separate entries for each data source and each entry provides a brief description of the source, lists or outlines the major data collected or reported, provides information on data availability, lists current uses and publications and provides the source or contact. The nine categories are: (1) Institutional Descriptors; (2) Student Data; (3) Student Longitudinal Data; (4) Student Financial Aid; (5) Financial Data; (6) Tuition and Fee Charges; (7) Faculty, Staffing and Salaries; (8) Physical Facilities, Libraries and Assets; (9) Sourcebooks and Comparative Studies. An appendix contains a blank form for reporting data sources to be included in the compendium or for making changes in sources already listed. (JB)

Appendix

Introduction

What do we know about higher education institutions? What are the needs and characteristics of postsecondary student populations? How are institutions financed and how do they use their financial resources? What sources of student aid are available?

There are multiple sources for such data, and the different types and sources of information on higher education have never been more important. They provide the resources by which we inform the public about educational opportunities and services and from which we analyze the strengths and weaknesses of different policies and programs. Using these data sources we attempt to improve resource management and encourage foundation, business and corporate leaders to invest in research, pilot initiatives and other studies.

Data collections on higher education come in many shapes and sizes. Some are national in scope and compile data from a broad universe of participants from across the country. For example, the U.S. Department of Education through the Integrated Postsecondary Education Data System (IPEDS) conducts annual surveys of all postsecondary institutions in the nation. These surveys cover a number of topics, including student enrollment and program completions, institutional characteristics, faculty salaries and institutional finance. Other data bases provide information from surveys of representative samples of institutions, students or faculty nationwide. Such national surveys produce very large data bases, even when the types of data and the nature of the information sought are carefully and narrowly defined. Both dimensions are important — that is, the multiplicity of potential sources and the specificity of data within each source.

The SHEEO *Compendium of National Data Sources on Higher Education* pulls together and provides a guide to these varied collections under one cover. It identifies surveys and data bases, as well as reports, statistical digests and other means for making data available. This compendium replaces a 1986 SHEEO publication called *Comparative Data About Higher Education*, updating and substantially expanding the earlier directory to take into account changing data resources and new information needs. It attempts to be as current and comprehensive as possible, while recognizing that the sources of data are rapidly expanding and that the data require regular updates. This compendium is issued in loose-leaf format to facilitate annual additions of new data sources and revisions of existing ones. To keep the compendium current, the appendix provides a shell entry to enable data providers and users to submit changes and additions, which SHEEO will periodically make available to compendium users.

The SHEEO compendium focuses on sources of data that are national in scope, updated and made available on a regular or periodic basis, and intended primarily for policy analysis and development. These criteria encompass many types and uses of data. Some sources are collections of information about institutions (addresses, accreditation, types of programs and degrees), which are compiled and organized as data bases. Other sources are summary statistics drawn from institutional administrative records — data on enrollments, degrees granted, staffing, salaries, revenues and expenditures. These are useful primarily for summary reports and comparative analyses. The data gathered from individual respondents are frequently used for cross-sectional (one point in time), time series, or longitudinal analyses depending upon the design of the population sample and the survey instrument.

The data sources in this compendium are divided into nine broad categories in order to facilitate the identification and use of the multiple sources of data of similar types and subject areas. Each category contains separate entries for each data source. Each separate entry provides a brief description of the source, lists or outlines the major data collected or reported, provides information on data availability, lists current uses and publications and provides the source or contact. The nine categories of data types and sources are as follows:

1. **Institutional Descriptors** — Basic directory-type data that can be used to describe and categorize postsecondary institutions. The types of data collected by the surveys and reported in numerous directories include the names and addresses of institutions, accreditation, calendar systems, types of degrees awarded, enrollment levels and tuition and fees charged.
2. **Student Data** — Encompasses numerous sources of primarily cross-sectional data on the student populations who are entering, enrolled in or completing postsecondary education. These sources provide a broad range of data on student demography and characteristics (including the preparation for college-level work of high school students based on such indicators as ACT scores, advanced placement exam scores and grade point averages), postsecondary enrollment and completion rates, indicators of student attitudes and values, and the socioeconomic characteristics of the population in relation to educational attainment. The sources of data identified in this section include census data, annual surveys, the National Assessment of Educational Progress (NAEP) and a number of other data collection programs from national education associations and institutions.
3. **Student Longitudinal Data** — Specialized sources that provide data on individual students or groups of students over time, derived from repeated or followup surveys of the same individuals. These include national studies such as the National Longitudinal Study of 1972 (NLS-72), High School and Beyond (HS&B), the National Education Longitudinal Study of 1988 (NELS 88) and the Recent College Graduate Study (RCG). Some longitudinal data and analysis can also be derived from data sources that are primarily cross-sectional in nature; these are listed under other categories.
4. **Student Financial Aid** — Includes survey data and reports that identify, describe and in some cases analyze the major sources of financial aid support to students, including federal government programs, state-funded programs, institutional aid and student/family contributions. Additional student aid data may also be derived from sources listed in other categories (e.g., from student longitudinal data bases and institution finance surveys).
5. **Financial Data** — Encompasses the many and diverse sources of data related to institutional revenues and operations. Includes sources of data on general institutional financing, state appropriations to higher education, comparative financial statistics, indices that reflect general price changes and cost-of-living differences, and income from voluntary contributions and endowment.
6. **Tuition and Fee Charges** — A special category of financial data that includes several sources for tuition and fee rates, tuition policies and comparative studies of student charges.

7. **Faculty, Staffing and Salaries** — Provides a number of sources of data on the size of the postsecondary labor force; tenure status of the postsecondary faculty; salaries and benefits of administrators, faculty and staff; and other information related to the postsecondary personnel. The data are drawn from national surveys by the National Center for Education Statistics (NCES), the U.S. Bureau of the Census, the Equal Employment Opportunity Commission (EEOC), the American Association of University Professors (AAUP), College and University Personnel Association (CUPA) and others.

Note that this section does not include data sources from the periodic faculty surveys undertaken as part of specific research projects, such as those sponsored by the Carnegie Endowment for the Advancement of Teaching, the American Council on Education and other organizations. A good source for information on these surveys and data bases is the Clearinghouse for Research on Faculty, jointly sponsored by the University of Nebraska-Lincoln and the University of Virginia.*

8. **Physical Facilities, Libraries and Assets** — Includes the limited sources of national data on higher education physical facilities, science and engineering research facilities surveys, surveys conducted by academic library associations and other sources. These sources are quite limited since the last comprehensive national survey of higher education physical facilities was completed in 1973 as part of the Higher Education General Information Survey (HEGIS). Many state coordinating and governing boards maintain physical facilities data systems and are a better source for such data. Most institutions also maintain detailed facility inventory systems.
9. **Sourcebooks and Comparative Studies** — Includes statistical digests, reports containing comparative data or combining data from several sources, computerized data base systems and other sources. Often it is useful to turn to these sources first for summary data before consulting the more specialized and detailed data sources listed in other categories.

A complete listing of the individual data source entries by category is provided in the Table of Contents. To locate a specific survey or source, consult this listing for the appropriate section and page numbers. No alphabetized index of surveys or subject areas is provided, due to the multiplicity of sources and the fact that several types of data or subject areas may be incorporated into the same survey or report. Cross-referencing has been kept to a minimum, although it is expected that users will see the numerous connections to be made across the separate entries. Data uses and publications have also been kept to a minimum, and are intended to be illustrative rather than comprehensive.

This compendium simplifies and is less than comprehensive in many respects. We hope, however, that it is a useful resource, and that it will continue to evolve, be updated, and become more complete on the basis of wide use and the input of users.

DATA SOURCE/TITLE: Current Population Reports — School Enrollment

DESCRIPTION: The U.S. Bureau of the Census conducts a monthly survey called Current Population Survey (CPS). The survey mainly deals with labor force data for the civilian noninstitutional population. However, in the October CPS, supplementary questions are included about school enrollment for all eligible household members 3 years old and older. These school enrollment data are published in the Current Population Reports series, P-20 and P-23. The latest report, released in April 1990 is called *School Enrollment — Social and Economic Characteristics of Students: October 1988 and 1987*. This report includes data on enrollment in nursery school through high school, and college and professional school. The data are disaggregated by personal characteristics such as age, sex, race, Hispanic origin, marital status, family status, family income, education of householder, labor force status, metropolitan residence, region, and mother's labor force status and education (for preprimary enrollment). The report also contains data on the level and grade of school, public/private school, full-time attendance status, and two-year/four-year college. Vocational school enrollment is presented separately. The most current CPS sample was selected from the 1980 Decennial Census files with coverage in all 50 states and the District of Columbia, drawn from 729 areas comprising 1,973 counties, independent cities, and minor civil divisions. About 56,100 occupied housing units are eligible for interview every month.

DATA SOURCE/TITLE: 1990 Census Tabulation and Publication Program

DESCRIPTION: The Census Tabulation and Publication Program is the structure by which the U.S. Bureau of the Census will disseminate 1990 decennial census data. The Census Bureau will release the results of the 1990 census to the public beginning in 1991 and continuing through 1993. In mid-1991, after the release of the redistricting data, the Census Bureau will begin to issue products showing the basic demographic and housing characteristics for block, block groups, census tracts, places, minor civil divisions, counties, states, the United States, American Indian Areas (e.g., reservations), and statistical areas such as MSAs. In early 1992 the sample data products will begin to be issued. These include social, economic, and detailed housing information for many of the areas listed above. Data for the states will be produced for a particular product, followed by data for the United States.

- *Subject Reports and Summary Tape Files*: Forty population and housing subject reports will be prepared from the 1990 census and released in 1993. Population reports will cover such topics as migration, education, occupation and industry, journey to work, income and poverty status. In addition, reports will be prepared showing data on subgroups of the population such as racial and ethnic groups and older population.

III. Student Longitudinal Data

DATA SOURCE/TITLE: High School and Beyond (HS&B)

DESCRIPTION: High School and Beyond (HS&B) is the second longitudinal study conducted by the National Center for Education Statistics. It begins with high school students and follows them after graduation to postsecondary education and work. The base year sample survey was conducted in 1980 and collected data from over 58,000 students (30,000 seniors and 28,000 sophomores) from over 1,000 public and private high schools from across the country. Base-year and followup surveys collected data on students, their parents, the schools attended, and observations from teachers.

DATA COLLECTED/REPORTED: The student questionnaire examined such areas as school experiences, test scores, school performance, and future educational plan and occupational goals. The school questionnaire provided information on enrollment, staff, educational programs, dropout rates and special programs for the handicapped and disadvantaged students. The parent survey studied family attitudes, family income, parent occupation and employment, financial planning and how these affect student aspirations for postsecondary education. The teacher checklist provided teacher observations of students in and out of the classroom. The followup questions reflect areas such as work experience, postsecondary education experience and job satisfaction.

DATA COLLECTION CYCLE: The base year of data collection was 1980. Followup surveys of subsets of both sample cohorts (sophomores and seniors) were conducted at two-year intervals in 1982, 1984 and 1986. Another follow-up is planned for 1992.

DATA AVAILABILITY: The Student Survey data files are available for \$175 (BPI 6250) and \$225 (BPI 1600). The cost for the supplementary files are \$175 for the first file, however, if ordered with student files the cost is \$75; each additional file is \$75. DATA SOURCE/TITLE: National Education Longitudinal Study of 1988 (NELS 88)

DESCRIPTION: The National Educational Longitudinal Study of 1988 is the third major longitudinal study sponsored by the National Center for Education Statistics which follows eighth graders through postsecondary education. It is comparable to the two studies preceding it — The National Longitudinal Study of 1972 and High School and Beyond — which surveyed high school seniors and sophomores through high school, postsecondary education and work and family formation experiences. In the 1988 base year, the study surveyed eighth grade students, their parents, teachers and school principals from a sample of 26,000 students from 1,000 public and private schools. Followup surveys are scheduled in two-year intervals and will reflect academic growth, student study habits, performance, and instructional practices. The first followup survey was conducted in 1990. The third, scheduled for 1992, will provide information on postsecondary education persistence, transfer and withdrawals; student characteristics; student financial aid; academic performance data; and labor force participation. The study is designed to provide trend data about critical transitions experienced by young people as they develop, attend school and embark on their careers.

DATA SOURCE/TITLE: Recent College Graduates Study (RCG)

DESCRIPTION: The Recent College Graduates Study (RCG) is a periodic national survey to collect data on potential teachers. The focus is the immediate post-degree employment and education experiences of persons who earned a bachelor's or master's degree from an American college or university during the previous academic year (July to June), with a heavy emphasis on those graduates qualified to teach at the elementary or secondary levels. The study is drawn from a sample of graduates of degree-granting institutions — both public and private — that award a significant number of degrees in education (at least 100 of the bachelor's degrees granted were in education or at least half of the bachelor's and master's degrees granted were in education). The objectives for the RCG study are threefold: first, to determine how many graduates become eligible or qualified to teach for the first time, and how many were employed as teachers in the year following graduation, by selected field of specialization. The second is to obtain information regarding types and patterns of courses taken by major field of study and third, to examine the relationship between courses taken, student achievement and occupational outcomes. The survey has been conducted since 1976. It was last conducted in 1987; the next survey is scheduled for 1991.

DESCRIPTION: This is a new study conducted by the National Center for Education Statistics (NCES) that will collect data on student persistence, progress and attainment from initial entry into postsecondary education through leaving and entry into the work force. For vocational students and those who enter the work force without a bachelor's degree, BPS will also address rate of return. DESCRIPTION: NPSAS is a congressionally-mandated nationwide study of how students and their families pay for postsecondary education. It was initiated in 1987 by the National Center for Education Statistics. Every third year, NPSAS surveys nationally represented samples of undergraduates, graduates and first professional students across all postsecondary sectors. For comparative purposes, the stratified samples include students who do not receive financial aid as well as those who do, and a sample of their parents. In addition to data related to student financing of their education, NPSAS compiles extensive demographic and descriptive data on postsecondary students.
