## ABSTRACT

This catalog of products from the Data Archive on Adolescent Pregnancy and Pregnancy Prevention (DAAPPP) contains a list of DAAPPP social science Data Sets on topics related to teenage pregnancy and family planning. Each Data Set listing contains the following information: (1) name of study or program; (2) name of investigator or sponsoring agency; (3) description of study or program; and (4) price of available materials. Each Data Set is for sale and comes with a raw data file, a separate SPSS program statement file, and a user's guide. The archive provides easy access to a large-scale database on sexuality, health, and adolescence. Section 1 is an introduction to DAAPPP. Section 2 lists the members of the DAAPPP advisory panel. Section 3 contains the following lists of Data Sets: (1) "Comprehensive Archive and Related Products"; (2) "Index of Data Sets by Original Investigator"; and (3) "Index of Data Sets by Key Word." Section 4 contains a listing of the National Archive on Sexuality, Health and Adolescence (NATASHA), which is the CD-ROM version of the DAAPPP. Section 5 contains a list of special products related to teen pregnancy. Section 6 contains a list of products related to health promotion. Section 7 contains an order form. (JS)

## **DATA ARCHIVE ON ADOLESCENT PREGNANCY AND PREGNANCY PREVENTION**

The Data Archive on Adolescent Pregnancy and Pregnancy Prevention (DAAPPP) is a collection of social science Data Sets on topics related to teenage pregnancy and family planning. Through DAAPPP, researchers, practitioners, administrators, and policy makers have easy access to a large-scale data base on sexuality, health, and adolescence. Data Sets were selected for the Archive by a national panel of experts, appointed by the U.S. Office of Population Affairs.

The data have been systematically processed in standard ways to facilitate their use. Each Data Set is assigned a Number according to the order in which it was deposited in the Archive, with Data Set Numbers running from 01 to 99, A1 to A9, B1 to B9, etc. Data Sets with a large number of variables, and successive waves of a single longitudinal study, are often assigned multiple Numbers. Most Data Sets come in two versions: mainframe and microcomputer. For the majority of Data Sets, the two versions are virtually identical. For some, a randomly selected extract of approximately 1,000 cases was selected for the microcomputer version because of general microcomputer space limitations. For a few, a microcomputer version was not created because even a 1,000-case extract would have exceeded normal microcomputer space limitations.

Each Data Set in DAAPPP comes with a raw data file and a separate SPSS program statement file. (SPSS/PC+ software is available from DAAPPP.) SPSS, a powerful and comprehensive program for analyzing data, will use these program statements to assign each variable name to the correct record and column position in the data file, and assign 40-character variable labels which identify the meaning of each variable in English words. SPSS programs also provide 20-character value labels (response option descriptions) for many variables. Users with access to one or more versions of SPSS (SPSS, SPSS<sup>x</sup>, SPSS/PC, SPSS/PC+) will be able to use the statements provided to create SPSS system files. Other users can modify these statements according to the syntax of their alternative statistical packages; the SPSS programs function as machine-readable codebooks.

Each variable in each Data Set is given a unique 8-character name, according to precise Archive conventions. The first two characters of each name are a 2-letter string which codes the variable topic, from a list of 38 topics. The third character of each variable's 8-character name codes the variable type, from a list of 16 types. The fourth and fifth characters of each variable's name code the Data Set Number. The sixth through eighth characters of each variable's name code the variable's ordinal position within the Data Set.

Because the SPSS programs classify all variables according to topic and type, and provide variable and value labels, they provide excellent documentation of the data. Additionally, a printed *User's Guide* is provided with each Data Set. The *User's Guide* includes a descriptive overview of the Data Set; frequencies for 19 key variables, as available in the Data Set; a list of variables sorted by topic and type; a report on the data's completeness and consistency; and often photocopies of original instruments or codebooks, which are also available separately.

## **Product Specifications**

### **Mainframe Tape:**

Mainframe computer tapes include: (1) raw data, (2) SPSS program statements (SPSS for Data Sets 01 through 19, SPSS<sup>x</sup> for Data Sets 20-24 onward), (3) a complete list of variable and value definitions, and (4) frequencies and/or other descriptive statistics for virtually every variable in the Data Set. Tapes are 9-track; 6250 or 1600 bpi; EBCDIC or ASCII; IBM Standard labelled, ANSI labelled, or unlabelled. Prices are \$75 for the first Data Set and \$25 for each additional Data Set in the same order. (Quantity discount may not be available at 1600 bpi.)

### **Floppy Diskette:**

Floppy diskettes include: (1) raw data and (2) SPSS/PC program statements for use with either SPSS/PC or SPSS/PC + . For some very large Data Sets, the microcomputer version consists of an extract of approximately 1,000 cases from the mainframe computer version of the Data Set. This is noted in the individual Data Set descriptions. Floppy diskettes are available in either regular density (IBM/PC 5.25"; 360KB) or high density (IBM/AT 5.25"; 1.2MB). Prices are \$75 for the first Data Set and \$25 for each additional Data Set in the same order.

### **Bernoulli Box Cartridge:**

Microcomputer versions of Data Sets can be transmitted via Bernoulli Box cartridges upon request. Cartridges are 8.5"; 20MB. Contact Sociometrics Corporation for prices.

### **CD-ROM:**

Data Sets 01 through B1 are available on a single microcomputer CD-ROM (compact disk read-only memory). The product is called NATASHA: National Archive of Sexuality, Health & Adolescence, and is available for \$495. Both the mainframe and microcomputer versions of the raw data and accompanying SPSS program statements are included in NATASHA. Users with a large enough hard disk on their microcom-

puters may elect to use the complete, mainframe version of the Data Set if the microcomputer version is a case extract.

**Printed Documentation:**

*User's Guides* are printed booklets prepared by DAAPPP staff describing each Data Set and facilitating its use. They are included in the purchase price of mainframe tape, floppy diskette, or Bernoulli cartridge orders; they can also be purchased separately for \$8 each. The guides are included in microfiche format in NATASHA, the CD-ROM version of the Archive. Paper photocopies of original instruments and codebooks are available for many Data Sets at \$0.15 per page.

## **DAAPPP DATA SETS**

**DAAPPP Data Set No. 01****1971 U.S. National Survey of Young Women: Selected Variables***Melvin Zelnik and John Kantner*

This study was aimed at documenting the sexual behavior and practices of adolescent females in the U.S. Two national probability samples were drawn, one of females aged 15 to 19 living in households in the continental U.S. in 1971, and one of university students living in dorms. A total of 4,611 women participated in the study. Data were collected primarily through in-person interviews, with questions presumed to be more sensitive asked in a self-administered questionnaire. Information was obtained regarding frequency of sexual behavior, contraceptive use, pregnancy, childbearing, and abortion, as well as basic background information (e.g., marital status, religion, education, employment status, family structure and family socioeconomic status). DAAPPP Data Set No. B8 includes all 516 variables from the original study.

This study was similar in purpose, scope, and content to the above described 1971 National Survey of Young Women. The total sample size was 2,193, reflecting adjusted completion rates of 76.2% for whites and 78.5% for blacks. Data were obtained entirely through in-person interviews, conducted in the spring and early summer of 1976.

**DAAPPP Data Set No. 03****Project TALENT: Consequences of Adolescent Childbearing for the Young Parents' Future Life, 1960-1974***J. J. Card*

This study investigated the educational, occupational, and family-related consequences of adolescent pregnancy and childbearing for young women and men who were in the ninth grade in the U.S. in 1960. The study utilized data for a subset of 7,656 individuals (1,883 blacks and 5,773 whites) who had participated in a large-scale educational research study called Project TALENT. Data available include demographic background, cognitive characteristics, and social-psychological characteristics as measured in ninth grade; educational, marital, and childbearing histories through age 29; and plans and expectations at age 29 regarding future childbearing.

**DAAPPP Data Set No. 04****Detroit Mother-Daughter  
Communication Patterns: Mother File,  
1978***Greer Fox*

This study examined patterns of communication between mothers and daughters about sex roles and sexual behavior and assessed the impact of varying communication patterns on the sexual and contraceptive knowledge and behaviors of daughters. The study sample consisted of 449 mothers of 14- or 15-year old daughters enrolled in the Detroit public schools; the daughters constituted a separate sample. A total of 1,935 mother-daughter pairs were invited to participate in the study; 449 (or 23%) accepted. Data were collected via in-person interviews and included, in addition to the topics noted above, mothers' marital and childbearing histories, knowledge about contraception, childrearing attitudes and behaviors, attitudes and knowledge regarding daughters' social and sexual behavior, sex-role attitudes, and aspirations for daughter.

This study examined the consequences of adolescent childbearing for mothers and for their children. The study sample included 2,178 Philadelphia women, primarily black, who were age 25 or younger at the birth of their first child. Data were obtained through interviews and medical examinations, and cover the socioeconomic circumstances of the mother during pregnancy and seven years later, as well as the intellectual and behavioral status of the child at birth and at ages 3 months, 4 years, and 7 years.

**DAAPPP Data Set No. 07****Nashville General Hospital  
Comprehensive Child Care Project,  
1974-1976: Selected Variables***Howard Sandler*

This study examined the child-rearing attitudes, perceptions of infant temperament, and mother-infant interactional behavior of primiparous adolescent mothers in comparison to mothers having their first infant post-adolescence. The newborn behavior of the infants was also examined. Data were obtained from the medical records of the mothers; from measures of maternal attitudes, maternal perceptions of infant temperament, and infant behavioral characteristics; and from an observational system. Data from the observational system were not included in the file archived for public use because they were available for only one-sixth of the sample and because they had already been subjected to detailed analysis by the principal investigators.

**DAAPPP Data Set No. 08****State Policy Determinants of Teenage  
Childbearing, 1979***Kristin Moore*

This study was designed to identify and catalog state governmental policies that affect the teenage mother and to describe how those policies may influence teenage childbearing. The policies examined included: Aid to Families with Dependent Children (AFDC), prenatal care programs, Medicaid, food stamps, family planning services, age of consent laws, abortion services, and alternatives to childbearing. The outcomes of interest included

teenage marriage, pregnancy, childbearing, and abortion rates. Two sets of analyses were carried out in the original study--one focusing on the individual teenage female as the unit of analysis, and the other focusing on the incidence of teenage childbearing within each state or SMSA as a whole. However, only the state-level data are included in the file. The sample thus consists of each of the 50 states plus the District of Columbia and the U.S. as a whole.

The CPS, which is conducted monthly by the Bureau of the Census, provides estimates of employment, unemployment, and other demographic statistics. The

supplement provided information on up to three marriages and on the birthdates and sex of up to five children, as well as the total number of children, expectations for more children, and selected characteristics of the current spouse. The CPS sample consists of individuals living in the 50 states and the District of Columbia. This extract file contains data for 71,407 women aged 14 or older. Data include selected demographic and occupational information from the CPS as well as the data from the marital and fertility history supplement. The microcomputer version of the raw data is an extract of 1,006 cases.

The June 1982 supplementary survey on marital and fertility history and child-care practices conducted in conjunction with the Current Population Survey (CPS) collected information from a sample of 64,842 women, representative of the U.S. as a whole, from the 50 states and the District of Columbia. The CPS, which is conducted monthly by the Bureau of the Census, provides estimates of employment, unemployment, and other demographic statistics. In the supplement, women 18-59 who had ever been married were asked questions concerning the total number of their liveborn children, the birth dates of the oldest and youngest children, and the date of their first marriage. Women 18-34 were also asked about birth expectations for the future. Information

about arrangements for child-care for children under the age of 5 was obtained from women who were currently employed, and education and employment information for current spouses was also obtained. The microcomputer version of the raw data is an extract of 1,013 cases.

These questions obtained information about their marital and fertility histories, including total number of liveborn children, birth dates of youngest and oldest children, and details of child-care arrangements for those who worked. The study contains information for 61,847 women from the 50 states and the District of Columbia, from households selected to be representative of the U.S. as a whole. All respondents were residents of Baltimore, Maryland in January 1984, received Aid to Families with Dependent Children (AFDC), were known to have at least one natural child 12 or under, and were not living with a legally wedded spouse. Respondents comprised three groups: 118 women with one or more physically abused children, 119 women who were known to personally neglect one or more children, and 281 women who were not known to have any children who met study criteria for abuse or neglect.

The interview included 1,372 closed-end items and took approximately 90 minutes to complete. Topics covered included growing-up experiences, problems with depression and substance abuse, employment aspirations, marital and courtship violence, self-esteem, reproductive history, family planning behaviors, and demographic characteristics. Items were taken from the National Survey of Family Growth, Cycle III (DAAPPP Data Set Nos. 26 and 27), the 1979 National Survey of Young Men and Young Women (DAAPPP Data Set Nos. 44 and 45), and the National Survey of Unmarried Young

Women (DAAPPP Data Set No. D5-D7). Also included were the Beck Depression Inventory, the Rosenberg self-esteem measures, the Michigan Profile of Parenting, the Conflict Tactics Scale, and a series of questions regarding mental health problems and social relationships from the NIMH Diagnostic Interview Schedule. The resulting data file has 518 cases and 1,404 variables.

## **NATASHA**

### **National Archive on Sexuality, Health & Adolescence**

NATASHA is the CD-ROM version of the Data Archive on Adolescent Pregnancy and Pregnancy Prevention (DAAPPP) and represents DAAPPP holdings as of 31 December 1987 (Data Sets Nos. 01 through B1). Both the mainframe and microcomputer versions of the Archive are included in NATASHA. For each study, a User's Guide describing the study's research design and contents has been prepared. The complete guides are included in NATASHA in the form of microfiche; the most salient portions of the guide are accessible from the CD-ROM.

The NATASHA product includes a CD-ROM containing original ASCII data from 82 studies, a floppy diskette with search and retrieval software, microfiche of User's Guides for each study, and a comprehensive User's Manual for the whole product. For each study, the CD-ROM also contains machine-readable documentation in the form of a program file which can be read by SPSS. When used with SPSS, this program will define all variables and values and create an SPSS system file. For most studies, these files are available in both mainframe and microcomputer form; there are 82 mainframe data files, 82 mainframe SPSS or SPSS<sup>x</sup> program files, 74 microcomputer data files, and 74 SPSS/PC program files (also readable by SPSS/PC + ).

**Variable Search.** Each of NATASHA's 39,815 variables is uniquely identified and searchable by topic, type, study, word in its variable descriptor label, or logical combination thereof. Results from a variable search can be written to a file or printed; the summaries for the studies in which the variables are found can be accessed directly for further information.

**Study Summaries.** Summaries include title; principal investigator; number of variables; number of cases, including coverage of gender, race, and age; names of data and SPSS program files; identification of which variables most closely correspond to 20 important "key characteristics" in a Key Characteristics Menu; and abstract.

**Crosstabulation.** NATASHA can provide the user with a crosstabulation of frequencies for virtually any pair of variables within the microcomputer version of a study.

**File Transfers.** NATASHA includes software to transfer microcomputer versions of data and SPSS/PC files from the CD-ROM to disk for analysis. Mainframe versions of these files can be uploaded to a mainframe computer via the user's communication software.

**Sophisticated Statistical Analysis.** Sophisticated statistical analyses are available to users of SPSS. Users of other statistical packages (such as SAS, BMDP, SYSTAT) can modify NATASHA's SPSS program statements to suit the syntax of their package. The modified program can read the ASCII data file from the CD-ROM.

**Requirements.** NATASHA requires an IBM-PC/XT/AT or compatible microcomputer with at least 640K RAM, a hard disk, DOS 3.1 or higher, and a CD-ROM drive. **Components of Effective Fertility

The Components of Effective Fertility Regulation is a study of 1,303 women aged 14 to 46, each interviewed 5 times over a period of 20 months. At intake, all respondents were starting, restarting, or continuing to use either oral contraceptives or the diaphragm. Enrollment began in April 1982 and ended in April 1983, with final data collected in late 1984. The investigation was conducted by Donald W. Helbig, MD, MPH, with a grant from the Demographic & Behavioral Sciences Branch of the Center for Population Research, NICHD.

The study is a longitudinal, prospective investigation of correlational factors which may be predictive of correct, continuous, and effective fertility regulation. The data come in 378 files, including raw data and SPSS program statements. The product includes three 20-megabyte Bernoulli cartridges (or approximately 60 high-density floppy diskettes), and four volumes of supporting documentation.

The Data Set was originally approved by the National Advisory Panel for inclusion in DAAPPP. However, the tremendous size of the Data Set, and Dr. Helbig's extensive documentation of the data, prompted the Panel to recommend that the data be

made available without standard DAAPPP processing and documentation. Dr. Helbig offers technical assistance "within generous limits."

**Inventory and Assessment of Data

This paper presents an overview of fertility-related data sources dealing with young male sexuality, contraception, and fatherhood. Not surprisingly, most

work in the area has focused exclusively on females. Only ten of the 85 data sources in the Data Archive on Adolescent Pregnancy and Pregnancy Prevention (DAAPPP) at the time this paper was written (Data Sets 01 through 85) were found to have data from young males. Seven of these data sources were national in scope; three were limited to one geographic area of the country (one Data Set on black teens in Philadelphia, and two Data Sets on college-age students and non-students in Madison, Wisconsin). The available Data Sets focused on sexual attitudes and behavior, contraceptive use, education, and occupation. There was virtually no attention to *out-of-wedlock* parenting per se.

The Data Sets can be analyzed further to shed light on the antecedents and consequences of male fertility-related behavior. This paper has included a description of how DAAPPP's products have been designed to facilitate such secondary analysis.

The Appendix contains a Key Characteristic Report; a matrix showing the Distribution of the Data Set's Contents (Variables) by topic and type; and a List of Variables Included, sorted by topic and, within topic, by type for each data source referenced in the paper.
