ABSTRACT

This unannotated bibliography features 99 listings of books and articles on, among other topics, language, linguistics, conversation, and gender, all written by the influential sociolinguist, Deborah Tannen. It also offers 10 listings of works co-authored or co-edited by Tannen. Although the bibliography focuses on written works published in English, some of the citations refer to videotapes and audiotapes, as well as to translated materials.
