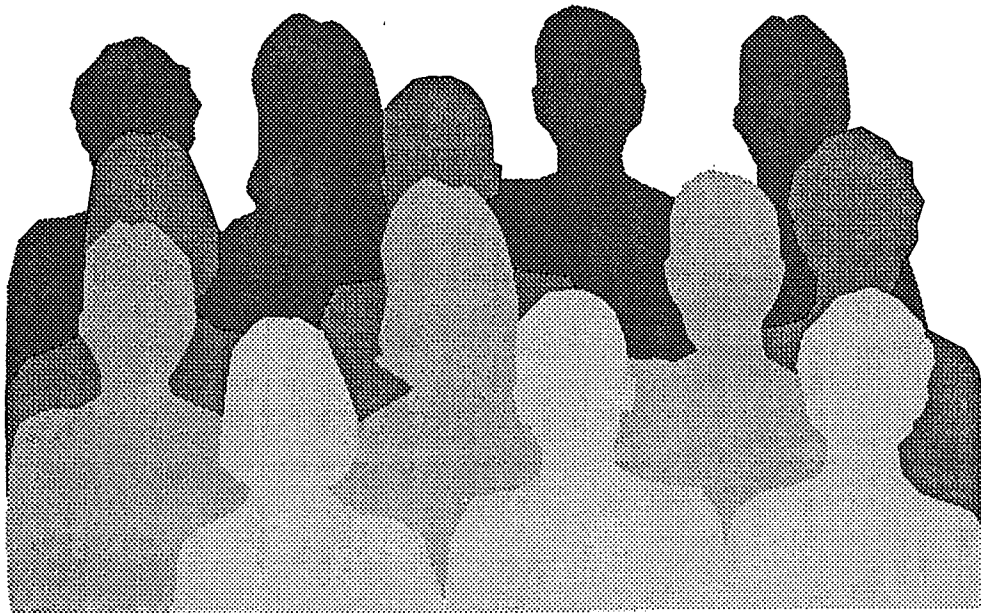

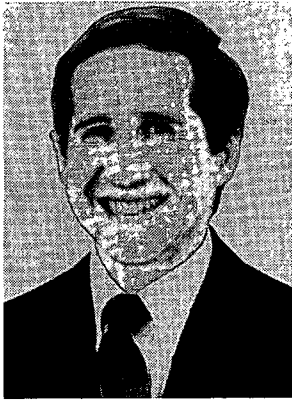

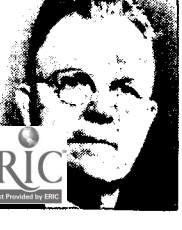

## IN REVIEW

Everyone is some kind of creator. To discover more ACES history, you were invited to experience this revelation of binocular historical vision through **PASSING TRADITION**. With the conclusion of President Samuel T. Gladding's administration, 51 leaders of ACES were responsible with other association members for growing a profession, showing how it was done, and evolving a history which they helped make and became a part of. The 1996-97 president-elect, Margaret Loomis Fong, number 52 among the elected leaders, also is included in **PT**. The tradition of choosing leadership to help direct ACES has prevailed since pre-World War II, when the genesis organization of ACES was founded. **PT**, my sequel to **PRESIDENTIAL REVIEW: ACES Leaders Create Ties, 1940-77 (1977)**, recorded the tradition of recognizing our elected leaders.

**PT** presented a pictorial directory, i.e., miniature portraits of the ACES presidents, all complemented by brief biographical sketches--profiles consisting of professional information at the time each was president, in addition to other officials of ACES, and very personal information about each president's family of origin and educational background. The biographical entries revealed a veritable who was/is who among the ACES leadership during the association's 57 years of existence to the present.

A storied past history done right presents essences to us. Something remains even though many of the ACES leaders retired, died, or simply have become a distant memory, if not gone and forgotten entirely. They served their terms, then stepped aside to permit others to replace them. In **PT**, the leaders made information about their lives available for other professionals to learn about and, perhaps, give back to them through preserving some of their traditions and offering different issues to members to help form a future past of ACES. We have come from where we were as an association, remembering the past but not living there.

A continuous transformation of ACES has been in progress, not always obvious because developments often occurred slowly. The ACES partnership within the parent American Counseling Association (ACA) has continued, an indication of a reliable professional group who cared much about its history and cared more that its mission and image would become aware to the membership and to education and general public audiences.

**Background:** The first of two predecessor organizations of ACES was formed in 1940 as the National Association of Guidance Supervisors, "affectionately" known as NAGS. Harry A. Jager, appointed Chief (August 1, 1938), Occupational Information and Guidance Service, Vocational Division, U.S. Office of Education, met with state guidance supervisors in different sections of the United States at his call with financial support. The five regions of ACES had their origins with that predecessor group. Jager believed the state supervisors needed an official organization to share experiences and discuss common problems. There were less than 10 supervisors among the small but influential group who organized NAGS.

On the national scene from 1934-40, the American Council of Guidance and Personnel Associations functioned as a confederation of guidance-related associations. CGPA functioned without the word "American" from 1940 until 1952, when a lack of unity among the groups finally led to dissolution. NAGS held affiliate membership in CGPA from 1949 until 1952.

With "counselor trainers" added as **regular** members in 1952, the membership of the new NAGSCT increased to over 100 which enabled the group to meet minimal "division" status requirements to join with three other former CGPA groups to organize and charter the American Personnel and Guidance Association (APGA). Those four divisions of APGA were the American College Personnel Association (now an independent association), NAGSCT (now ACES), National Vocational Guidance Association (the major contributor to the formation of APGA),

Our professional association faces the same challenge of any system; growth brings demands to both integrate and differentiate at the same time. Currently in the differentiation of specialties, many forces pull us apart as an overall profession. To survive, ACA has to help keep all counselors integrated, unified as a whole, while allowing room for differentiation. Otherwise, our one professional organization will stop growing and perhaps "die" as the differentiation continues without the increased integration.

now the National Career Development Association, and the Student Personnel Association for Teacher Education, now the Association for Humanistic Education and Development. APGA was renamed American Association for Counseling and Development (AACD) in 1983 and became ACA in 1992.

Officials of NAGS, then NAGSCT, and some of their members also met during the annual American Vocational Association conferences and presented programs. With the inclusion of local supervisors with state guidance supervisors and counselor trainers (renamed counselor educators), NAGSCT was reorganized and renamed ACES in 1961. ACES has continued the partnership tradition with AACD and ACA begun much earlier by NAGSCT.

**In Appreciation:** Professional organization leaders in the counseling movement have dominated much of my research and fondest memories since 1965. Communications with all the ACES past presidents and/or their surviving families have benefitted my career greatly. My debts of gratitude to each are tremendous!

My thankfulness is extended to the 1996-97 ACES Executive Council members, headed by President Gladding, for their decision to publish this update booklet (20 years later) as a second edition to **PRESIDENTIAL REVIEW**. Plans are to print in the **ACES SPECTRUM NEWSLETTER** a detailed analysis of information which appeared in the presidential profiles.

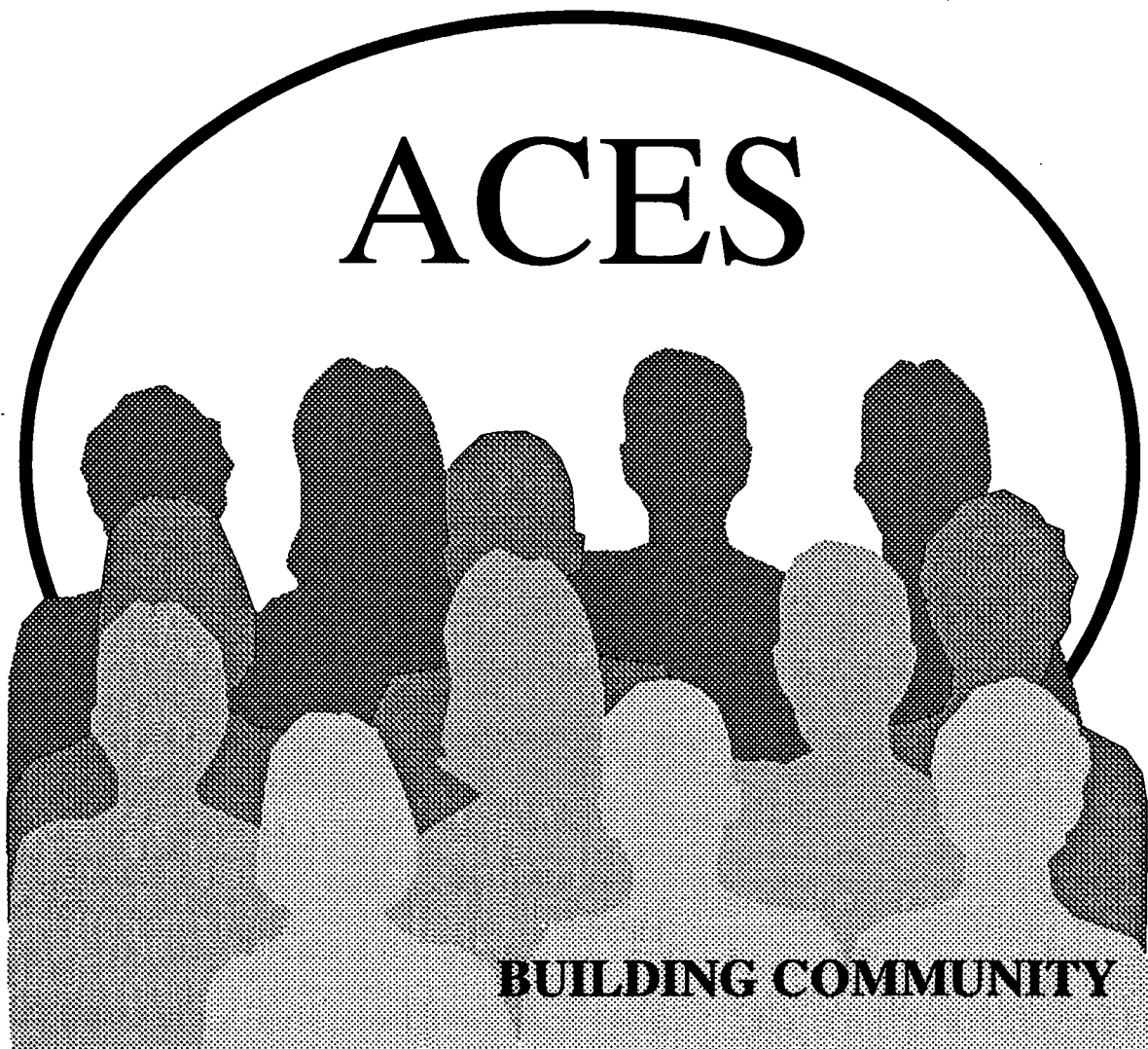
