



Prospective higher education providers


1. Overview

Since the inception of TEQSA in January 2012, **106** organisations have submitted or indicated their intention to submit applications for initial registration to TEQSA. Of those who have submitted applications, **2** have been rejected, **10** have subsequently been withdrawn by the applicants, and **24** have been successfully registered.

This report, drawn from data captured on 15 August 2016, provides summary statistics of prospective higher education providers, organised by:

- ▶ *pre-submission applicants* - those who have indicated an intention to submit an application for registration but are yet to do so; and
- ▶ *post-submission applicants* - those who have submitted registration applications, the assessment of which has not yet been finalised.

There are **70** pre-submission and post-submission applicants identified as prospective higher education providers. Future reports will reflect any changes that occur quarterly.




2. Key statistics - 15 August 2016

4.1 Pre-submission applicants

- ▶ **49** of the 70 applicants had indicated their intention to submit applications.

4.2 Post-submission applicants


- ▶ **21** applicants had submitted an application for initial registration to TEQSA, of which:
 - **2** were undergoing preliminary assessment
 - **3** were awaiting commencement of substantive assessment, and
 - **16** were under substantive assessment.



3. RTOs¹ and CRICOS registration


3.1 Pre-submission applicants

- ▶ **28** (57%) of the applicants who have indicated their intention to submit applications are Registered Training Organisations (RTOs).
 - At least **17** of these RTOs have a current Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS) registration.



3.2 Post-submission applicants

- ▶ **11** (52%) of the applicants whose applications were under assessment on 15 August 2016 are RTOs.
 - At least **6** of these RTOs have a current CRICOS registration.

4. Applications by state²

4.1 Pre-submission applicants

- ▶ At least **22** (46%) of the applicants who have indicated their intention to submit applications are based in New South Wales.

- ▶ At least **8** (38%) of the applicants whose applications were under assessment on 15 August 2016 are based in New South Wales.

5. Applications by top 3 Broad Fields of Education³

5.1 Pre-submission applicants

- ▶ **31** (63%) of the applicants who have indicated their intention to submit applications have specified the type of courses they intend to offer.
- ▶ Just over two-thirds of these providers intend to offer at least one course in the broad field of 'Management and Commerce' (e.g. business, accounting).

5.2 Post-submission applicants

- ▶ Almost two-thirds of the applicants whose applications were under assessment on 15 August 2016 intend to offer at least one course in the broad field of 'Management and Commerce' (e.g. business, accounting).
